1 LEVINE Hello.  
2 KIFERBAUM Stuart.  
3 LEVINE Yes.  
4 KIFERBAUM Thank you.

6 LEVINE Um, and uh, but you know we have to

11 stupid.

12 KIFERBAUM I, I agree with you. I think that

17 know, don't, whatever happens, let her  
18 do it and, and um, uh, because you don't  
19 want, you don't want uh,...

20 KIFERBAUM No, no, I hear you.

2 KIFERBAUM Great. I am, I am delighted and I  
3 appreciate you uh, being there and I'll  
4 fill you in tomorrow as soon as I know  
5 what's going on or as soon as she calls  
6 me. I left, I, I literally did exactly  
7 what you said.

8 LEVINE Right.

9 KIFERBAUM I left the ball in her court. I said,  
10 "you gotta call me and you tell me what  
11 you want me to do."

12 LEVINE Mm hm.

13 KIFERBAUM That's it.

14 LEVINE And if, and if she says to you, "I, you  
15 know, can't get it done this fast. I  
16 promise you, we'll sign it." Then  
17 you'll say to her, "I take you at your  
18 word and uh, and I'll do what I can."

19 KIFERBAUM Okay.
