1 LEVINE Hi Tom.  
2 BECK Hello Stu.  
3 LEVINE Did you have a nice time?  
4 BECK Oh, yeah.

6 BECK Uh uh. See I'm only in town for such a  
7 short period. I schedule all these  
8 annual tests that I have to take uh, to  
9 get 'em done.  
10 LEVINE (laughs) Where do you get 'em done?  
11 BECK Ah, out here.  
12 LEVINE Out here. Well how 'bout, how 'bout if  
13 I buy you lunch?  
14 BECK Um, let me, let me call you in the

17 LEVINE They'll, they'll be, they'll be able to

13 LEVINE And then uh, you know there's a...

15 LEVINE There's some time that gone by and uh,  
16 and so forth. But the, the, the  
17 essential thing is they may have enough  
18 uh, uh, in there...

19 BECK Mm hm.

20 LEVINE That uh, that um, you know that, that  
21 does the thing which has nothing to do  
22 with whether or not you know, you know.

23 BECK We'll, we'll take a look at it and see  
24 if, uh, we can't. Like our, our good  
25 friend today said uh, he goes you know  
26 you got the 5. And I says yeah I know
