1 LEVINE Hello.
2 GONZALEZ Hi Stuart. I didn't know, are you
3 taking calls?
4 LEVINE Sure.
5 GONZALEZ Okay, I have Sheldon Pekin on the line.
6 LEVINE Oh, put him on the line.
7 GONZALEZ Okay, hold on.
8 (PAUSE)
9 LEVINE Hi Shelly, how are you?
10 PEKIN Fine, Stuart. How are you?
11 LEVINE Good.
12 PEKIN Two quickies for ya. Ah, Dave would
13 like to call Jon Bauman about uh, ...
14 LEVINE I beg your pardon?
15 PEKIN Dave would like to call Jon Bauman about
16 due diligence on Stockwell. Any
17 problem, any problems with that?
18 LEVINE Well, Jon Bauman's out of town uh, uh,
19 for a week and uh, uh, I'm, I'm on it.
20 Uh, I told 'em to speed it up.
21 PEKIN Okay.

1 LEVINE Um,...

2 PEKIN But you...

3 LEVINE But at least, at least David knows
4 enough he has to call you all the time.

5 PEKIN Yes I like that.

6 LEVINE No, I mean he, he's, he needs to be,
7 he's had too much ah, he's too full of
8 himself, but that's fine.

9 PEKIN Okay.

10 LEVINE Listen Shelly are you around tomorrow?

11 PEKIN I will be around.

12 LEVINE I'm gonna, I'm gonna stop by because um,
13 I wanna talk to you about uh, uh, about
14 a couple of uh, of things and um, um,
15 um, you know the arrangement with a,

17 PEKIN Right.

26 LEVINE Yes you are.

29 something um, uh there's something ab-,
30 I don't, I don't know him at all.

31 PEKIN Mm hm.

32 LEVINE All I know is that you are the second

1 person of true decency and worth that
2 I'm close to that ended a friendship
3 with him. One was Izzy Levy.

4 PEKIN (UI) they were best friends.

5 LEVINE They're very close.

6 PEKIN Yeah.

7 LEVINE And,...

8 PEKIN (UI) best friend at one time.

9 LEVINE And, and now they don't speak.

10 PEKIN It's hard to believe.

11 LEVINE And, but that tells you something about,
12 about a, about Bill.

13 PEKIN Yeah. I appreciate it. I have an
14 expert witness case I may (UI) check
15 with...

16 LEVINE It doesn't have to be tomorrow. It
17 doesn't have to be tomorrow.

18 PEKIN So, but I, I'll be around...

19 LEVINE I'm goin' to Cubs opener today with my
20 boy.

21 PEKIN Oh, wonderful.

22 LEVINE (laughs)

23 PEKIN Takin' Bennett?

24 LEVINE Sure.

25 PEKIN That's great.

26 LEVINE You think I would go for myself?

27 PEKIN Nice picture of you guys in, in the
28 flier by the way.

1 LEVINE Wasn't that nice?
2 PEKIN That was very nice.
3 LEVINE Yeah.

6 LEVINE Yeah.
