2 WEINSTEIN Hello Stuart.
3 LEVINE How are you?
4 WEINSTEIN I'm fine.
5 LEVINE Um, yeah I want, I wanna, I had, I met
6 with uh, Steve Loren this morning I went
7 over uh, uh, everything that I talked to
8 Tony about.
9 WEINSTEIN Mm hm.
10 LEVINE Uh, and um, uh, (chuckles) I've got uh,
11 assuming that everything falls into
12 place and that this, and I'd, I'd say
13 that it's a pretty good uh, uh, a shot
14 of that uh, of that, that it will

16 and it's just a question of, of uh, and
17 I will have control. I, I think, I

13 for uh, the new Glencoe deal uh, the

15 WEINSTEIN Mm hm. That's perfect.

16 LEVINE Yeah. Um, a big piece of it is this, is
17 the mortgage company deal. Uh,...

18 WEINSTEIN (UI) they can come to R and L and every
19 month they can just distribute half to
20 you.

21 LEVINE Oh, oh yeah this, this is a, this is...

22 WEINSTEIN No it's fine, but you, you, 'cause you
23 know where this stuff is.
