1 LEVINE Hello.  
2 GONZALES Hi Stuart, I have Bill Cellini.  
3 LEVINE Yeah put him on.  
4 GONZALES Hold on.  
5 (PAUSE)  
6 LEVINE Yeah Bill.  
7 CELLINI Hello.  
8 LEVINE Hi Bill.  
9 CELLINI Yes.  
10 LEVINE Hey I just got a call from uh, Chris  
11 uh, ...  
12 CELLINI I know 'cause he was talkin' to me at  
13 the same time.  
14 LEVINE Oh, okay.  
15 CELLINI Uh, you haven't talked to him yet?  
16 LEVINE No I'm supposed to meet him at Tony's  
17 office at 2:15 so I was checking with  
18 you to see if uh, ...  
19 CELLINI Oh, oh, well see this is typical of him.  
20 What happened was uh, he called me this  
21 morning uh, over, do you remember I told  
22 you we had an event and somebody had

1 bailed.

2 LEVINE Right.

3 CELLINI And I said to him, well you know the  
4 people bailed because there's uh,  
5 there's some uh, talk and uh, they're  
6 concerned about it and you know we  
7 better just as well be safe and uh, well  
8 he starts questioning me about what,  
9 what kind of talk is it. And I said  
10 well, you know when I see you I'm comin'  
11 in Wednesday, Thursday I says as a  
12 matter of fact uh there's another item  
13 that uh, uh, we probably need to talk  
14 with Tony about th-, th-, over the kind  
15 of, same kind of stuff and we need to  
16 sit down and uh, make sure the things  
17 are fine. And he says uh, what items  
18 that. I said, he says does it involve  
19 me. I said no it involves Tony. He  
20 said well what, what. I said well it  
21 has to do with a guy who uh, uh, uh,  
22 thinks that he uh, is getting hammered  
23 for something. And he said uh, well  
24 who, who, what. I mean he, you know how

26 LEVINE Mm hm.

27 CELLINI And I said well, so I give him the name.  
28 And he said, that's funny I got a call  
29 this morning about that. And I said,  
30 you got a call, from who? Well, when I  
31 see you I'll tell you. Then I said  
32 well, he said well, what's the problem.  
33 I said well the guy thinks that he's uh,  
34 gotten something uh, uh, uh, pulled from  
35 him and uh, he thinks he's getting  
36 hammered. And uh, he says uh, uh, and I  
37 said but, but it isn't you, it's Tony  
38 and Stuart and I will talk about it when  
39 we come in. He said Stuart knows about  
40 it? I said Stuart knows about it. He  
41 said wait a minute I'm gonna call him.  
42 And I'm, I'm (UI) I mean I can hear him,  
43 you know he carries three cell phones.

1 LEVINE Mm hm.

2 CELLINI So I'm sittin' here and I hear him  
3 sayin', this is Chris he says, then he  
4 comes to me and he says, I didn't tell  
5 him my last name do you think they know.  
6 I said yeah you're like Madonna.  
7 (laughs)

8 LEVINE (laughs)

9 CELLINI I said he'll know who the hell Chris is.

10 LEVINE Mmm.

11 CELLINI So then, you know that, that was, that  
12 was it, but, but he's like a bull in a  
13 china closet (UI).

14 LEVINE Yeah.

15 CELLINI (UI).

16 LEVINE You know it, it, you know, fir-, first  
17 of all uh, no matter how you cut it,  
18 nobody has talked to uh, to uh,...

19 CELLINI To what?

20 LEVINE to Tom, nobody has asked Tom for  
21 anything. That's, that's the reality of  
22 things.

23 CELLINI Yeah.

24 LEVINE I saw Eddie today.

25 CELLINI (UI).

26 LEVINE Because uh, and I told him uh, what  
27 happened because remember that uh, that  
28 Eddie was the guy who was supposed to  
29 come and talk...

30 CELLINI Right, right.

31 LEVINE ...to (UI). Which had nothing to do  
32 with any of this new stuff.

1 CELLINI Right, right.

2 LEVINE And he had settled that other case and  
3 uh, uh, you know it, because I want  
4 everybody who is involved here to know  
5 when I see Chris I wanted to check with  
6 you to make sure that's, you know what  
7 it was he could be calling me about. I  
8 figured it must of somehow been this,  
9 but I wanted to know whether it was  
10 somehow comin' from the other end. And  
11 I'm gonna tell Chris that there is uh,  
12 uh, there is nothin' and that uh, I  
13 really gotta wait for Tony to come back  
14 to find out what occurred here. But  
15 regardless of what occurred.

16 CELLINI Well he said Tony's back now.

17 LEVINE He is?

18 CELLINI Yeah.

19 LEVINE Well...

20 CELLINI But really uh, this, no, you know, dummy  
21 Tommy made some strong statements.

22 LEVINE Mm hm.

23 CELLINI You know by god I'll, you know take 'em  
24 down I'll do this. You know they got 48  
25 hours to correct this.

26 LEVINE Well, you know...

27 CELLINI I resent these strong arm guys, you  
28 know.

29 LEVINE Well who...no-, nobody's asked him for  
30 anything.

31 CELLINI No but he, you know he, he's makin' his  
32 assumptions.

33 LEVINE Well he can make all the assumptions he  
34 wants nobody's asked him for anything  
35 yet.

1 CELLINI Mm hm.

2 LEVINE That's the point Bill. Nobody sat down  
3 and says do this for me.

4 CELLINI Yeah. Well uh, Jon called me over the  
5 weekend and uh, alluded to it.

6 LEVINE Uh, alluded to what?

7 CELLINI Well I understand, you know that uh,...

8 LEVINE Alluded to what?

9 CELLINI Alluded to the fact that it got uh,...

10 LEVINE Uh huh.

11 CELLINI Pulled.

12 LEVINE Mm hm.

13 CELLINI That a brick got placed.

14 LEVINE Mm hm.

15 CELLINI And uh, I asked Jon, he said, I said do  
16 I understand that they're supposed to  
17 get two different areas? He said yeah.  
18 I said is there any problem with either  
19 area if somebody only wanted to do one?  
20 He said not at all.

21 (PAUSE)

22 LEVINE Well, you were askin' Jon if, he would,  
23 you know would you have any problem  
24 doing it if you wanted to?

25 CELLINI Yeah.

26 LEVINE Well that, that, that's...

27 CELLINI Or, or did he have any problem doin' the  
28 one that was, that's the non-real  
29 estate.

30 LEVINE Oh, the comingled?

1 CELLINI Yeah.

2 LEVINE Yeah. Uh huh.

3 CELLINI Was the comingled real estate too?

4 LEVINE Yeah.

5 CELLINI Oh hell I didn't know that.

6 LEVINE It's a \$20 million dollar comingled real  
7 estate fund.

8 CELLINI Oh, oh. But, but see that, that, that  
9 might be uh, uh, an interesting thing to  
10 do, but...

11 LEVINE No I, I, I, I hear you loud and clear,  
12 but uh, but the fact is that nobody has  
13 sat down and demanded anything from him  
14 and there's a reason that, that we  
15 didn't wanna go forward have nothin' to  
16 do with Chris...if we wished it. And  
17 that has to do with the fact that he  
18 lied to Staff and is continuing to lie  
19 to Staff. If Jon would have said to him  
20 could you give me in a letter stating  
21 that you have no confidentiality  
22 statements out with anybody uh, uh, uh,  
23 that you've dealt with in going to sell  
24 the company, he couldn't of given a  
25 letter.

26 CELLINI Mm hm.

27 LEVINE But Tommy cannot, you know uh, I would  
28 say, I certainly would never do anything  
29 with Tommy.

30 CELLINI May, may, maybe they still have to ask  
31 that.

32 LEVINE Maybe they, yeah I think, no I think  
33 that, that'll all be part and parcel to  
34 how this is handled.

35 CELLINI Yeah maybe you give the comingled 'cause  
36 it's not a big amount and ask for a

1 letter before...

2 LEVINE Yeah I'm on the phone Bob. Yeah.

3 CELLINI What?

4 LEVINE Mm hm.

5 CELLINI Well, anyway, that's what it's about.

6 LEVINE Mm hm. Alright, well I'm going to uh,  
7 um, I suppose I need to tell him what I  
8 know.

9 CELLINI Yeah, yeah.

10 LEVINE But I tell him to wait until Tony's  
11 involved.

12 CELLINI Yeah and he, you know he says to me well  
13 if the guy uh, on ice until, until then.  
14 I said I think he is. I don't think  
15 Tommy's gonna do anything until he knows  
16 for sure whether, whether he has or  
17 hasn't something.

18 LEVINE Mm hm. Did he know who Tom was?

19 CELLINI Oh yeah.

20 LEVINE Does he know him?

21 CELLINI He said who the hell does he think he  
22 is.

23 LEVINE Mm hm.

24 CELLINI He didn't sound like he was a fan of  
25 his.

26 LEVINE Yeah well I mean uh, uh, Eddie uh, uh,  
27 uh, uh, you know Eddie's opinion of  
28 him...he fucked Eddie years ago.

29 CELLINI Mm hm.

30 LEVINE Yeah he's got a long trail uh, Tommy,  
31 but uh, Eddie uh, Eddie said to me um,

1                   uh, he said uh, this ain't over and uh,  
2                   meaning, meaning that uh, you know  
3                   Tom...  
4    CELLINI           Okay, are you gonna call him back or see  
5                   him?  
6    LEVINE            No I'm gonna go see him 2:15.  Should I  
7                   call you afterwards?  
8    CELLINI           Okay.  Yeah.  
9    LEVINE            Alright.  Bye.
