2 DORFMAN: Which he promised me he would get me.
3 But, all you get from him are promises
4 of bullshit. You see, my statement to
5 him today is going to be, listen,
6 Morris, where is my twenty-five percent
7 of the holdings that Hoffa and I are
8 supposed to have? We're suppose to have
9 25 percent of Pennesquitos, nothing
10 happened. Twenty-five percent of Aptos,
11 nothing happened at all. In fact, I got
12 a letter. Twenty-five percent of IJK,
13 Nevada, nothing happened, which now
14 owns, which was then, then became the
15 ah, Dunes Hotel. I says, all I know is
16 we ain't got a fucking thing. That's
17 all I'm going to say to him. Now where
18 the fuck we goin'? Did you ever give me
19 a fuckin' dime, Morris? Ever give Hoffa
20 a fuckin' dime? If you did, I don't
21 know about it. And if you did, I don't
22 give a fuck because I didn't get
23 nothin'.

25 LOMBARDO: We're not saying that, we're not saying
26 give Hoffa anything. Just like uh,
27 bypass that question.
28
29 DORFMAN: Okay. Yeah, because he made us.
30 (LAUGHING)
31
32 LOMBARDO: Yeah, just give him food for thought.
33 Ya know what mean?...which, why don't I
34 give it all to Fitzsimmons. Ya know
35 what I mean? Because that's bullshit.
36 Now, when he sold Pennesquitos, he
37 didn't give you a fuckin' dime. How
38 much money was made on that?

1 DORFMAN: I don't know exactly what he got out of
2 it. But he would have had to have
3 gotten, in the ultimate settlement, I
4 would imagine that he would have gotten,
5 just a second...I've got it, I could
6 really find out exactly.
7
8 LOMBARDO: Give me a ball park figure.
9
10 DORFMAN: I can find out exactly. The Fund has
11 the records. The Fund would have...
12
13 LOMBARDO: It doesn't matter 'cause he'll be here
14 at four o'clock, so, ah, think about a
15 ball park figure.
16
17 DORFMAN: What he get out of it? I would say he
18 got somewhere between three and five
19 million.
20
21 LOMBARDO: You know the guy got three to five
22 million.
23
24 DORFMAN: Yeah, the Kahn estate.
25
26 LOMBARDO: So that's, that's fifty-fifty right? He
27 got fifty percent, the other guy got,
28 uh, ten million.
29
30 DORFMAN: That's twenty-five percent belongs to
31 us.
32
33 LOMBARDO: Right, but this ten million, is two and
34 a half million dollars that belongs
35 here.
36
37 DORFMAN: Sure.
38
39 LOMBARDO: We'll bring that up. Boy, I could
40 almost, that uh, Pennesquitos. Now,
41 It's counting time. Your twenty-five
42 percent of X amount of dollars. That's
43 money that we want right away.
44
45 DORFMAN: Well, you can make the demands, ah (UI).
46
47 LOMBARDO: We'll make the demands, we'll make it,
48 ah, don't you understand. We got to

1 make a demand for this guy where he's
2 gonna have to run for help somewhere.
3 Now he's in trouble. Don't you
4 understand? Now he ain't talking to you
5 no more, now he's in, he's got serious
6 trouble. He's gonna go run for help.
7 You know where he'll run for help at?
8 He's gonna run to St. Louis. St. Louis
9 says there's nothing we can do about it.
10 It's out of our fuckin' hands. Now
11 he's runnin' for help. Now he says,
12 this is serious, ya know what I mean?
13 You ain't no more conversation. Now,
14 after you tell him everything, then I'll
15 say excuse us Allen. Now you go out.
16 Now, I'm gonna give him the fuckin' riot
17 act. I'm going to tell him, listen,
18 this is what you gotta come up with, and
19 if you (BANGING THE TABLE) don't, this
20 is what's going to happen to you, you
21 understand? As long as we can't spend
22 our money, you ain't gonna spend your
23 fucking money. Do you understand? And
24 you go wherever the fuck you wanna go.
25 I'm just relayin' you a message. I'm
26 just an errand boy. This is what they
27 wanted me to tell you. Your bullshit's
28 all through, it's all over with.
29 (BANGING TABLE) Now, we gotta get
30 results. So that Jun...this is May,
31 June, July 1st.

33 DORFMAN: No, instead of doing it that way,
34 Joey...I mean do it that way, but,
35 instead I'd say to him, listen you have
36 thirty days to tell us what down payment
37 plan you gonna come up with.
38

39 LOMBARDO: And if you don't tell us, we'll tell you
40 what kind of payment plan we want. And
41 what you have to comply with. In thirty
42 days, you tell Allen what kind of a
43 payment plan you're coming up with. You
44 mean? You owe two and a half million
45 dollars from that fuckin' Pennesquitos,
46 as, as an offshoot and then twenty-five
47 percent of all the fucking joints that
48 you got goin' that belongs to us. Now,

1 you tell him what kind of payment plan
2 you gonna pay him, in thirty days. Now,
3 if he don't hear from you, we're gonna
4 come by you again.
5
6 DORFMAN: And mark down that Sports Arena, what
7 happened to that fuckin' Sports Arena
8 stock.
9
10 LOMBARDO: Right. Right. The point is...
11
12 DORFMAN: The two million, two million shares that
13 he, he's supposed to have.
14
15 LOMBARDO: In thirty days, you tell us what kind of
16 a payment plan you'll come up with. And
17 you're gonna keep it. In thirty days.
18 Now if you don't come up with it in
19 thirty days, then we'll come by you and
20 we'll tell you what kind of a fuckin'
21 payment plan that we want, and then
22 you're on file, and if you don't, this
23 is what's gonna happen to you. Do you
24 understand?
25
26 DORFMAN: You gotta be careful with him. You know
27 he's a...
28
29 LOMBARDO: What's he going to do?
30
31 DORFMAN: He's a crabby, crabby motherfucker.
32
33 LOMBARDO: Go right to the G?
34
35 DORFMAN: Ah, I'll bet he wouldn't.
36
37 LOMBARDO: What can he do?
38
39 DORFMAN: I don't know.
40
41 LOMBARDO: How cold can he be? Go the, the G and
42 beef on me? Beef on one guy. Where's
43 he going after that, Allen? So you
44 sacrifice one guy. If it's a fucking
45 army, is that right? You can't
46 sacrifice the fuckin' army. That's why
47 you only sacrifice one guy. I'll tell
48 him, but then excuse yourself, Allen.

1 LOMBARDO: Well, we'll straighten it all out today.
2
3 DORFMAN: The estimated value of one hundred
4 percent of Continental Connectors assets
5 over liabilities is one hundred seventy-
6 four million dollars.
7
8 LOMBARDO: And you got twenty-five percent of that?
9
10 DORFMAN: That's right.
11
12 LOMBARDO: Right.
13
14 DORFMAN: That's right.
15
16 LOMBARDO: Looks, ya got about forty million
17 dollars coming, just about.
18
19 DORFMAN: (LAUGHING) How can he, how can he
20 afford...fuckin' thing out, this
21 cocksucker. It doesn't matter. You
22 know, Uncle Joey, you know what really
23 irritates me more than anything else
24 about all this? All of this was made
25 possible by Hoffa and myself.
26
27 LOMBARDO: Right.
28
29 DORFMAN: All of this fuckin' shit.
30
31 LOMBARDO: Right. And now, he's out to fuck you.
32 you see, he's bullshittin', he's
33 countin' (UI)...
34
35 DORFMAN: Oh, but, not only fuckin', but Joey he
36 makes no effort to, to do anything, ya
37 know saying...
38
39 LOMBARDO: He should shit then, he should shit then
40 or get off the fuckin' pot. We don't
41 want any of these cocksuckers.
42
43 DORFMAN: Yeah.
44
45 LOMBARDO: And he don't...(UI)...nobody, he sits
46 there.

2 DORFMAN: Nice fucking people.
3
4 LOMBARDO: You know, what I'm gonna tell him? This
5 is half of our fucking money that you
6 got and know what we do, it ah, know
7 what we do for less money than this? We
8 do, we do a lot of bad things for less
9 money than this. Imagine what we'd do
10 for this kind of fuckin' money? You
11 tell him, I'm gonna tell him, fuck you.
12 I'm gonna tell him, you know. If we
13 can't get our money, then you ain't
14 gonna spend a fuckin' penny of it
15 either. Then when your heirs get it
16 too, we're gonna give them a lot of
17 fuckin' trouble, too. Whoever
18 inherited. And they're gonna have a
19 lotta fuckin' trouble. I'm gonna tell
20 him, we don't want no fucking problem.
21 All we want is our fuckin' money. Is
22 that hard, hard to ask? Ya know what I
23 mean?
24
25 DORFMAN: Give us at least what we're entitled to.
26
27 LOMBARDO: Are we entitled to what we got's coming
28 to us? All we're fighting for is what
29 fucking belongs to us. And, Morris, you
30 ain't gonna fuck us out it. Twelve
31 years is a long time to wait. And we
32 ain't waiting another fucking month.
33 One month is all we'll give ya, and
34 after that the shits gonna hit the fan.
35 You're not gotta spend a fuckin' nother
36 penny after that. You're seventy-two
37 years old? Well, you're not gonna reach
38 seventy-three, I'll guarantee it, if you
39 don't give us our fuckin' money. Or
40 we'll make a fuckin' deal to keep up, to
41 keep it up.
42
43 DORFMAN: Or work out a payment plan.
44
45 LOMBARDO: Or work out a fuckin' payment plan...and
46 stand by it. But you have a choice,
47 either, reach, reach seventy-three and
48 keep up your payment plan, or you don't
