29 bothering him.

31 CALABRESE, SR.: Who was bothering him?

2 FRANK, JR.: He said a lot of people, and he said that
3 um, he told Smiley you know um, something
4 about ah if he ran into the other person
5 to tell him, you know ah (UI) were bothering
6 him. He finally told everybody you know
7 I got nothing to do with him.

9 CALABRESE, SR.: Oh with the little guy. (FRANK, JR. nods
10 head in the affirmative) Naw, I can't
11 believe that.

13 FRANK, JR.: He, he wouldn't get out (UI)...
