The Environmental Services Department uses one of the following methods of legal action to enforce the Environmental Health Code.

- •A Permit Revocation may be initiated against a facility/establishment that has not demonstrated compliance or has been found in violation of any applicable code. Permit revocation may also be initiated against trailer parks, hotels, semi-public swimming pools, and retail food establishments.
- •A **Permit Suspension** may occur immediately for serious environmental health code violations, which pose a major health hazard. The facility/establishment would not be permitted to operate.
- •Citations are issued for violations of the health code. The citation directs the defendant to appear for arraignment in Justice Court.
- •Cease and Desist Orders are issued for serious violations of the environmental health code. The violation must be corrected immediately and a hearing may be requested. Disregarding the order will result in injunctive action in Maricopa County Superior Court.
