A. Alternative Travel Area Goals, Objectives, Standards and Guidelines

Travel Planning Area Direction Under Alternative 1

Alternative 1 is the "no action" alternative. There would be no changes to current management direction applicable to travel management.

Travel Planning Area Direction Under Alternatives 2 through 7-M

- GOAL 1: Summer Recreation Use. Provide travel opportunities for non-motorized and motorized summer recreation use with an emphasis on hiking, biking and horseback riding. This goal is applicable to Alternatives 2 through 5, and 7-M. Alternative 6 would not allow for summer motorized or mountain bike use, in favor of high wildlife habitat security and no mechanized use within the Wilderness Study Area.
 - **OBJ. 1-1a:** Manage the road and trail system to provide for the following types of summer recreation use. *This objective is applicable to Alternatives 2 through 6, however, the amount of opportunity varies among alternatives as shown in the following table. The column for Alternative 7-M is provided for information only.*

- GOAL 2: Winter Recreation Use. Provide a winter recreation opportunity for backcountry snowmobiling and cross-country skiing/snowshoeing. This goal is applicable to Alternatives 2 through 5, and 7-M. Alternative 6 would not allow for snowmobiling, in favor of high wildlife habitat security and no mechanized use within the Wilderness Study Area.
 - **OBJ. 2-1a:** Manage the road and trail system to provide for the following types of winter recreation use. This objective is applicable to Alternatives 2 through 6, however, the amount of opportunity varies among alternatives as shown in the following table. The column for Alternative 7-M is provided for information only.



- **OBJ. 2-1b:** Achieve the winter recreation opportunities identified in GOAL 2 through the marked and groomed route management decisions made through this Travel Plan along with decisions made on the area available to snowmobiles. Any future proposals to change the uses specified should be done in consideration of the targeted recreation setting to be provided [see the "Recreation Opportunity Spectrum" (ROS) map for winter uses under Alternative 7-M] which is hereby incorporated by reference. *This objective applies to Alternative 7-M only.*
- **GOAL 3: Other Resource Protection.** Provide a trail system that accommodates recreation traffic consistent with protecting soil and watershed condition and maintaining wildlife security. *This goal is applicable to Alternatives 2 through 7-M*.
 - **OBJ. 3-1:** Repair damage to trails from recreational livestock use. *This objective is applicable to Alternatives 2 through 7-M.*
 - **OBJ. 3-2:** Rehabilitate and recontour the Rock Creek Road outside of the Wilderness Study Area boundary. *This objective is applicable to Alternatives 2 through 7-M.*
 - **OBJ. 3-3:** Provide interpretive/educational signing along motorized routes and in affected areas, asking motorized users seeking camp spots to stay out of wet, muddy and shrubby areas, and to keep vehicles (and campsites) a minimum distance (e.g. 50 feet) from lakes, ponds, rivers and streams. *This objective applies to Alternative 7-M only.*
- **GOAL 4: Wilderness Character.** Manage the Hyalite/Porcupine-Buffalo Horn Wilderness Study Area to sustain the recreation setting and existing Wilderness characteristics as they were in 1977 and to preserve the area for future consideration as Wilderness. *This goal applies to Alternatives 2 through 7-M.*
 - **OBJ. 4-1:** Through monitoring and modification of use patterns, manage designated uses of roads and trails to meet Goal 4. *This objective applies to Alternatives 2 through 7-M*.
