**Proposed Objectives** 

P Ensure that operating experience is collected, evaluated,communicated and applied to enhance safety

P Ensure that operating experience is used to improve the effectiveness, efficiency, and realism of NRC decisions

**P** Ensure that the public, Congress, and other external stakeholders are provided with timely information regarding operational experience including actual or

#### **Proposed Attributes**

P Clearly defined and communicated roles and responsibilities

**P** Efficient collection, storage, and retrieval of operating experience

**P** Effective screening of operating experience for followup evaluation

P Timely communication of operating experience to stakeholders for information or evaluation

Proposed Attributes (Cont)

**P** Timely and thorough evaluations of operating experience to identify trends, recurring events, or significant safety issues for appropriate followup actions

**P** Timely decisions on implementation and appropriate followup resulting from the review of operating experience

**P** Periodic assessments of the operating experience program to determine its effectiveness and to identify needed improvements
