The licensee has proposed deferring inspections recommended by the bulletin for Unit 2 until their next refueling outage which is scheduled to begin on January 19, 2002. The bulletin recommends that inspections be performed prior to December 31, 2001. A list of the meeting participants is included as Enclosure 1. The meeting handouts are included as Enclosure 2.
