**Subject: Program Update—CDC Community Water Fluoridation** 

The Centers for Disease Control and Prevention (CDC) Community Water Fluoridation Program periodically issues this update on program activities and resources for water fluoridation specialists, engineers with state drinking water programs, and state oral health officials. ## **Water Fluoridation Training**

The CDC-sponsored course on basic community water fluoridation, **Water Fluoridation: Principles and Practices,** scheduled for February 26-29, 2008, is full. Waiting list applicants will be considered on an availability basis. The course will be conducted next in Murfreesboro, TN, during the week of September 22–26, 2008. The course is intended to build the skills needed to manage and operate a state water fluoridation program and to train engineers in fluoridation engineering principles. ## **Water Fluoridation Quality Awards**

The CDC annually announces the Water Fluoridation Quality Awards to recognize water systems that consistently adjust water fluoride to optimum levels. For an adjusted water system to be eligible for this award, the water system must have the adjusted fluoride level in the optimal range during all 12 months in a calendar year and must have the operations documented by the state in the CDC Water Fluoridation Reporting System (WFRS). To be eligible for an award, state programs must complete documentation of all 2007 system operation data by March 1, 2008. ## Fluoride Additives Supply Update

Over the past several years, the fluoride additive supply has been disrupted several times. The shortage is related to the producer of fluorosilicic acid who has the largest market share. Other producers are not experiencing the same shortages, but they only have sufficient product for previously negotiated supply contracts.

There are indications that the producers are investigating short-term ways to expand production to address the shortfall. This process involves equipment modifications, better ore quality, and inventory management. From discussions with producers, CDC believes that the shortages this coming summer will not be as extreme as those

The district provides wholesale water to other regional utility purveyors serving over 18 million people. These facilities were placed into operation during November, bringing water fluoridation to fruition in the region.
