For the period J anuary through J une 2006, $25.6 \%$ ( $95 \%$ confidence interval $=24.59-$ $26.64 \%$ ) of U.S. adults aged 20 years and over were obese, which was not significantly different from the 2005 estimate of $25.4 \%$.

The annual prevalence of obesity among U.S. adults aged 20 years and over has increased over time from 19.4\% in 1997 to $25.6 \%$ for the period January through June 2006.

For both sexes combined, the prevalence of obesity was highest among adults aged 40-59 years ( $28.8 \%$ ) and lowest among adults aged 20-39 years ( $22.6 \%$ ).

There was no significant difference in the prevalence of obesity between women and men for all three age groups.
