Notes: Through a news report from Raleigh's News & Observer, it came to the attention of the Atlanta School Participation Team that North Carolina Central University (NCCU), based in Durham, NC, had operated an out-of-state and unauthorized location in Lithonia, GA approximately 400 miles away. The unauthorized site, dubbed the New L.I.F.E. College Program, was located at the New Birth Missionary Church, 6400 Woodrow Road, Lithonia, GA. The New Birth program was dissolved in June 2008 after the Southern Association of Colleges and Schools (SACS), the school's accreditor, refused to authorize it. NCCU did not notify SACS about the New Birth program when it began in 2004.

NCCU disbursed Title IV funds to students who had attended the unauthorized additional location, which had not received approval from SACS and the North Carolina University System's governing board. Neither the university system nor SACS had approved the New Birth Program. During the course of this program, which was offered over a 4-year period, approximately 125 students were enrolled - 25 of whom have been awarded Bachelor's degrees in either Criminal Justice, Hospitality and Tourism Administration, or Business Administration.

NCCU and the university system engaged in a conference call with the U.S. Department of Education and the institution acknowledged that the Lithonia site was not accredited by SACS and, hence, the students were not eligible for the Title IV aid received. The University is very interested in resolving this matter and examining all of the various academic, legal and financial questions associated with the Georgia-based program.

The last date of instruction at the Lithonia site was on August 4, 2008, the end of summer session II.

Student Arrangements: A teach-out plan is currently under development for approximately 45 students and must be approved by several groups, including SACS and UNC General Administration. The teach-out plan is due to SACS by September 19, 2008 and will be reviewed by their Commission during its December 2008 meeting. Students in the program have been contacted to keep them apprised of the current status of the program. As the directions for assisting these students becomes clearer, further directions will be provided to the students. A contact point for student questions has been provided on the NCCU campus. In addition to the teach-out plan, NCCU is exploring transfer options in the greater Atlanta area, online options from NCCU and online options from other campuses.
