### **DOE O 241.1A**

## **CONTRACTOR REQUIREMENTS DOCUMENT**

### **Software-Related Requirements**

- Item 2. Make available to OSTI useful scientific and technical (S&T) computer software (i.e., unclassified, sensitive, or classified) resulting from scientific and technical endeavors. Include an announcement record (DOE F 241.4) available at <http://www.osti.gov/estsc/>.
- Item 3. Use best practices as identified by DOE and contractor STI community available in Part III of DOE G 241.1-1A to manage DOE's S&T computer software.
- Item 4. Review as appropriate and apply any statutory or program-driven announcement and/or availability restrictions.
- Item 5. Notify OSTI when making changes (including updates) to S&T computer software previously announced.
- Item 6. Apply the requirements of this Order to subcontracts at any tier to the extent necessary to ensure the contractors' compliance with the requirements.

### **Software Procedures**

- Coordinate with the Nuclear Transfer and Supplier Policy Division (NN-43) regarding unclassified software meeting specific criteria (i.e., ECI, algorithms for high explosives..., etc.) as identified in DOE G 241.1-1A, Part III, Section 3.1
- Always submit an announcement record (DOE F 241.4) for S&T Software to ESTSC regardless of the available source.
- Submit the software with the announcement record to OSTI; submit the software to a Specialized Information Analysis Center when it meets the scope of interest/operation; or host the software at the development site.

### **OSTI/ESTSC RESPONSIBILITIES**

- Serve as the Department's central announcement mechanism for DOE-sponsored S&T software
- Serve as the Department's focal point for collecting, processing, and distributing S&T software
- Reproduce and disseminate available S&T software to requesters at cost
- Serve as the exclusive point of availability (other than the copyright holder or its licensees) for DOE software for which copyright has been asserted
- Exclusive coordinator with NN-43 for all sensitive country requests for software
- Serve as the operating agent for implementing portions of the DOE international exchange agreements with the Nuclear Energy Agency (NEA), which provides for the exchange of software

### **Copyrighted Software**

Software for which the developing DOE contractor has asserted copyright must be announced to OSTI's ESTSC using the DOE F 241.4.

The software should be made available to OSTI and/or it can be hosted by the originating site for dissemination to requesting DOE contractors and other government organizations.

### **Unclassified-Unlimited Software**

Software for which the contractor has not asserted copyright must be announced to OSTI's ESTSC using the DOE F 241.4. Unclassified-unlimited software is available to the public. The software should be submitted to OSTI, a Specialized Information Analysis Center (SIAC), if in their scope of interest/operation, or hosted at the originating site.

### **NEXT STEPS FOR STI POCS**

- Review and update the Software POC list
- Communicate to site's Software POC requirements for software submission
- Follow-up to ensure:
  - software packages have been announced and made available to ESTSC according to DOE O 241.1A and DOE G 241.1-1A (unclassified-unlimited, classified, sensitive-unclassified, copyrighted, etc.)
  - only software packages that meet the scope of interest/operation of a Specialized Information Analysis Center (SIAC) are being submitted to the SIAC
  - software hosted at the developing site is announced to ESTSC via the DOE F 241.4
  - updates of software packages are made available to ESTSC

### **NEXT STEPS FOR OSTI/ESTSC**

- Catalog updated to reflect current software holdings ([www.osti.gov/estsc](http://www.osti.gov/estsc))
- Reconcile data with:
  - Laboratories/Major Contractors
    - to ensure announcements/software packages have been made available to ESTSC
    - to ensure incomplete or problem packages are completed or problems resolved
    - to ensure updates of current software holdings at ESTSC are provided
  - SIACs
    - by comparing the scope of holdings at both SIACs and ESTSC
