- Data that measure components of CDC's best practices for tobacco control programs.
- Survey methodology that is tested and up to date.
- Tailoring of questionnaire to state's unique tobacco control program.
- Complete documentation of survey process and procedures.
- Ability to conduct trend analyses.
- Data specifically from middle school students.
- Dissemination of data online through
 - * State Tobacco Activities Tracking and Evaluation (STATE) System.
 - * Surveillance Morbidity and Mortality Weekly Report (MMWR).

- The YTS collects data from young people in grades 6 through 12.
- YTS data provide information on many key intermediate and long-term tobaccorelated indicators, allowing states to measure progress toward state and national goals and objectives.



Youth Tobacco Survey

States in blue conducted the YTS at least once from 1998 to 2007.



- Prevalence of tobacco use among young people.
- Tobacco-related knowledge and attitudes of young people.
- Exposure to pro- and anti-tobacco media and advertising.
- Minors' access to tobacco.
- Tobacco-related school curricula.
- Secondhand smoke.
- Addiction to tobacco and initiation and cessation of tobacco use.

Methods

- School-based survey of students in grades 6 through 12.
- Both public and private schools eligible for inclusion.
- Multi-stage design.
 - * Schools randomly selected with probability proportional to enrollment size.
 - * Classrooms chosen randomly within selected schools, and all students in selected classes eligible to participate.
- Anonymous and self-administered questionnaire.
- Only one class period required to administer questionnaire.
- State-level data collected, but data can be analyzed at the local level.
