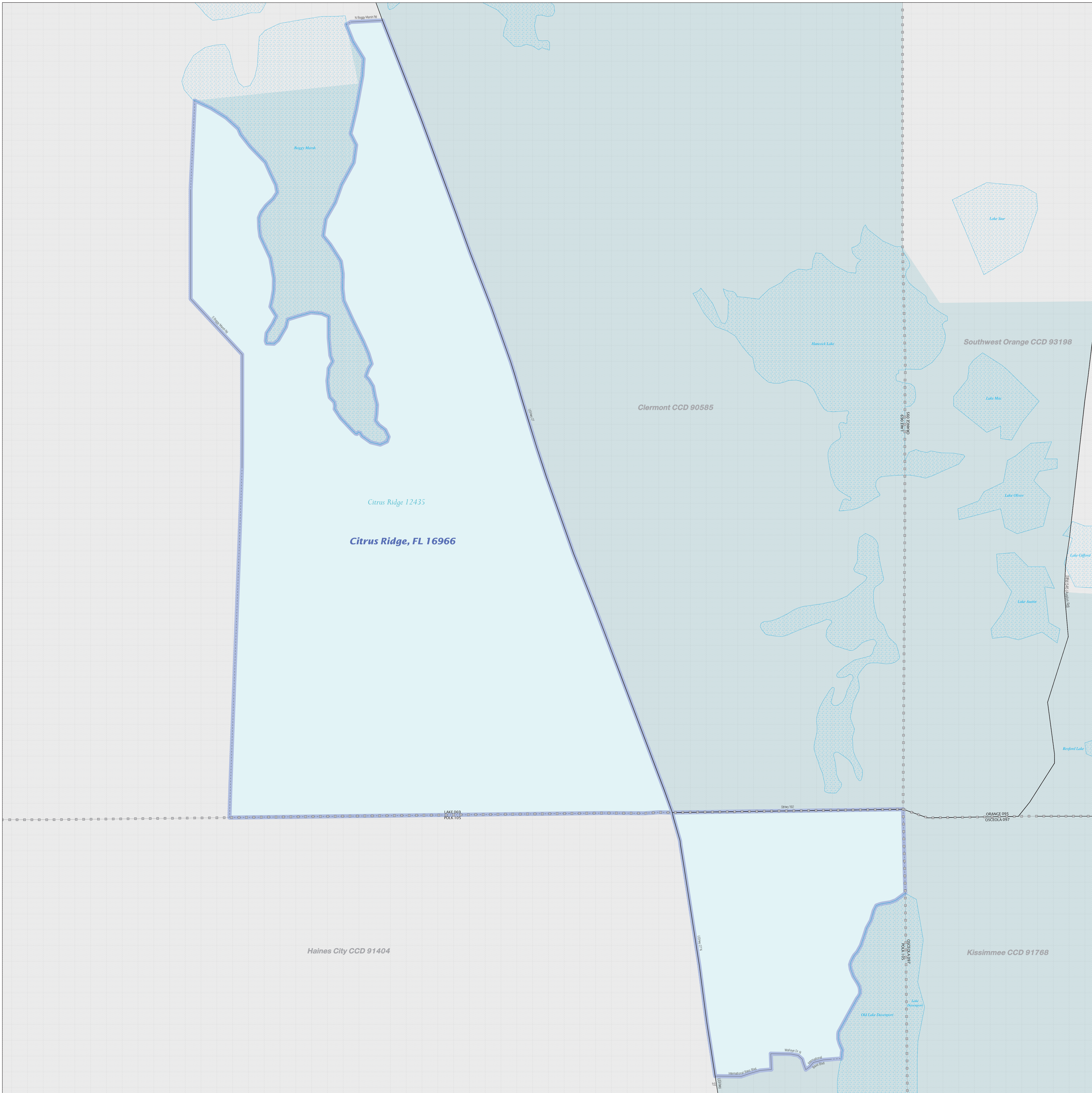


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) Citrus Ridge, FL
