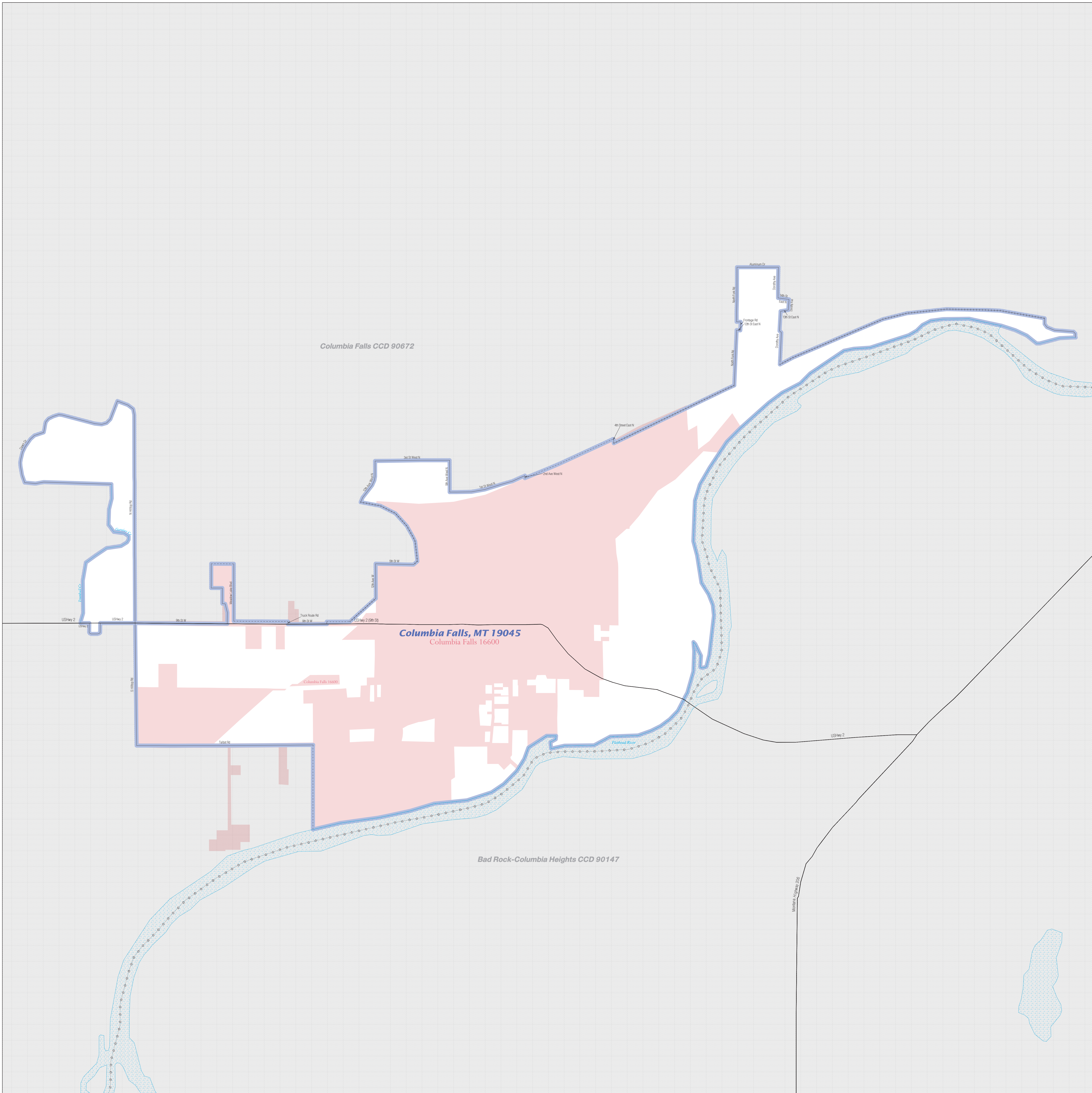


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) Columbia Falls, MT
