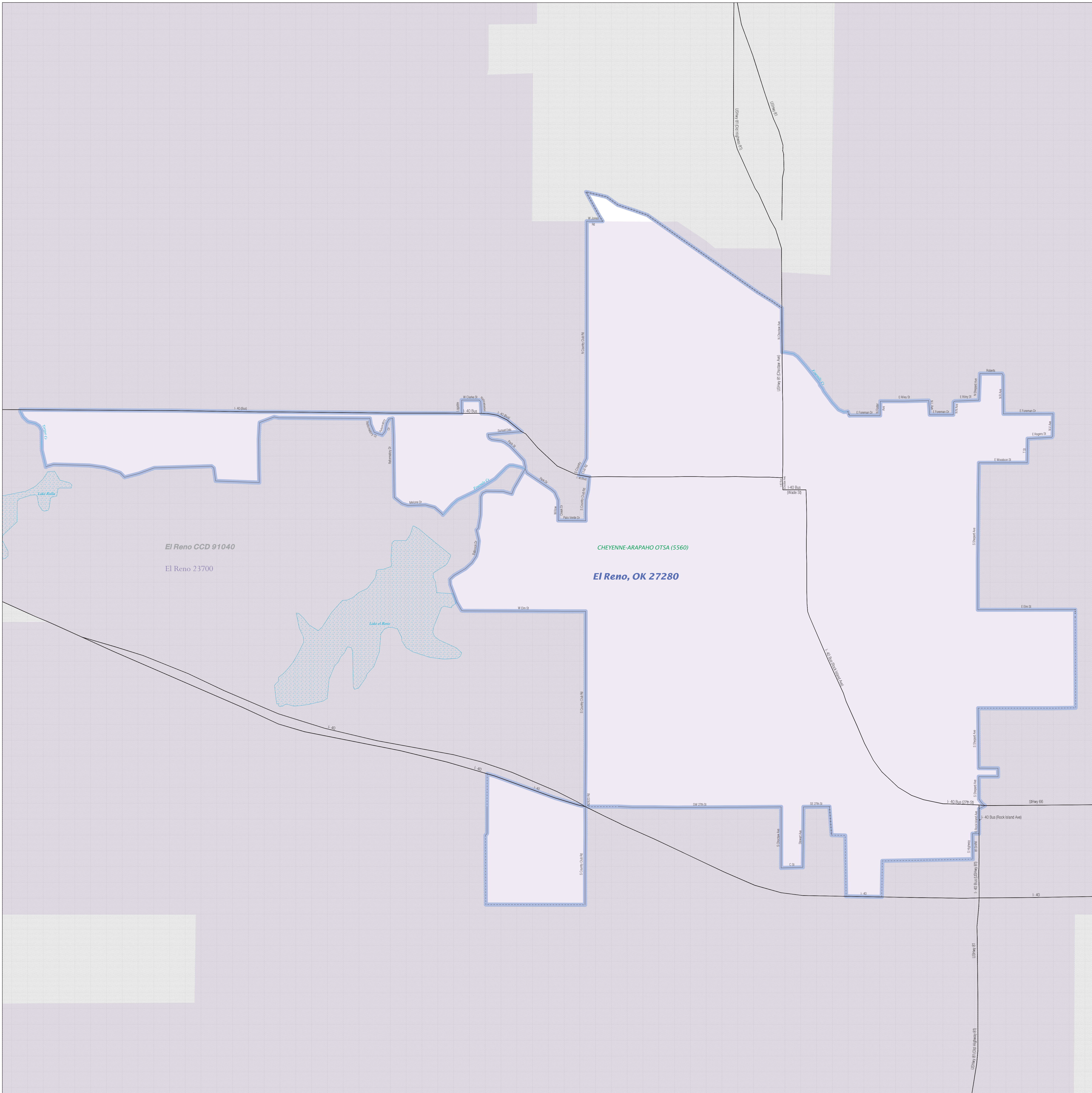


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) El Reno, OK
