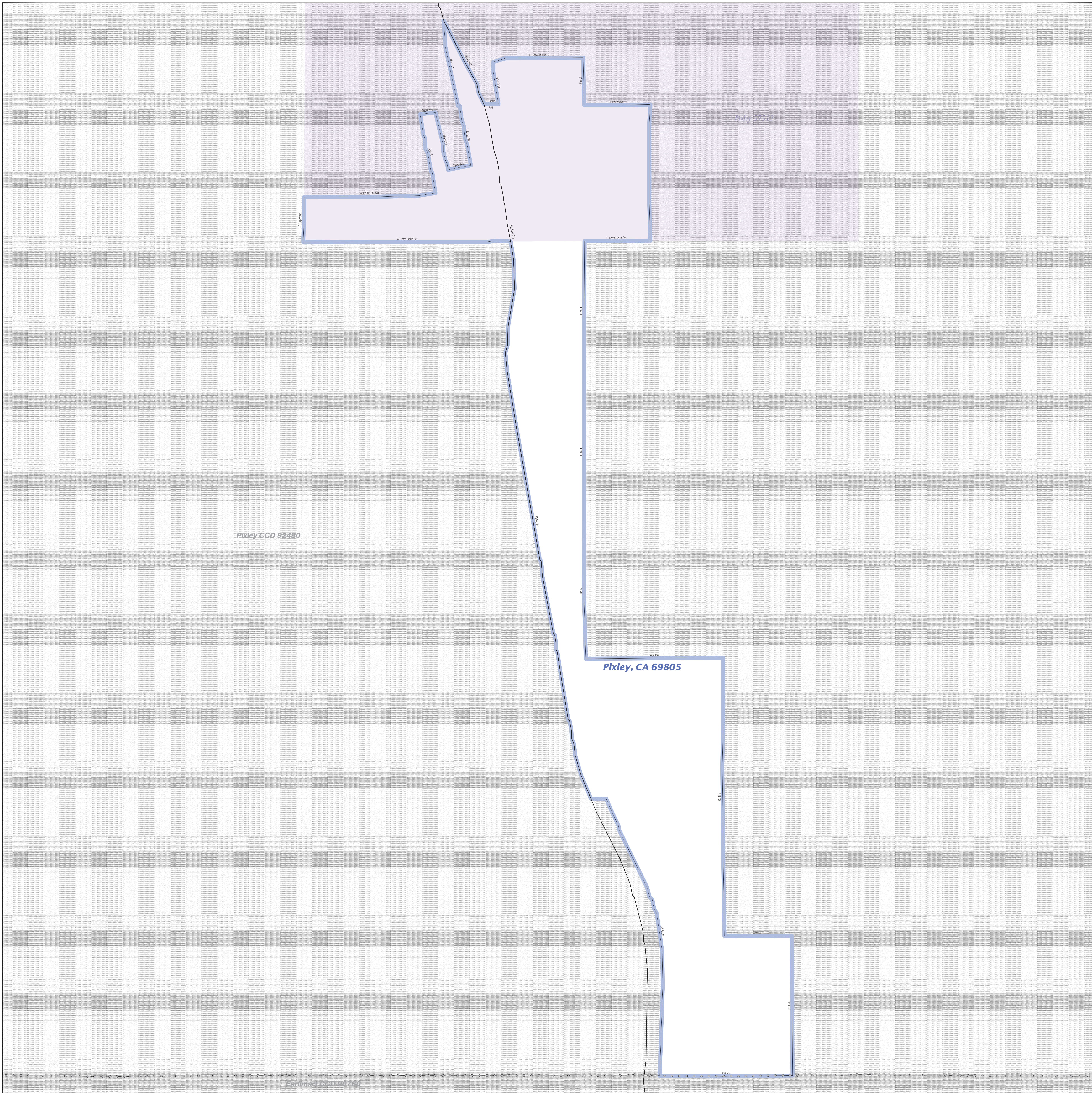


URBAN CLUSTER OUTLINE MAP (CENSUS 2000) Pixley, CA
