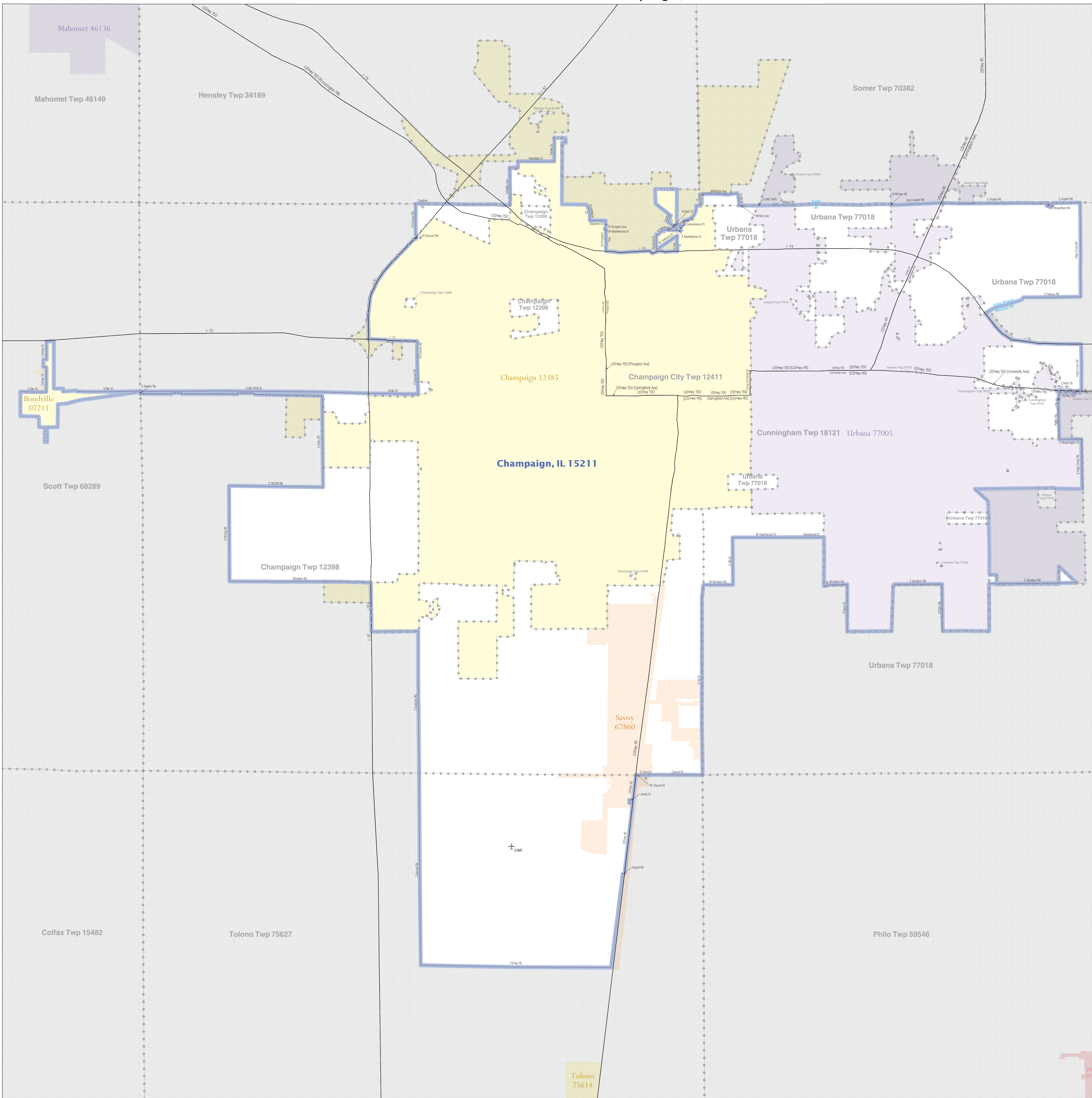


# URBANIZED AREA OUTLINE MAP (CENSUS 2000) Champaign, IL
