KNOW YOUR RIGHTS

Do you have trouble with English? Are you unable to speak, read, write, or understand English well? If so, you are Limited English Proficient (LEP).

Federal agencies and organizations that get money from the federal government have to take reasonable steps to help people who have trouble with English.

If you are mistreated because you are LEP, it may be National Origin Discrimination.

I. INTRODUCTION

NSF's policy guidance is consistent with a Department of Justice (DOJ) directive noting that recipient/covered entities have an obligation pursuant to Title VI's prohibition against national origin discrimination to provide oral and written language assistance to Limited English Proficiency (LEP) persons. (2) It is also consistent with a government-wide Title VI regulation issued by DOJ in 1976, "Coordination Nondiscrimination Enforcement of Federally Assisted Programs," 28 C.F.R. Part 42, Subpart F, that addresses the circumstances in which recipient/covered entities must provide written language assistance to LEP persons.

II. LEGAL AUTHORITY

Section 601 of Title VI of the Civil Rights Act of 1964, 42 U.S.C. Section 2000d et. seq. states: "No person in the United States shall on the ground of race, color or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance." This is further ordered by Executive Order 13166, "Improving Access to Services for Persons With Limited English Proficiency," and United States Department of Justice Guidance as published in the Federal Register, Vol. 65, No. 159, August 16, 2000.

EXAMPLES of Good Practices:

1 An award is declined because a referral letter that goes with a grant proposal is submitted in a foreign language.

1 NSF provides translation services so that fair and equitable consideration is given to the proposal.

- 2 The lack of translating information/services by a recipient of NSF funds for an educational program that services a community with a large population of non-English speaking beneficiaries.
- 2 Recipients of NSF funds provide oral and written translation services for beneficiaries in their respective languages.

- 3 Your child's school sends important information or a notice to you in English. The school refuses to provide the information to you in Spanish and suggests instead that your child interpret the information for you.
- 3 Your child's school has many Spanishspeaking parents. The school knows you speak only Spanish. You should receive the important information or notice in Spanish.
