## SCHEDULE OF FEES AND CHARGES

**EFFECTIVE DATE:** March 1, 2006 "Federal Grain Inspection Service (FGIS) must approve all fees for official services and Official Agencies (OAs) will assess only those fees appearing on their current approved fee schedule."

**OFFICE HOURS:** Owensboro Office hours are 8:00 a.m. to 4:00 p.m. C.S.T.  
Clarksville Office hours are 7:00 a.m. to 3:00 p.m. E.S.T.

**REGULAR HOURS:** Monday - Friday during normal office hours \$13.00

**OVERTIME HOURS:** Saturdays and other than normal office hours \$19.50

**SUNDAYS & HOLIDAYS:** All hours \$26.00

**HOLIDAYS:** New Year's Day, Martin Luther King, Jr. Day, President's Day, Memorial Day, 4<sup>th</sup> of July, Labor Day, Columbus Day, Veteran's Day, Thanksgiving Day, and Christmas Day.

All hourly rates will be assessed in quarter-hour increments. Travel and standby time will be assessed at the applicable hourly rate.

**MINIMUM FEE:** A 3-hour minimum call out fee will be assessed at the applicable hourly rate. Travel time will not be charged when minimum fee applies.

**MILEAGE:** The IRS standard mileage rate will be assessed per mile for actual miles traveled. Any change to the mileage rate is effective when the IRS changes their standard mileage rate. Mileage and travel time will be prorated where possible.

**ON SITE LAB INSPECTIONS:** Revenue generated during regular hours must equal \$13.00 per hour, per person. Saturday and other than normal office hours revenue must equal \$19.50 per hour, per person. Sunday and holiday revenue must equal \$26.00 per hour, per person.

**LATE PAYMENT CHARGE:** A late payment charge of two percent (2%) will be assessed on any payment not received ten (10) days after the billing date.

**PERSONNEL SAFETY:** At times, the need for two people to sample hopper cars may result in increased costs to the applicant. When cars are to be probed, and if a man is provided by the elevator for safety, one sampler will perform the requested service, otherwise two (2) samplers will be required.
