EFFECTIVE DATE: April 1st 2007 Federal Grain Inspection Service (FGIS) must approve all fees for official services and OAS will assess only those fees appearing on their current approved fee schedule

REGULAR HOURS: Monday thru Friday, 7:00am - to 3:30pm

REGULAR HOURLY RATE: D/T Sampler \$18.00, Probe or Pelican Sampler \$18.00, Technician or Weigher \$18.00 and Inspector \$21.00 in quarter hour increments, minimum of 4 hours will be charged.

OVERTIME HOURLY RATE: One and one half times regular hourly rate applies to all hours outside regular hours and Saturday in addition to unit fees. Minimum of 4 hours will be charged except one hour before or continuation of regular work day.

SUNDAY AND HOLIDAY HOURLY RATE: Double regular hourly rate, minimum 4 hours, in addition to unit fees Holidays include Presidents Day, Memorial Day, 4th of July, Labor Day Thanksgiving Day, Christmas Day, and New Years Day.

STANDBY RATES: Will be charged at applicable hourly rate for delays not caused by agency.

TRAVEL TIME: \$18.00 per hour will be assessed for all special service request and overtime performed outside Essex city limits to sample cars, trucks or pick up samples, except when in conjunction with an applied minimum charge.

MILEAGE FEES: The IRS standard mileage rate will be assessed per mile actual miles travel. Any change to the mileage rate is effective when the IRS changes their standard mileage rate. (prorated when possible)

ONSITE LAB STAFFING: Applicable hourly rate charged per individual necessary to perform the service.

OFFICIAL INSPECTION SERVICES: Include sampling **EXCEPT** where indicated:

Railcars, Hopper or Box, PLUS sampler hourly rate\$15.00
Truck or Trailer, PLUS sampler hourly rate\$ 8.25
