EFFECTIVE DATE: December 1, 2008. Federal Grain Inspection Service (FGIS) must approve all fees for official service and OA's will assess only those fees appearing on their current approved fee schedule.

REGULAR HOURS: 7:30 A.M. to 3:30 P.M. Monday through Friday, except holidays.

REGULAR, STANDBY, AND TRAVEL TIME RATE: \$20.00 per hour in half-hour increments. Travel time will apply to services performed outside the Memphis city limits.

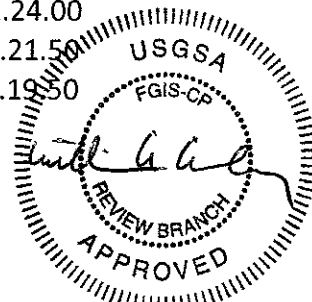
OVERTIME AND HOLIDAY HOURLY RATE: \$30.00 per hour for Saturday, Sunday, Holidays, and other than regular weekly work hours. Holidays include New Year's Day, President's Day, Good Friday, Memorial Day, July Fourth, Labor Day, Thanksgiving Day, and Christmas Day. There will be a four hour minimum for call in.

MILEAGE: The IRS standard mileage rate will be assessed for all services performed outside the Memphis city limits. Rate changes effective concurrent with IRS change to IRS rate.

PER DIEM FEES: Actual motel cost (maximum \$85 plus \$30 expenses when required to stay overnight).

OFFICIAL SERVICE CHARGES: Charges includes FGIS user fees unless otherwise noted.

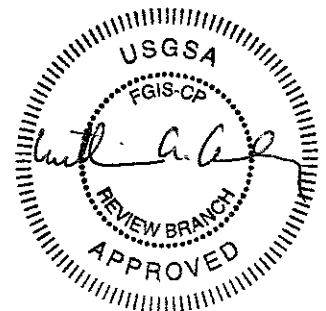
