This is in response to your letter to the Food and Drug Administration (FDA), dated November 27, 2000, pursuant to 21 U.S.C. 343(r)(6) (section 403(r)(6) of the Federal Food, Drug, and Cosmetic Act (the Act)). Your submission states that Maxi Health Research, Inc. is making the following claims, among others, for the following products:

### **Chromium Supreme Dietary Supplement**

"...maintain healthy blood sugar levels"

### Maxi B50 Dietary Supplement

"...maintain normal regulation of cholesterol and sugar levels..."

### Chewable Calcium Complex Dietary Supplement

"...clotting the blood"

### Maxi Cal 1000 Dietary Supplement

"It plays a role in ...clotting the blood"

## Chewable Maxi Health Children's Multi Dietary Supplement

"For support for healthy blood clotting"

21 U.S.C. 343(r)(6) makes clear that a statement included in labeling under the authority of that section may not claim to diagnose, mitigate, treat, cure, or prevent a specific disease or class of diseases. The statements that you are making for these products suggest that they are intended to treat, prevent, or mitigate diseases, namely hypercholesterolemia, disorders of glucose metabolism, and, and disorders of platelet aggregation and blood clotting. These claims do not meet the requirements of 21 U.S.C. 343(r)(6). These claims suggest that these products are intended for use as drugs within the meaning of 21 U.S.C. 321(g)(1)(B), and that they are subject to regulation under the drug provisions of the Act. If you intend to make claims of this nature, you should contact FDA's Center for Drug Evaluation and Research (CDER), Office of Compliance, HFD-310, 7520 Standish Place, Rockville, Maryland 20855.
