The L. Perrigo Company (Perrigo) respectfully requests to participate in the Electronic Filing of Drug Registration and Listing Information Pilot Project.

Perrigo is the nation's largest private-label manufacturer of OTC drug products, serving numerous mass merchandisers, chain drugstores and supermarkets. Most of the OTC products are marketed under existing OTC monographs. A small, but growing, volume of Perrigo's OTC products is covered by approved abbreviated new drug applications (ANDAs).

Perrigo would appreciate the opportunity to participate and provide feedback on the FDA's Electronic Filing process. Perrigo believes its participation in the Pilot Project would be beneficial to both Perrigo and the Agency due to the volume of reporting and vast experience with the drug listing process.

- The primary function of Perrigo is manufacturing OTC products, but in addition Perrigo distributes those products under several Perrigo label names. Perrigo also acts as a relabeler, and a repacker.
- Over 200 over-the-counter (OTC) human drug products are actively listed with the FDA.
- Four manufacturing sites are registered.

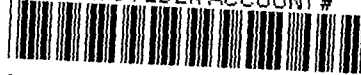
