## **UNA FIRMA EN NEW YORK RETIRA DEL MERCADO PRODUCTOS DE CARNE DE VACUNO Y DE AVES POR UNA POSIBLE CONTAMINACION CON *LISTERIA***

WASHINGTON, el 3 de Mayo del 2008 – Gourmet Boutique, L.L.C., en Jamaica, NY., esta retirando en forma voluntaria aproximadamente 286,320 libras de productos frescos y congelados de carne y aves que podrían estar contaminados con *Listeria* anuncio hoy el Servicio de Inocuidad e Inspección de los Alimentos (FSIS, por sus siglas en inglés) del Departamento de Agricultura de los EE.UU (USDA, por sus siglas en inglés).

Los siguientes productos han sido retirados del mercado (Los nombres de los productos están mencionados en inglés).

Los productos de ensaladas de carnes y aves frescas fueron producidos entre Abril 19 y abril 24 del 2008, Los productos congelados fueron producidos entre el 23 de octubre y el 23 de abril del 2007. Los productos de la retirada fueron enviados a nivel nacional a establecimientos de servicios de alimentos y almacenes al por menor.

El problema fue descubierto por el FSIS y el departamento de agricultura y servicios al consumidor de Florida a través de una muestra microbiológica. El FSIS no ha recibido ningún reporte de enfermedades relacionadas con el consumo de estos productos.

El consumo de alimentos contaminados con la bacteria *Listaria monocytogenes* puede causar Listeriosis, una enfermedad no muy común pero potencialmente fatal. Personas saludables raramente contraen Listeriosis. Sin embargo Listeriosis puede producir fiebre alta, fuertes dolores de cabeza, tortícolis y náuseas. Listeriosis también puede producir abortos espontáneos, así como también serias y algunas veces fatales infecciones en las personas que tienen el sistema inmunológico débil tales como los niños, personas de edad avanzada y las personas con HIV o las que están en tratamiento de quimioterapia

Retirada Clase I	Esta es una situación que presenta un peligro hacia la salud donde existe una probabilidad razonable que el uso del producto causará consecuencias serias, adversas a la salud, o la muerte.
Retirada Clase II	Esta es una situación que presenta un peligro hacia la salud donde existe una probabilidad remota que el uso del producto cause consecuencias adversas a la salud.
Retirada Clase III	Esta es una situación donde el uso del producto no causará consecuencias adversas a la salud.
