

## Jay Hein Convenes Meeting on Human Trafficking

On March 8<sup>th</sup>, Director Jay Hein and the White House Office on Faith-Based and Community Initiatives convened a meeting with Professor David Richardson, the Director of the Wilberforce Institute for the study of Slavery and Emancipation (WISE) at the University of Hull (Hull, England). Dr. Richardson was joined by American businessman Chuck Stetson to discuss their new ventures to commemorate the 200<sup>th</sup> anniversary of William Wilberforce's efforts to abolish the slave trade in Britain. Meeting participants brainstormed how to advance the cause of ending human trafficking by leveraging partnerships with academia, media and business.

Dr. Richardson is spending the month of March in the United States to lecture at Yale University and collaborate with U.S. partners in preparation for an international conference entitled, *Slavery: Unfinished Business* to be held May 16<sup>th</sup> - 19<sup>th</sup>, 2007, in Hull. Mr. Stetson is sponsoring a documentary entitled, *The Better Hour*, which offers a penetrating look at Wilberforce and presents various educational offerings for students and the general public.

The March 8<sup>th</sup> private meeting was organized for senior Bush administration officials and other leaders who have demonstrated an interest in the Wilberforce model and for those leading Wilberforce-type social justice projects in government or civil society. ### Department of Veterans Affairs Works to Restore Vision for Homeless Veterans

The U.S. Department of Veterans Affairs (VA) Center for Faith-Based and Community **Initiatives** (CFBCI) collaborated with VA Healthcare for Homeless Veterans (HCHV) and coordinators of programs for the homeless to create Restored Vision, a one program pilot year

which will provide eyeglasses to homeless veterans in five locations throughout the United States.

Restored Vision seeks partnerships with faith-based and community grassroots organizations to provide funds or vouchers for the cost of eyewear and eye exams. Each

Restored Vision site works with local which provides LensCrafters, homeless veterans free or reduced-priced glasses through its Gift of Sight Program. LensCrafters' Gift of Sight is also supported by community organizations such as Lions Club International, the Maryland Society for Sight, and the Jewish War Veterans. Bill Taylor, an indigent Vietnam veteran assisted by this program, said, "I knew I needed glasses, but I didn't have the money. Thanks to this program, I got my glasses." Appropriate eyewear enabled this homeless veteran to become self-sufficient, a necessary element in keeping veterans off of the streets. Over 150 veterans have received prescription glasses to restore their vision. # No Child Left Behind Technical Assistance Workshop

On March 7th, the Department of Education's Center for Faith-Based and Community **Initiatives** (CFBCI) partnered with the Department of Health and Human Services' CFBCI to conduct a "No Child Left Behind" technical assistance workshop in conjunction with the Michigan Department of Education (MDE) in Dearborn, Michigan. 146 people attended the workshop, which focused on youth related services as well as the availability of Federal funding for these services.

At the workshop, Shayam Menon, Director of Education's CFBCI, and Regional Todd Zoellick instructed Representative attendees on compliance with Federal equal treatment regulations and the provisions of "No Child Left Behind." MDE provided instruction on supplemental educational services (SES) and 21st Century Community Learning Centers grant applications. Ben O'Dell, Associate Director of Health and Human Service's CFBCI shared information about available

Federal funding to expand services to at-risk vouth.

## **Government Funding Opportunities**

#### Capacity Building Opportunity

The U.S. Department of Health and Human Services Administration for Children and Families (ACF) announced applications are being accepted for new grants under the Compassion Capital Fund (CCF) Targeted Capacity Building Program. ACF will award up to \$10 million through CCF to faith-based and community organizations that address the needs of distressed communities. A distressed community is defined as a neighborhood or geographic community with an unemployment rate and/or poverty rate equal to or greater than the State or national rate. The Targeted Capacity Building Program will focus on building among organizations capacity addressing the following programmatic service areas: help for at-risk youth; help for the homeless; marriage education and preparation services to help couples who choose marriage themselves develop for the skills and knowledge to form and sustain healthy marriages; or social services to those living in rural communities. Applications are due April 10, 2007.

#### Food Stamp Program

The U.S. Department of Agriculture (USDA) announced up to \$5 million in Food Stamp Program grants is available to improve the accessibility and awareness of USDA's Food Stamp Program for low-income households. The 2002 Farm Bill authorized USDA to award \$5 million in grants for projects aimed at simplifying the food stamp application and eligibility systems or improving access to food stamp benefits by eligible households. year USDA intends to fund at least one proposal that involves a partnership between a state agency and one or more private non-profit organizations, including faith or community based organizations. The Food Stamp Program, administered by USDA's Food and Nutrition Service, is the cornerstone of federal nutrition assistance programs and provides crucial support to working poor and needy households. The program currently serves more than 26 million people monthly.
