

EXECUTIVE SUMMARY

This report represents an accounting of Federal, and to the extent available, State, funding for Great Lakes restoration activities. This report is provided to Congress in response to Section 744 of Public Law 110-161, the Consolidated Appropriations Act, 2008 (the "Omnibus").

The FY 2009 President's Budget continues the Administration's strong support for Great Lakes environmental restoration by requesting over \$550 million for high priority programs and projects. This substantial funding, along with the President's 2004 signing of Executive Order 13340, demonstrates the Administration's commitment to the Great Lakes region.

This crosscut budget provides information on Federal funding for Great Lakes restoration work in the following formats:

- Total Federal funding by agency, which includes national and Great Lakes programs, as well as Great Lakes projects, FYs 2004 enacted-2009 President's Budget;
- Agency funding—national programs, FYs 2004 enacted-2009 President's Budget;
- Agency funding—Great Lakes programs, FYs 2004 enacted-2009 President's Budget; and
- Agency funding—Great Lakes projects, FYs 2004 enacted-2009 President's Budget.

As directed in the 2008 Omnibus, OMB requested Great Lakes restoration funding data from the Great Lakes States--New York, Pennsylvania, Ohio, Michigan, Indiana, Illinois, Wisconsin, and Minnesota. By February 15, 2008, OMB had received data only from Illinois, Michigan, and Indiana.

This report includes the data (or links to the data) as submitted by these States. OMB cannot verify the accuracy or completeness of the data.

The Administration looks forward to working with Congress to implement the President's FY 2009 request for the Great Lakes basin and continue these important efforts to protect human health and the environment in the region.

INTRODUCTION

This report represents an accounting of Federal, and to the extent available, State, funding for Great Lakes restoration activities. This report is provided to Congress in response to Section 744 of Public Law 110-161, the Consolidated Appropriations Act, 2008 (the "Omnibus").

The Great Lakes comprise the largest surface freshwater system in the world and provide drinking water, food, recreation, and transportation to more than 35 million Americans. In recognition of the Great Lakes' significance, President Bush signed Executive Order (E.O.) 13340 in 2004 that established a Federal Interagency Task Force (IATF) and promoted collaboration between Federal, State, local, and tribal governments to more effectively address environmental issues in the region. The IATF brings together Federal department and cabinet officers to provide strategic direction on Great Lakes policy.

Since the signing of E.O. 13340, Federal agencies have worked closely with State, Local, and tribal governments to collaborate on activities and shared goals in the Great Lakes region. This has resulted in an unprecedented and ongoing dialogue between Federal agencies and their non-Federal partners, as well as important accomplishments that will help protect and restore the Great Lakes ecosystem. These accomplishments include:

- Remediation of over 1.5 million pounds of contaminated sediment at six Areas of Concern (AOC) through EPA's Great Lakes Legacy Act. This work, funded by nearly \$97 million in Federal and non-Federal contributions, includes cleanup of over 25,000 pounds of PCBs, over one million pounds of chromium, approximately 400 pounds of mercury, and 171 pounds of lead.
- Delisting of the Oswego River (NY) AOC in 2007, the first U.S. AOC delisting since the U.S. and Canada jointly established AOCs in 1987.
- Restoration, protection, or improvement of approximately 65,000 acres of wetlands by IATF agencies, in support of the IATF's 100,000 acre near-term goal.
- Establishment by the IATF of the Federal Aquatic Invasive Species
 Rapid Response Subcommittee to coordinate Federal invasive species
 efforts. The Subcommittee has been working with partners to develop
 a Communication Protocol that will assist in coordinating efforts to
 ensure appropriate resources and expertise are available when
 needed.

- Listing of Asian Silver Carp, Largescale Silver Carp, and Black Carp as injurious under the Lacey Act.
- Completion of the electric carp barrier in Illinois to prevent the spread of these harmful species into the Great Lakes.

As stated in E.O. 13340, the Great Lakes are a national treasure, and protecting them requires the combined efforts of Federal, State, local, and tribal governments. It is only through systemic coordination at all levels of government that we will be able to continue to make progress in restoring the Great Lakes ecosystem.

FEDERAL DATA

This crosscut budget provides information on Federal funding for Great Lakes restoration work in the following formats:

- Total Federal funding by agency, which includes national and Great Lakes programs, as well as Great Lakes projects, FYs 2004 enacted-2009 President's Budget;
- Agency funding—national programs, FYs 2004 enacted-2009 President's Budget;
- Agency funding—Great Lakes programs, FYs 2004 enacted-2009 President's Budget; and
- Agency funding—Great Lakes projects, FYs 2004 enacted-2009 President's Budget.

This crosscut excludes Federal programs and projects that have never received at least \$500,000 in a fiscal year during the reporting period.

The FY 2009 President's Budget requests over \$550 million for Federal Great Lakes ecosystem restoration activities and programs. This proposal includes funding to:

- Provide \$35 million for EPA's Great Lakes Legacy Act projects with non-Federal partners to clean up over 350,000 cubic yards of contaminated sediment, removing toxic substances from waterways and protecting habitat and human health:
- Continue the Army Corps of Engineers' work on the McCook and Thornton Reservoirs in Illinois. This flood damage reduction project will limit backflows of raw sewage and other stormwater related pollutants from the city of Chicago into nearby water bodies and Lake Michigan; and
- Provide an estimated \$15 million increase in financial and technical assistance to farmers to help them implement conservation practices through USDA's Environmental Quality Incentives Program.

While the FY 2009 President's Budget proposed funding level is lower than that enacted in previous years, much of the decrease can be attributed to a few specific items. For example:

- The FY 2009 President's Budget request for the Great Lakes basin's share of EPA's Clean Water State Revolving Fund (SRF) capitalization funding is an estimated \$15 million less than the FY 2008 enacted level. However, the FY 2009 request fully supports the President's commitment to provide \$6.8 billion in total capitalization nationally for the Clean Water SRF between FYs 2004-2011 to help communities finance water infrastructure.
 - Due to the revolving nature of the program, funds available to communities through the Clean Water SRF continue to increase. As of early 2008, \$26 billion in Federal capitalization has resulted in \$65 billion in available funds nationally since the program's inception.
- The FY 2009 President's Budget for the Army Corps of Engineers does not fund earmarks for construction projects. Funds available for construction are allocated to give priority to the highest-performing ongoing projects in the Corps' main mission areas (commercial navigation, flood control, and aquatic ecosystem restoration). Environmental infrastructure projects such as wastewater treatment projects are outside the Corps' main mission areas and are not included in the President's Budget, providing savings of \$35 million in FY 2009.

It is important to note that for national programs, in many cases the numbers shown for FY 2009 are extrapolated either from past funding provided to the region, or by using the percentage of land in the Great Lakes basin relative to the rest of the State. The funding ultimately provided to the Great Lakes basin through national programs may differ from these estimates.

STATE DATA

As directed in the 2008 Omnibus, OMB requested the following information from the Great Lakes States (New York, Pennsylvania, Ohio, Michigan, Indiana, Illinois, Wisconsin, and Minnesota):

- Great Lakes restoration funding by State agency (e.g., Department of Environmental Quality, Department of Agriculture, Department of Natural Resources) and the respective program for FYs 2004-2009; and
- Federal funds used by the State for Great Lakes restoration activities in FYs 2007-2008.

OMB requested this data through letters to the governors of each State, and through followup email communications via EPA with the Governors' Priorities Task Force on the Great Lakes.

In response, the Council of Great Lakes Governors sent a letter to OMB that said "It is unclear precisely what information is being sought or what methodology is to be used for its collection in order to provide meaningful, consistent data from each state." The letter also said some States might follow up with additional information; however, by February 15, 2008, OMB had received data only from Illinois, Michigan, and Indiana.

This report includes the data (or links to the data) as submitted by these States. OMB does not guarantee the accuracy or completeness of the data and, in general, believes the data submitted is incomplete or underreports the extent of States' contributions to Great Lakes restoration.
