THE WHITE HOUSE FELLOWS PROGRAM HOSTS A RECEPTION TO PREMIER THE NEW **PROMOTIONAL DVD**

We are excited to have the new recruiting tool. We completed the filming for the promotional DVD in May and just received the final DVD copies. The White House Fellows Association will be providing a copy of the DVD to all of the alumni soon.

The film, which is now up on our website, includes interviews with program alumni, former and current principals, speakers, and others. The DVD also includes a range of historical footage, photographs, and action shots of the current Class of Fellows on policy study trips and in their agency placements.

The film was premiered at the Motion Picture Association of America on June 14th. Following comments by Jack Valenti and me, the audience of roughly 80 people was able to view the film. The feedback was outstanding! Nearly everyone commented on the representation of the program's rich history, as well as the education, fellowship, and placement aspects of the program. We are very excited to include the film on our website and in our recruiting efforts, and believe that it will do a terrific job of representing the White House Fellows' experience to those whom we hope to attract. Fellows Journey to Turkey, Poland, and Russia

n May, the Fellows traveled to Turkey, Poland, and Russia, visiting the cultural, commercial, and governmental centers of each (Istanbul/Ankara, Warsaw/Krakow, and Moscow/St. Petersburg). Three major study themes dominated this year's agenda: the challenges facing emerging democracies, the challenges of free market reforms, and security issues, including combating terrorism and weapons proliferation.

In each country, in addition to receiving a broad overview from State Department officials and Chamber of Commerce staff, the Fellows visited with the ministry officials of Foreign Affairs or Defense and leadership

from civil society and the private sector.

In Turkey, conversation centered on the topic of the country's bid for EU accession, the place of Islam and religious minorities within this secular democracy, and the economic and cultural legacy of Ataturk, which has enabled the country to achieve precocious success. The Fellows were fortunate to secure a meeting with Mustafa Koc, the third generation family owner/CEO of Turkey's largest conglomerate, which alone comprises 13 percent of Turkey's exports.

Highlights of the Poland experience included a site tour and briefing at the Polish subsidiary of McLane

The second session was designed and



Industries, a leading U.S. grocery and food service distributor, a panel discussion drawing numerous representatives from the nation's surprisingly advanced nongovernmental sector, and a meeting with the young director of an influential local think tank.

In Russia, the Fellows participated in a discussion of the operational challenges faced by Western energy businesses in a world where rule of law is inadequate and domestic politics unpredictable. They also participated in panel discussions with university students studying international affairs and members of the intellectual citizenry. The Fellows also took part in a review of the recent success of non-proliferation programs between our countries. Cultural highlights of the trip included visits to the Hagia Sophia Mosque, Blue Mosque, and covered bazaar in Istanbul, Ataturk's Mausoleum, and Ethnographic Museum in Ankara, the charming city of Krakow, the Kremlin and Winter Palace in Moscow, and the Summer Palace in St. Petersburg. The Fellows also took a side trip to Auschwitz.

Fellows agreed that these three emerging democracies (though Turkey had a 70 year head start, it is still a work in progress) had remarkably different outlooks and attitudes. The people of Turkey, and especially Poland, with whom the Fellows met seemed very optimistic, while the Russians were viewed as stuck in the past. This could be seen in everything from civic society and bonds, or lack thereof, between regular citizens, to the impressions of American expatriates.

Overall, the Fellows recognized how truly visionary our founding fathers were in creating our democratic and free-market systems almost 250 years ago. Though Turkey, Poland, and Russia have made great strides in the past 15 years, all of them face a much longer journey ahead. In this period when our own country faces serious challenges at home and abroad, the trip served as a timely reminder for us to make sure that we stay on the right track, check our own complacency, and re-affirm our great blessings.

he 2003-2004 Class of White House Fellows completed its domestic and international policy trip schedule in July with a tour through a portion of America's heartland. Over the course of three days, the Class visited Oklahoma City, Tulsa, and rural parts of Oklahoma, capping off a year in which the Fellows had the privilege of experiencing such disparate destinations as the Big Apple and St. Petersburg, Russia.

Equipped through an informative pre-brief by Congressman Brad Carson ('97-98), the Fellows began their trip in the State's capital. The Oklahoma Bureau of Narcotics provided a comprehensive and sobering look at the burgeoning metham-

phetamine problem in Middle America. The Class received a compelling tour of the Oklahoma City Bombing Memorial and Museum, followed by a briefing on the ground-breaking research being conducted at the adjoining National Memorial Institute for the Prevention of Terrorism.

In order to better understand the challenges facing the energy sector, the Fellows spent a day tracing the production and utilization of fossil fuels from the oil rig through the refinery to the trading floor. White House Fellow alum Tom Bennett ('85-86) of Tulsa, his wife, Sue, and the family of Gentner Drummond hosted the Fellows at the Post Oak Lodge – providing a spectacular

dinner of authentic rural fare, and a discussion with Cherokee Nation Principal Chief Chad "Corntassle" Smith.

The Class spent the last day on horseback, joining the owners and cowboys of the Drummond Ranch in northern Oklahoma for a genuine look into rural life, the agricultural economy, and the frontier heritage that persists throughout the Great Plains. The Fellows had the opportunity through the Oklahoma trip to experience and reflect on the vital importance of America's vibrant interior and to better grasp the obstacles and opportunities that lie in its vast expanse.
