This application packet contains information and the required forms for you to use in submitting a new application for funding under one program authorized by the Individuals with Disabilities Education Act (IDEA). This packet covers two competitions under the Technology and Media Services for Individuals with Disabilities (CFDA 84.327) program--Educational Materials in Accessible Formats for Students with Visual Impairments and Other Print Disabilities (CFDA No. 84.327K) and Educational Media Activities to Improve State Systems for Providing Educational Materials in Accessible Formats (CFDA No. 84.327S).

I. Funding Opportunity Description

<u>Purpose of Program</u>: The purpose of the Technology and Media Services for Individuals with Disabilities program is to:

(1) improve results for students with disabilities by promoting the development, demonstration, and use of technology; (2) support educational media services activities designed to be of educational value in the classroom for students with

Priority:

The purpose of this priority is to provide free educational materials, including textbooks, in accessible media for use by students with visual impairments and other print disabilities in elementary and secondary schools and in postsecondary and graduate schools. These materials may be provided using CD-ROMs, audiotapes, and similar technologies, including electronic text and digital audio synchronization.

To be considered for funding under this priority, the project must--

- (a) Provide educational materials in accessible formats to State educational agencies (SEAs) and local educational agencies (LEAs) for use by elementary and secondary education students with visual impairments or other print disabilities. The educational materials, including specialized equipment needed to use the materials, must be provided at no cost. For example, the project may not assess membership fees to individual students or to institutions, including schools, SEAs, or LEAs;
- (b) Provide educational materials in accessible formats for students with visual impairments or other print disabilities attending postsecondary and graduate schools. Materials may be provided directly to eligible students or to postsecondary and graduate institutions and vocational rehabilitation agencies requesting materials in accessible formats on behalf of eligible students. The materials and equipment needed to use the materials must be provided free of charge. For example, the project may not assess fees to individual students or to institutions, including, vocational rehabilitation agencies, post-secondary schools, and graduate schools;
- (c) Obtain statements of eligibility signed by professionals who certify the eligibility of postsecondary and graduate students with visual impairments and other print disabilities and the students' specific need for educational materials in accessible formats;

- (d) Coordinate and collaborate with publishers, software developers, other manufacturers of accessible materials for individuals with visual impairments or print disabilities, and the National Instructional Materials Access Center (NIMAC) to ensure that the project uses the most effective and economical technology available to provide access to educational materials, including textbooks;
- (e) To the fullest extent possible and appropriate, produce accessible materials using files that are compliant with the National Instructional Materials Accessibility Standard (NIMAS);
- (f) Coordinate with SEAs, LEAs, other government agencies, and disability and educational organizations, including the NIMAC, to ensure non-duplication of effort in the production or acquisition of accessible materials and in the delivery of these materials to SEAs, LEAs, and eligible postsecondary and graduate students;
- (g) Cooperate with SEA and LEA efforts to implement or improve State systems for providing educational materials in accessible formats to students with visual impairments or other print disabilities;
- (h) Ensure that project activities are conducted in compliance with section 121 of the Copyright Act, as amended;
- (i) Establish an advisory group consisting of SEA and LEA representatives, parents of individuals with visual impairments

and other print disabilities ages birth through 26, consumers with visual impairments and consumers with other print disabilities who use educational materials in accessible formats, and schools or other institutions where educational materials in accessible formats are used. The purpose of this advisory group is to provide the project with input and ongoing advice on the project's goals, objectives, program activities, and services;

- (j) Budget for a one and one-half day kick-off meeting to be held in Washington, DC, within four weeks after receipt of the award. The primary purposes of this meeting will be to review the Department's grantee requirements, discuss the project's planned activities and budget, and confirm the expectations for the project's performance measures and evaluation;
- (k) Budget for a three-day Project Director's meeting in Washington, DC, during each year of the project, and one additional two-day trip to Washington, DC, to meet with the Project Officer for the Office of Special Education Program (OSEP) and other funded projects for purposes of cross-project collaboration and information exchange; and
- (1) Include on its Web site, if the project maintains a Web site, relevant information and documents in a format that meets a government or industry-recognized standard for accessibility.

Fourth and Fifth Years of Project:

In deciding whether to continue this project for the fourth and fifth years, the Secretary will consider the requirements of 34 CFR 75.253(a), and in addition--

- (a) The recommendations of a review team consisting of experts selected by the Secretary. The review will be conducted during the last half of the project's second year in Washington, DC. Projects must budget for travel expenses associated with this one-day intensive review;
- (b) The timeliness and effectiveness with which all requirements of the negotiated cooperative agreement have been, or are being, met by the project; and
- (c) Evidence of the quality, relevance, and usefulness of the project's activities and the degree to which the project's activities have contributed to improved results for students with disabilities.

Waiver of Proposed Rulemaking: Under the Administrative

offers interested parties the opportunity to comment on proposed

Enhancement activities are either expansions of activities already described in the narrative or new activities that will improve the quality

of the tasks proposed by the applicant; for example, increased production and distribution of materials in accessible formats, the acquisition of expert technical assistance, or improved stakeholder involvement. A separate budget for the enhancement funds must be prepared and included in Part II of the application if the applicant chooses to include a proposal for potential enhancements as part of its application. The budget for the enhancement funds may not exceed \$5,000,000.

- 2. <u>Cost Sharing or Matching</u>: This competition does not require cost sharing or matching.

- (a) The projects funded under this competition must make positive efforts to employ, and advance in employment, qualified individuals with disabilities (see section 606 of IDEA).
- (b) The applicant and grant recipient funded under this competition must involve individuals with disabilities or parents of individuals with disabilities ages birth through 26 in planning, implementing, and evaluating the project (see section 682(a)(1)(A) of IDEA).

Background:

The IDEA requires States to provide a free appropriate public education (FAPE) to all students with disabilities. This includes the provision of educational materials in accessible formats for students with disabilities eligible for services under Part B of IDEA, including students with visual impairments or other print disabilities and learning disabilities.

The 2004 amendments to IDEA added several new provisions to improve the timely production and dissemination of educational materials in accessible formats for students who are blind and other students with print disabilities, including the following:

- Section 612(a)(23) of IDEA requires States, including the Outlying Areas (OAs) (United States Virgin Islands, Guam, American Samoa, and the Commonwealth of the Northern Mariana Islands) and the Freely Associated States (FAS) (Palau, the Marshall Islands, and the Federated States of Micronesia), to adopt the National Instructional Materials Accessibility Standard (NIMAS) for the purpose of providing instructional materials to persons who are blind and other persons with print disabilities, and to ensure that these materials are provided in a timely manner. (Section 613(a)(6) of IDEA includes similar requirements for local educational agencies (LEAs)).
- Section 674(e) of IDEA requires the Department of Education (Department) to establish a National Instructional Materials Access Center (NIMAC) to act as a repository for electronic files of print instructional materials created in the NIMAS format.
- Section 612(a)(23) of IDEA requires States, including the OAs and FAS, that choose to coordinate with the NIMAC, as part of any materials adoption process, procurement contract, or other practice or instrument used for purchase of print

instructional materials, to enter into a written contract with the publisher of the print instructional materials to: (1) require the publisher to prepare and provide, on or before delivery of the print instructional materials, the NIMAC with NIMAS-compliant electronic files of print instructional materials (section 613(a)(6) of IDEA contains similar requirements for LEAs) or (2) purchase instructional materials from the publisher that are produced in, or may be rendered in, specialized formats.

Educational materials obtained from the NIMAC only may be provided to students with disabilities who meet the eligibility criteria of section 674(e) of IDEA. However, the group of students that meets the 674(e) eligibility criteria does not include all students with disabilities eligible under Part B of IDEA whom State educational agencies (SEAs) and LEAs are required to serve. In the preamble to the regulations implementing Part B of IDEA (71 FR 46618), the Department explained that SEAs and LEAs have an obligation to provide accessible instructional materials in a timely manner to children with disabilities who may need educational materials in accessible formats, but who are not eligible to receive materials produced from files obtained through the NIMAC. States must determine how they will provide accessible materials to children who are eligible to receive materials produced from

files obtained through the NIMAC, as well as to children who are eligible to receive services under Part B of IDEA but who are not eligible to receive materials produced from files obtained through the NIMAC.

States, including the OAs and FAS, and LEAs are experiencing significant challenges implementing these new provisions, including adapting existing systems for providing educational materials in accessible formats to address the new requirements. This priority supports educational media activities that address State needs for assistance in providing students with disabilities educational materials in accessible formats.

Priority:

The purpose of this priority is to support educational media activities that establish or enhance State, including OAs and FAS, systems or mechanisms for providing educational materials in accessible formats for students with disabilities who are eligible for services under Part B of IDEA.

Applicants must describe in their applications their specific plans for how they will use grant funds received under this priority to implement or enhance State systems for providing educational materials in accessible formats in a timely manner to students with disabilities who are eligible under Part B of IDEA, and ensuring that the accessible formats

are appropriate for use by these students. Activities may include, but are not limited to, activities that assist States to:

- understand and implement the NIMAS and NIMAC requirements in Part B of IDEA;

ABSOLUTE PRIORITY:

The purpose of this priority is to provide free educational materials, including textbooks, in accessible media for use by students with visual impairments and other print disabilities in elementary and secondary schools and in postsecondary and graduate schools. These materials may be provided using CD-ROMs, audiotapes, and similar technologies, including electronic text and digital audio synchronization.

To be considered for funding under this priority, the project must--

- (a) Provide educational materials in accessible formats to State educational agencies (SEAs) and local educational agencies (LEAs) for use by elementary and secondary education students with visual impairments or other print disabilities. The educational materials, including specialized equipment needed to use the materials, must be provided at no cost. For example, the project may not assess membership fees to individual students or to institutions, including schools, SEAs, or LEAs;
- (b) Provide educational materials in accessible formats for students with visual impairments or other print disabilities attending postsecondary and graduate schools. Materials may be provided directly to eligible students or to postsecondary and graduate institutions and vocational rehabilitation agencies requesting materials in accessible formats on behalf of eligible students. The materials and equipment needed to use the materials must be provided free of charge. For example, the project may not assess fees to individual students or to institutions, including, vocational rehabilitation agencies, post-secondary schools, and graduate schools;
- (c) Obtain statements of eligibility signed by professionals who certify the eligibility of postsecondary and graduate students with visual impairments and other print disabilities and the students' specific need for educational materials in accessible formats;
- (d) Coordinate and collaborate with publishers, software developers, other manufacturers of accessible materials for individuals with visual impairments or print disabilities, and the National Instructional Materials Access Center (NIMAC) to ensure that the project uses the most effective and economical technology available to provide access to educational materials, including textbooks;
- (e) To the fullest extent possible and appropriate, produce accessible materials using files that are compliant with the National Instructional Materials Accessibility Standard (NIMAS);

- (f) Coordinate with SEAs, LEAs, other government agencies, and disability and educational organizations, including the NIMAC, to ensure non-duplication of effort in the production or acquisition of accessible materials and in the delivery of these materials to SEAs, LEAs, and eligible postsecondary and graduate students;
- (g) Cooperate with SEA and LEA efforts to implement or improve State systems for providing educational materials in accessible formats to students with visual impairments or other print disabilities;
- (h) Ensure that project activities are conducted in compliance with section 121 of the Copyright Act, as amended;
- (i) Establish an advisory group consisting of SEA and LEA representatives, parents of individuals with visual impairments and other print disabilities ages birth through 26, consumers with visual impairments and consumers with other print disabilities who use educational materials in accessible formats, and schools or other institutions where educational materials in accessible formats are used. The purpose of this advisory group is to provide the project with input and ongoing advice on the project's goals, objectives, program activities, and services;
- (j) Budget for a one and one-half day kick-off meeting to be held in Washington, DC, within four weeks after receipt of the award. The primary purposes of this meeting will be to review the Department's grantee requirements, discuss the project's planned activities and budget, and confirm the expectations for the project's performance measures and evaluation;
- (k) Budget for a three-day Project Director's meeting in Washington, DC, during each year of the project, and one additional two-day trip to Washington, DC, to meet with the Project Officer for the Office of Special Education Program (OSEP) and other funded projects for purposes of cross-project collaboration and information exchange; and
- (l) Include on its Web site, if the project maintains a Web site, relevant information and documents in a format that meets a government or industry-recognized standard for accessibility.

Fourth and Fifth Years of Project:

EDUCATIONAL MEDIA ACTIVITIES TO IMPROVE STATE SYSTEMS FOR PROVIDING EDUCATIONAL STUDENTS WITH VISUAL IMPAIRMENTS AND OTHER PRINT DISABILITIES (CFDA 84.327S)

DEADLINE: 09/04/07

ABSOLUTE PRIORITY:

Background:

The IDEA requires States to provide a free appropriate public education (FAPE) to all students with disabilities. This includes the provision of educational materials in accessible formats for students with disabilities eligible for services under Part B of IDEA, including students with visual impairments or other print disabilities and learning disabilities.

The 2004 amendments to IDEA added several new provisions to improve the timely production and dissemination of educational materials in accessible formats for students who are blind and other students with print disabilities, including the following:

- Section 612(a)(23) of IDEA requires States, including the Outlying Areas (OAs) (United States Virgin Islands, Guam, American Samoa, and the Commonwealth of the Northern Mariana Islands) and the Freely Associated States (FAS) (Palau, the Marshall Islands, and the Federated States of Micronesia), to adopt the National Instructional Materials Accessibility Standard (NIMAS) for the purpose of providing instructional materials to persons who are blind and other persons with print disabilities, and to ensure that these materials are provided in a timely manner. (Section 613(a)(6) of IDEA includes similar requirements for local educational agencies (LEAs)).
- Section 674(e) of IDEA requires the Department of Education (Department) to establish a National Instructional Materials Access Center (NIMAC) to act as a repository for electronic files of print instructional materials created in the NIMAS format.
- Section 612(a)(23) of IDEA requires States, including the OAs and FAS, that choose to coordinate with the NIMAC, as part of any materials adoption process, procurement contract, or other practice or instrument used for purchase of print instructional materials, to enter into a written contract with the publisher of the print instructional materials to: (1) require the publisher to prepare and provide, on or before delivery of the print instructional materials, the NIMAC with NIMAS-compliant electronic files of print instructional materials (section 613(a)(6) of IDEA contains similar requirements for LEAs) or (2) purchase instructional materials from the publisher that are produced in, or may be rendered in, specialized formats.

Educational materials obtained from the NIMAC only may be provided to students with disabilities who meet the eligibility criteria of section 674(e) of IDEA. However, the group of students that meets the 674(e) eligibility criteria does not include all students with disabilities

eligible under Part B of IDEA whom State educational agencies (SEAs) and LEAs are required to serve. In the preamble to the regulations implementing Part B of IDEA (71 FR 46618), the Department explained that SEAs and LEAs have an obligation to provide accessible instructional materials in a timely manner to children with disabilities who may need educational materials in accessible formats, but who are not eligible to receive materials produced from files obtained through the NIMAC. States must determine how they will provide accessible materials to children who are eligible to receive materials produced from files obtained through the NIMAC, as well as to children who are eligible to receive services under Part B of IDEA but who are not eligible to receive materials produced from files obtained through the NIMAC.

States, including the OAs and FAS, and LEAs are experiencing significant challenges implementing these new provisions, including adapting existing systems for providing educational materials in accessible formats to address the new requirements. This priority supports educational media activities that address State needs for assistance in providing students with disabilities educational materials in accessible formats.

Priority:

The purpose of this priority is to support educational media activities that establish or enhance State, including OAs and FAS, systems or mechanisms for providing educational materials in accessible formats for students with disabilities who are eligible for services under Part B of IDEA.

Applicants must describe in their applications their specific plans for how they will use grant funds received under this priority to implement or enhance State systems for providing educational materials in accessible formats in a timely manner to students with disabilities who are eligible under Part B of IDEA, and ensuring that the accessible formats are appropriate for use by these students. Activities may include, but are not limited to, activities that assist States to:

- understand and implement the NIMAS and NIMAC requirements in Part B of IDEA;
- reconcile conflicting State and Federal statutory and regulatory provisions related to types of file formats that must be used in producing educational materials in accessible formats;
- modify State and LEA systems that use other file formats to use NIMAS complaint-files;
- determine how the SEA will assess the need for educational materials in accessible formats, assist LEAs in determining how student needs for accessible materials will be identified, document needs in students' individualized education programs (IEPs), and certify the eligibility of students for NIMAC materials in accordance with section 674(e)(3)(A) of IDEA;
- develop data management and tracking systems for managing NIMAS files and providing educational materials in accessible formats:

- identify vendors that convert NIMAS files into accessible formats and, as necessary, distribute the materials produced from the NIMAS files;
- create an integrated system that coordinates NIMAC-related requests and educational
 media activities of students with visual impairments and other print disabilities with
 educational media activities that benefit children with disabilities who do not meet the
 NIMAC eligibility requirements, but who need accessible versions of educational
 materials as determined pursuant to section 614(d) of IDEA;
- build upon existing State systems or infrastructures related to special education or regular education, rather than creating new systems to address the NIMAS and NIMAC requirements, as appropriate; and
- coordinate with Federal technical assistance providers, such as the NIMAS Technical Assistance Center.

Applicants that are <u>not</u> SEAs, FAS, or OAs also may apply if the application includes a letter of endorsement from an SEA, FAS, or OA indicating that the applicant is applying on its behalf.

Where it would be a more effective use of resources, SEAs, FAS, and OAs are encouraged to form consortia that meet the requirements in 34 CFR 75.127 to 75.129, and submit a joint application that proposes to use the combined funds available for each State, FAS, or OA. A consortium is comprised of more than one eligible entity and could include entities from the same geographic region or entities with similar demographic characteristics, populations, geographic characteristics, or other characteristics. The Secretary views the formation of consortia as an effective and efficient strategy to address the requirements of this priority.

Projects funded under this priority also must--

- (a) Budget for a three-day Project Directors' meeting in Washington, DC during the 18-month project period, plus one additional two-day trip to Washington, DC to meet with the Office of Special Education Programs (OSEP) Project Officer and other funded projects for purposes of cross-project collaboration and information exchange.
- (b) If the project maintains a Web site, include relevant information and documents in a format that meets a government or industry-recognized standard for accessibility.

Program Authority: 20 U.S.C. 1474 and 1481.

PERFORMANCE MEASURES: Under the Government Performance and Results Act of 1993 (GPRA), the Department has developed measures that will yield information on various aspects of the quality of the Technology and Media Services for Individuals with Disabilities program. These measures focus on the extent to which projects are of high quality, are relevant to the needs of children with disabilities, and contribute to improving the results for children with

disabilities. We will collect data on these measures from the projects funded under this competition.

Grantees also will be required to report information on their projects' performance in annual reports to the Department (34 CFR 75.590).

APPLICATIONS AVAILABLE: August 3, 2007.

DEADLINE FOR TRANSMITTAL OF APPLICATIONS: September 4, 2007.

DEADLINE FOR INTERGOVERNMENTAL REVIEW: September 7, 2007.

ESTIMATED AVAILABLE FUNDS: \$6,300,000. Contingent upon the availability of funds and the quality of applications, we may make additional awards in FY 2008 from the list of unfunded applicants from this competition.

ESTIMATED RANGE OF AWARDS: \$400,000-\$500,000.

ESTIMATED AVERAGE SIZE OF AWARDS: \$420,000.

MAXIMUM AWARD: The maximum amount available per State, OA, or FAS is \$500,000. The level of funding for a consortium or any other group of States, including OAs and FAS, may not exceed the combined total of the maximum amounts that the entities comprising the consortium or group could have received if they had applied separately. The Secretary does not intend to make more than one award to serve a State, OA or FAS. The Assistant Secretary for Special Education and Rehabilitative Services may change the maximum amount through a notice published in the Federal Register.

<u>PAGE LIMITS</u>: If your proposed project is for a single State, you must limit the application narrative Part III to the equivalent of no more than 15 pages. To determine the number of pages or the equivalent, you must use the following standards:

SELECTION CRITERIA AND FORMAT FOR THE EDUCATIONAL MATERIALS IN ACCESSIBLE FORMATS FOR STUDENTS WITH VISUAL IMPAIRMENTS AND OTHER PRINT DISABILITIES (CFDA 84.327K) AND THE EDUCATIONAL MEDIA ACTIVITIES TO IMPROVE STATE SYSTEMS FOR PROVIDING EDUCATIONAL STUDENTS WITH VISUAL IMPAIRMENTS AND OTHER PRINT DISABILITIES (CFDA 84.327) COMPETITIONS

Part III of the application form requires a narrative that addresses the selection criteria that will be used by reviewers in evaluating individual proposals. Applications are more likely to receive favorable reviews by panels when they are organized according to the format suggested below. This format was published in the FEDERAL REGISTER as an appendix to the program regulations, and it addresses all the selection criteria used to evaluate applications required by regulations. If you prefer to use a different format, you may wish to cross-reference the sections of your application to the selection criteria to be sure that reviewers are able to find all relevant information.

The selection criteria that will be used to evaluate applications submitted to the Educational Materials in Accessible Formats for Students with Visual Impairments and Other Print Disabilities (CFDA 84.327K) and the Educational Media Activities to Improve State Systems for Providing Educational Students with Visual Impairments and Other Print Disabilities (CFDA 84.327S) competitions are the selection criteria for new grants required by the EDGAR general selection criteria menu. The maximum score for all of the criteria is 100 points.

An **abstract**, not to exceed two pages, should precede the application narrative of all applications and it would be helpful if it included the following information: Purpose of the project; disability addressed by the project; age group (e.g., 0-3, preschool, elementary school, middle school, high school, secondary transition, and postsecondary); geography (e.g., rural, suburban, urban); severity (e.g., mild, moderate, and severe); proposed products; proposed outcomes; names/affiliations of key collaborators. It would be helpful if the abstract includes: (a) the title of the program, (b) the name of the Absolute Priority, and (c) the CFDA Number (e.g., 84.327S).

For Technology and Technical Assistance and Dissemination applications, the abstract should include (a) design and (b) project evaluation, including measures.

The application narrative should include the following sections in this order:

(a) Need for project (10 points)

- (1) The Secretary considers the need for the proposed project.
- (2) In determining the need for the proposed project, the Secretary considers the following factors:
- (i) The magnitude of the need for the services to be provided or the activities to be carried out by the proposed project; and
- (ii) The extent to which the proposed project will focus on serving or otherwise addressing the needs of disadvantaged individuals.

(b) Quality of project services (30 points)

- (1) The Secretary considers the quality of the services to be provided by the proposed project.
- (2) In determining the quality of the services to be provided by the proposed project, the Secretary considers the quality and sufficiency of strategies for ensuring equal access and treatment for eligible project participants who are members of groups that have traditionally been underrepresented based on race, color, national origin, gender, age, or disability.
 - (3) In addition, the Secretary considers the following factor:
- (i) The extent to which the services to be provided by the proposed project are appropriate to the needs of the intended recipients or beneficiaries of those services.

(c) Quality of project personnel (20 points)

- (1) The Secretary considers the quality of the personnel who will carry out the proposed project.
- (2) In determining the quality of project personnel, the Secretary considers the extent to which the applicant encourages applications for employment from persons who are members of groups that have traditionally been underrepresented based on race, color, national origin, gender, age, or disability.
 - (3) In addition, the Secretary considers the following factors:
- (i) The qualifications, including relevant training and experience, of the project director or principal investigator;
- (ii) The qualifications, including relevant training and experience, of key project personnel; and
- (iii) The qualifications, including relevant training and experience, of project consultants or subcontractors.

(d) Quality of the management plan (20 points)

- (1) The Secretary considers the quality of the management plan for the proposed project.
- (2) In determining the quality of the management plan for the proposed project, the Secretary considers the following factors:

- (i)The adequacy of the management plan to achieve the objectives of the proposed project on time and within budget, including clearly defined responsibilities, timelines, and milestones for accomplishing project tasks;
- (ii) The adequacy of procedures for ensuring feedback and continuous improvement in the operation of the proposed project; and
- (iii) The adequacy of mechanisms for ensuring high-quality products and services from the proposed project.

(e) Adequacy of resources (20 points)

- (1) The Secretary considers the adequacy of resources for the proposed project.
- (2) In determining the adequacy of resources for the proposed project, the Secretary considers the following factors:
- (i) The adequacy of support, including facilities, equipment, supplies, and other resources, from the applicant organization or the lead applicant organization;
- (ii) The relevance and demonstrated commitment of each partner in the proposed project to the implementation and success of the project;
 - (iii) The extent to which the budget is adequate to support the proposed project;
- (iv) The extent to which the costs are reasonable in relation to the objectives, design, and potential significance of the proposed project;
- (v) The extent to which the costs are reasonable in relation to the number of persons to be served and to the anticipated results and benefits; and
- (vi) The potential for continued support of the project after Federal funding ends, including, as appropriate, the demonstrated commitment of appropriate entities to such support.

GENERAL INFORMATION ON COMPLETING AN APPLICATION

GENERAL INFORMATION ON COMPLETING AN APPLICATION

Potential applicants frequently direct questions to officials of the Department regarding application notices and programmatic and administrative regulations governing various direct grant programs. To assist potential applicants, the Office of Special Education Programs staff have assembled the following most commonly raised issues. In general, this information applies to the grant competitions covered by this application package.

EXTENSION OF DEADLINES

Waivers for individual applications are not granted, regardless of the circumstances. Under very extraordinary circumstances a closing date may be changed. Such changes are announced in the Federal Register.

COPIES OF THE APPLICATION

Current Government-wide policy is that only an original and two copies need to be submitted. OSEP would appreciate receiving three additional copies to facilitate the peer review process. This would mean an original and two copies need to be submitted and we would appreciate your voluntarily submitting an additional three copies (six applications in all). Copies of the application may be bound, but it is not necessary or required. If bound, one copy should be left unbound to facilitate electronic scanning and any necessary reproduction. Applicants should not use colored paper, foldouts, photographs, or other materials that are hard to duplicate.

Please Note: If an application is recommended for funding and a grant award is issued, we will contact the applicant to request a copy of the application on a diskette or CD. The Department is moving toward an electronic grant filing system and an electronic copy of all applications that are being funded will facilitate this effort.

MAKING APPLICATIONS MORE ACCESSIBLE TO REVIEWERS WHO ARE BLIND OR HAVE LOW VISION

The Department will accept one copy of the application in an accessible format (i.e., IBM PC compatible WordPerfect or ASCII code diskette) along with the original and two print copies of the application. The accessible format copy can be used with available software to convert the text of the application into Braille, or with text to voice applications. If there are any differences in the print original provided on the disk and in print, the print original is assumed to be the correct version. Please note that it is not a requirement that one copy of the application be in an accessible format.

MISSED DEADLINES AND SUBMISSION UNDER OTHER COMPETITIONS

Should an application miss the deadline for a particular competition, it may be submitted to another competition. However, if an application is properly prepared to meet the specifications of one competition, it is extremely unlikely that it would be favorably evaluated under a different competition.

SUBMISSION TO MORE THAN ONE PROGRAM

Applications may be submitted to more than one Federal program if you are unsure of the most appropriate program. Each application should be prepared following the instructions for that particular program as closely as possible (which may require some reformulation). It is very helpful if each program is notified that an identical or similar application is being submitted to another program.

HELP PREPARING APPLICATIONS

We are happy to provide general program information. Clearly it would <u>not</u> be appropriate for staff to participate in the actual writing of an application, but we can respond to specific questions about our application requirements and evaluation criteria, or about the announced priorities. Applicants should understand that such previous contact is not required, nor does it guarantee the success of an application.

NOTIFICATION OF FUNDING

The time required to complete the evaluation of applications is variable. Once applications have been received staff must determine the areas of expertise needed to appropriately evaluate the applications, identify and contact potential reviewers, convene peer review panels, and summarize and review the recommendations of the review panels. You can expect to receive notification within 3 to 6 months of the application closing date, depending on the number of applications received and the number of competitions with closing dates at about the same time. The requested start date can be no later than January 1 of the year following the competition's fiscal year (FY). For example, FY 2006 applications may request a start date no later than January 1, 2007.

POSSIBILITY OF LEARNING THE OUTCOME OF REVIEW PANELS PRIOR TO OFFICIAL NOTIFICATION

Every year we are called by a number of applicants who have legitimate reasons for needing to know the outcome of the review prior to official notification. Some applicants need to make job decisions, some need to notify a local school district, etc. Regardless of the reason, we cannot share information about the review with <u>anyone</u> until the Assistant Secretary has approved a slate of projects recommended for funding. You will be notified as quickly as possible either by telephone (if your application is recommended for funding), or through a letter (if your application is not successful).

FORMAT FOR APPLICATIONS

The application narrative (Part III of the application form) should be organized to follow the exact sequence of the components in the selection criteria used to evaluate applications. (The selection criteria for the competitions covered by this packet are listed following the specific competition information in section "B" of this packet.) A table of contents, list of priority requirements, and an abstract (see page B-13) should precede the application narrative. If you prefer to use a different format, you may wish to cross-reference the sections of your application to the selection criteria to be sure that reviewers are able to find all relevant information.

To aid in screening and reviewing the application, applicants should list in Part II and prior to the abstract, all general, special, and other requirements for the priority and corresponding page number (s) where requirements are addressed within the application. Page limits do not apply to this list. (All requirements are found in each priority description included in this application package.) The format included below is an example of how you might provide this information in your application.

PAGE LIMITS

Please note that all applications submitted under the competition in this application package must adhere to the Part III - Application Narrative page limit requirements that are specified under each priority/competition description. Your application should provide enough information to allow the review panel to evaluate the importance and impact of the project as well as to make knowledgeable judgments about the methods you propose to use (design, subjects, sampling procedures, measures, instruments, data analysis strategies, etc.). It is often helpful to have:

- (l) <u>Staff Vitae</u>--They should include each person's title and role <u>in the proposed project</u> and contain <u>only</u> information that is <u>relevant</u> to <u>this</u> proposed <u>project's</u> activities and/or publications. Vitae for consultants and Advisory Council members should be similarly brief.
- (2) <u>Instruments</u>--except in the case of generally available and well known instruments.
- (3) <u>Agreements</u>—when the participation of an agency other than the applicant is critical to the project. This is particularly critical when an intervention will be implemented within an agency, or when subjects will be drawn from particular agencies. Letters of cooperation should be specific, indicating agreement to implement a particular intervention or to provide access to a particular group of students.

The items listed above are not included under page limits.

MAKING SURE APPLICATION IS ASSIGNED TO THE CORRECT COMPETITION

Applicants should clearly indicate in Item 11 on the application (SF Form 424) the CFDA number of the program priority (e.g., 84.327K, etc.) representing the competition in which the application should be considered. If this information is not provided, your application may inadvertently be assigned and reviewed under a different competition from the one you intended.

RETURN OF NON-FUNDED APPLICATIONS

We do not return original copies of applications. Thus, applicants should retain at least one copy of the application. Copies of reviewer comments will be mailed to all applicants.

PROPOSED STAFF AVAILABILITY TO PROJECT

For each staff person named in the application, please provide documentation of all internal and external time commitments. In instances where a staff person is committed on a federally supported project, please provide the project name, Federal office, program title, the project Federal award number, and the amount of committed time by each project year. This information (e.g., <u>Staff</u>: Jane Doe; <u>Project Name</u>: Succeeding in the General Curriculum; <u>Federal office</u>: Office of Special Education Programs; <u>Program title</u>: Technical Assistance and Dissemination to Improve Services and Results for Children with Disabilities; <u>Award number</u>: H326A030002; <u>Time commitments</u>: Year 1—30%; Year 2—25% and Year 3—40%) can be provided as an Appendix to the application.

In general, we will not reduce time commitments on currently funded grants from the time proposed in the original application. Therefore, we will not consider for funding any application where key staff are bid above a time commitment level that staff have available to bid. Further, the time commitments stated in newly submitted applications will not be negotiated down to permit the applicant to receive a new grant award.

USE OF PERSON LOADING CHARTS

It is important for applicants to include proposed time commitments for all project personnel. Also, program officials and applicants often find person loading charts useful formats for showing project personnel and their time commitments to individual activities. A person loading chart is a tabular representation of major evaluation activities by number of days spent by each key person involved in each activity, as shown in the following example.

DELIVERING/SENDING APPLICATIONS TO THE COMPETITION MANAGER

Applications can be mailed or hand delivered, or submitted electronically but in either case <u>must</u> go to the Application Control Center at the address listed in the <u>Application Transmittal Instructions</u>. Delivering or sending the application to the competition manager in the program office may prevent it from being logged in on time to the appropriate competition and may result in the application not being reviewed.

ALLOWED TRAVEL UNDER THESE PROJECTS

Travel is allowed if the travel specifically relates to the expressed goals of the project. Travel by students to further their education under the project's goals is also allowed. Travel to conferences is the travel item that is most likely to be questioned during negotiations. Such travel is sometimes allowed when it is for purposes of dissemination, when there will be results to be disseminated, and when it is clear that a conference presentation or workshop is an effective way of reaching a particular target group.

FUNDING OF APPROVED APPLICATIONS

It is often the case that the number of applications recommended for approval by the reviewers exceeds the dollars available for funding projects under a particular competition. When the panel reviews are completed for a particular competition, the individual reviewer scores and applications are ranked. The higher ranked, approved applications are funded first, and there are often lower ranked, approved applications that do not receive funding. Sometimes, one or two applications that are approved and fall next in rank order (after those projects selected for funding) are placed on hold. If dollars become available as a result of negotiations, or if a higher ranked applicant declines the award, the projects on hold may receive funding. If you receive a letter stating that you will not receive funding, then your project has neither been selected for funding nor placed on hold.

INDIRECT COST RATE

There is no maximum indirect cost for the competitions in this application package. An organization's current effective indirect cost rate is the rate that should be reflected in your proposed budget. The Department of Education (ED) reimburses grantees for its portion of indirect costs that a grantee incurs in projects funded by the Educational Materials in Accessible Formats for Students with Visual Impairments and Other Print Disabilities (CFDA 84.327K) and the Educational Media Activities to Improve State Systems for Providing Educational Students with Visual Impairments and Other Print Disabilities (CFDA 84.327S) competitions. Any grantee charging indirect costs to a grant from this program must use the indirect cost rate (ICR), negotiated with its *cognizant agency*, i.e., either the Federal agency from which it has received the most direct funding, subject to indirect cost support, the particular agency specifically assigned cognizance by the Office of Management and Budget or the State agency that provides the most subgrant funds to the grantee.

Note: Applicants should pay special attention to specific questions on the application budget form (ED 524) about their cognizant agency and the ICR they are using in their budget.

If an applicant selected for funding under this program has not already established a current ICR with its cognizant agency as a result of current or previous funding, ED will require it to do so within 90 days after the date the grant was issued by ED. Applicants should be aware that ED is very often *not* the cognizant agency for its own grantees. Rather, ED accepts, for the purpose of funding its awards, the current ICR established by the appropriate cognizant agency.

An applicant that has not previously established an indirect cost rate with the Federal government or a State agency under a Federal program and that is selected for funding will not be allowed to charge its grant for indirect costs until it has negotiated a current indirect cost rate agreement with its cognizant agency.

Applicants are encouraged to use their accountant (or CPA) to calculate an indirect cost rate using information in the IRS Form 990, audited financial statements, actual cost data or a *cost policy statement* that such applicants are urged to prepare (but NOT submit to ED) during the application process.

Applicants should use this proposed rate in their application materials and indicate which of the above methods was used to calculate the rate. Guidance for creating a cost policy statement can be obtained by sending an e-mail to *katrina.mcdonald@ed.gov*. Applicants with questions about using indirect cost rates under this program should contact the program contact person shown elsewhere in this application package.

ISSUES RAISED DURING DISCUSSIONS PRIOR TO AWARD

If your application is recommended for funding, discussions may be held prior to award to clarify technical or budget issues. These are issues that have been identified during panel and staff review. Generally, technical issues are minor issues that require clarification. Alternative approaches may be presented for your consideration, or you may be asked to provide additional information or rationale for something you have proposed to do. Sometimes, concerns are stated as "conditions". These are concerns that have been identified as so critical that the award cannot be made unless those conditions are met. Questions are also raised about the proposed

budget during the discussion phase. Generally, budget issues are raised because there is inadequate justification or explanation of the particular budget item, or because the budget item does not seem critical to the successful completion of the project. A Federal project officer will present the issues to you and ask you to respond. If you do not understand the question, you should ask for clarification. In responding to discussion items you should provide any additional information or clarification requested. You may feel that an issue was addressed in the application. It may not, however, have been explained in enough detail to make it understood by reviewers, and more information should be provided. If you are asked to make changes that you feel could seriously affect the project's success, you may provide reasons for not making the changes, or provide alternative suggestions. Similarly, if proposed budget reductions will, in your opinion, seriously affect the proposed activities, you may want to explain why and provide additional justification for the proposed expenses. Your changes, explanations, and alternative suggestions will be carefully evaluated by staff. In some instances, an applicant may again be contacted for additional information. An award cannot be made until all issues have been resolved and conditions met.

• TREATING A PRIORITY AS TWO SEPARATE COMPETITIONS. In the past, there have been problems in finding peer reviewers without conflicts of interest where applications are made by many entities throughout the country. The Standing Panel requirements also place additional constraints on the availability of reviewers. Therefore, The Department has determined that, for some discretionary priorities, applications may be ranked and selected for funding in two or more groups, which will ensure the availability of a much larger group of reviewers without conflicts of interest. This procedure will increase the quality, independence and fairness of the review process and will permit panel members to review applications under discretionary priorities to which they have also submitted applications.

• SUCCESSFUL APPLICATIONS AND ESTIMATED/PROJECTED BUDGET AMOUNTS IN SUBSEQUENT YEARS

There is a maximum award amount specified for the priority/competitions included in this package. The Department rejects and does not consider an application that proposes a budget exceeding the maximum amount for any single budget period of 12 months for the priorities included in this package. Please refer to the priority description to determine the maximum award for any one particular competition. Since the yearly budgets for multi-year projects will be negotiated at the time of the initial award, applicants must include detailed budgets for each year of their proposed project. Generally, out-year funding levels most likely will not exceed 1st year budgets. However, budget modifications during the negotiation process, the findings from the previous year, or needed changes in the study design can affect your budget requirements in subsequent years, but in no case will out-year budgets exceed the maximum award amount.

REQUIREMENT TO REPORT THE RESULTS OF GRANT ACTIVITIES

The Department shall, where appropriate, require recipients of all grants, contracts and cooperative agreements under Part D of the Individuals with Disabilities Education Act to prepare reports describing their procedures, findings, and other relevant information. The Department shall require their delivery to the Department of Education and other networks as The Department may determine appropriate. (20 U.S.C. 1482)

DIFFERENCE BETWEEN A COOPERATIVE AGREEMENT AND A GRANT

A cooperative agreement is similar to a grant in that its principal purpose is to accomplish a public purpose of support or stimulation as authorized by a Federal statute. It differs from a grant in the sense that in a cooperative agreement substantial involvement is anticipated between the executive agency (in this case the Department of Education) and the recipient during the performance of the contemplated activity.

DIFFERENCE BETWEEN AN ABSOLUTE PRIORITY, AN INVITATIONAL PRIORITY, AND A COMPETITIVE PRIORITY

An absolute priority is a priority that an applicant must address in order to receive an award. If an applicant does not address an absolute priority, their application will be returned as being non-responsive to the priority.

An invitational priority is a priority that reflects a particular interest of the Department, and an applicant is encouraged to address the invitational priority along with the required absolute priority. However, an applicant choosing to address an invitational priority, will not receive any competitive preference over other applications.

A competitive priority is like an invitational priority in that it reflects a particular interest of the Department, and an applicant is encouraged to address the competitive priority along with the required absolute priority. A competitive priority may be handled in one of two ways: (1) an application may be awarded additional points depending on how effectively it addresses the competitive priority; or (2) an application that meets a competitive priority may be selected over an application of comparable merit that does not address the competitive priority. The type of competitive priority for a particular competition is always included in the FEDERAL REGISTER announcement.

NOTICE TO ALL APPLICANTS

The purpose of this enclosure is to inform you about a new provision in the Department of Education's General Education Provisions Act (GEPA) that applies to applicants for new grant awards under Department programs. This provision is Section 427 of GEPA, enacted as part of the Improving America's Schools Act of 1994 (Public Law (P.L.) 103-382).

To Whom Does This Provision Apply?

Section 427 of GEPA affects applicants for new grant awards under this program. ALL APPLICANTS FOR NEW AWARDS MUST INCLUDE INFORMATION IN THEIR APPLICATIONS TO ADDRESS THIS NEW PROVISION IN ORDER TO RECEIVE FUNDING UNDER THIS PROGRAM.

(If this program is a State-formula grant program, a State needs to provide this description only for projects or activities that it carries out with funds reserved for State-level uses. In addition, local school districts or other eligible applicants that apply to the State for funding need to provide this description in their applications to the State for funding. The State would be responsible for ensuring that the school district or other local entity has submitted a sufficient section 427 statement as described below.)

What Does This Provision Require?

Section 427 requires each applicant for funds (other than an individual person) to include in its application a description of the steps the applicant proposes to take to ensure equitable access to, and participation in, its Federally-assisted program for students, teachers, and other program beneficiaries with special needs. This provision allows applicants discretion in developing the required description. The statute highlights six types of barriers that can impede equitable access or participation: gender, race, national origin, color, disability, or age. Based on local circumstances, you should determine whether these or other barriers may prevent your students, teachers, etc. from such access or participation in, the Federally-funded project or activity.

The description in your application of steps to be taken to overcome these barriers need not be lengthy; you may provide a clear and succinct description of how you plan to address those barriers that are applicable to your circumstances. In addition, the information may be provided in a single narrative, or, if appropriate, may be discussed in connection with related topics in the application.

Section 427 is not intended to duplicate the requirements of civil rights statutes, but rather to ensure that, in designing their projects, applicants for Federal funds address equity concerns that may affect the ability of certain potential beneficiaries to fully participate in the project and to achieve to high standards. Consistent with program requirements and its approved application, an applicant may use the Federal funds awarded to it to eliminate barriers it identifies.

What are Examples of How an Applicant Might Satisfy the Requirement of This Provision?

The following examples may help illustrate how an applicant may comply with Section 427.

- (1) An applicant that proposes to carry out an adult literacy project serving, among others, adults with limited English proficiency, might describe in its application how it intends to distribute a brochure about the proposed project to such potential participants in their native language.
- (2) An applicant that proposes to develop instructional materials for classroom use might describe how it will make the materials available on audio tape or in braille for students who are blind.
- (3) An applicant that proposes to carry out a model science program for secondary students and is concerned that girls may be less likely than boys to enroll in the course, might indicate how it intends to conduct "outreach" efforts to girls, to encourage their enrollment.

We recognize that many applicants may already be implementing effective steps to ensure equity of access and participation in their grant programs, and we appreciate your cooperation in responding to the requirements of this provision.

B. Exemptions.

Research activities in which the <u>only</u> involvement of human subjects will be in one or more of the following six categories of *exemptions* are not covered by the regulations:

(1) Research conducted in established or commonly accepted educational settings, involving normal educational practices, such as (a) research on regular and special education instructional strategies, or (b) research on the effectiveness of or the comparison

among instructional techniques, curricula, or classroom management methods.

- (2) Research involving the use of educational tests (cognitive, diagnostic, aptitude, achievement), survey procedures, interview procedures or observation of public behavior, unless: (a) information obtained is recorded in such a manner that human subjects can be identified, directly or through identifiers linked to the subjects; and (b) any disclosure of the human subjects' responses outside the research could reasonably place the subjects at risk of criminal or civil liability or be damaging to the subjects' financial standing, employability, or reputation. If the subjects are children, exemption 2 applies only to research involving educational tests and observations of public behavior when the investigator(s) do not participate in the activities being observed. Exemption 2 does not apply if children are surveyed or interviewed or if the research involves observation of public behavior and the investigator(s) participate in the activities being observed. [Children are defined as persons who have not attained the legal age for consent to treatments or procedures involved in the research, under the applicable law or jurisdiction in which the research will be conducted.]
- (3) Research involving the use of educational tests (cognitive, diagnostic, aptitude, achievement), survey procedures, interview procedures or observation of public behavior that is not exempt under section (2) above, if the human subjects are elected or appointed public officials or candidates for public office; or federal statute(s) require(s) without exception that the confidentiality of the personally identifiable information will be maintained throughout the research and thereafter.
- (4) Research involving the collection or study of existing data, documents, records, pathological specimens, or diagnostic specimens, if these sources are publicly available or if the information is recorded by the investigator in a manner that subjects cannot be identified, directly or through identifiers linked to the subjects.
- (5) Research and demonstration projects which are conducted by or subject to the approval of department or agency heads, and which are designed to study, evaluate, or otherwise examine: (a) public benefit or service programs; (b) procedures for obtaining benefits or services under those programs; (c) possible changes in or alternatives to those programs or procedures; or (d) possible changes in methods or levels of payment for benefits or services under those programs.

(6) Taste and food quality evaluation and consumer acceptance studies, (a) if wholesome foods without additives are consumed or (b) if a food is consumed that contains a food ingredient at or below the level and for a use found to be safe, or agricultural chemical or environmental contaminant at or below the level found to be safe, by the Food and Drug Administration or approved by the Environmental Protection Agency or the Food Safety and Inspection Service of the U.S. Department of Agriculture.
