Dear Mr. Chairman:

In accordance with section 3801 (a) of Chapter 8 of Title III of Division B of the Department of Defense Appropriations Act, 2006 (P.L. 109-148), I herewith transmit the report on the 1 percent government-wide reduction against:

- (1) the budget authority provided (or obligation limit imposed) for fiscal year 2006 for any discretionary account in any fiscal year 2006 appropriation Act;
- (2) the budget authority provided in any advance appropriation for fiscal year 2006 for any discretionary account in any prior fiscal year 2006 appropriation Act; and
- (3) the contract authority provided in fiscal year 2006 for any program subject to limitation contained in any fiscal year 2006 appropriation Act.

Section 3801 (c) exempts appropriations designated as an emergency pursuant to section 402 of the 2006 budget resolution (H. Con. Res. 95) and appropriations made to the Department of Veterans Affairs.
