Dear Superintendent Flanagan:

Thank you for the timely submission of Michigan's FFY 2006 Annual Performance Report (APR) and revised State Performance Plan (SPP) under Part C of the Individuals with Disabilities Education Act (IDEA), as amended in 2004. We also acknowledge the revisions to Michigan's SPP and APR received on April 11, 2008. We appreciate the State's efforts in preparing these documents.

The Department has determined that, under IDEA sections 616(d) and 642, Michigan needs assistance in meeting the requirements of Part C of the IDEA. The Department's determination is based on the totality of the State's data and information including the State's FFY 2006 APR and revised SPP, other State-reported data, information obtained through on-site verification and focused monitoring visits, and other publicly available information. See the enclosure entitled "How the Department Made Determinations under Sections 616(d) and 642 of the IDEA in 2008" for further details.

Specific factors affecting OSEP's determination of needs assistance for Michigan included the following: (1) for Indicator 1, the State reported 47% compliance with the timely service provision requirements, which represents progress from the State's FFY 2005 data of 19%; (2) for Indicator 7, the State reported 63.1% compliance with the 45-day timeline requirements; (2) for Indicator 8A, the State reported 73% compliance with the IFSP transition content requirements with progress from 59.28%; (3) for Indicator 8C, the State reported 85.5% compliance with the timely transition conference requirements with progress from 84.4%; (4) for Indicators 1, 7, 8A, and 8C, the State did not report correction of prior findings of noncompliance; and (5) for Indicator 9, the State reported 28% compliance with timely correction requirements, which data reflect the measurement for this indicator, unlike the State's FFY 2005 data that did not reflect the measurement for this indicator. In addition, the State did not report correction of prior noncompliance with the requirements in 34 CFR §§303.322(c)(3)(ii) and 303.344(a) that each child has a timely, comprehensive, multidisciplinary evaluation, and an IFSP that identifies the child's present level of functioning in each of the five developmental areas. For these reasons, we were unable to determine that your State met requirements under IDEA sections 616(d) and 642. OSEP notes that the State reported a high level of compliance for Indicator 8B. We hope that your State will demonstrate in next year's APR that it meets requirements.


The enclosed table provides OSEP's analysis of the State's FFY 2006 APR and revised SPP and identifies, by indicator, OSEP's review of any revisions made by the State to its targets, improvement activities (timelines and resources) and baseline data in the State's SPP. It also identifies, by indicator, the State's status in meeting its targets, whether the State's data reflect progress or slippage, and whether the State corrected noncompliance and provided valid and reliable data.

As you know, your State must report annually to the public on the performance of each early intervention service (EIS) program located in the State on the targets in the SPP under IDEA sections 616(b)(2)(C)(ii)(I) and 642. In addition, your State must review EIS program performance against targets in the State's SPP, determine if each EIS program meets the requirements of the IDEA and inform each EIS program of its determination. Finally, if you included revisions to baseline, targets or improvement activities in your APR submission, and OSEP accepted those revisions, please ensure that you update your SPP accordingly and that the updated SPP is made available to the public.
