Dear Mr. Alexander:

Thank you for the timely submission of Rhode Island's FFY 2006 Annual Performance Report (APR) and revised State Performance Plan (SPP) under Part C of the Individuals with Disabilities Education Act (IDEA), as amended in 2004. We also acknowledge the revisions to Rhode Island's SPP and APR received on April 14, 2008. We appreciate the State's efforts in preparing these documents.

The Department has determined that, under IDEA sections 616(d) and 642, Rhode Island needs assistance in meeting the requirements of Part C of the IDEA. The Department's determination is based on the totality of the State's data and information including the State's FFY 2006 APR and revised SPP, other State-reported data, and other publicly available information. See the enclosure entitled "How the Department Made Determinations under Sections 616(d) and 642of the IDEA in 2008" for further details.

Specific factors affecting OSEP's determination of needs assistance for Rhode Island include: (1) For Indicator 1, the State reported 81.98% compliance with the timely service provision requirements, which represents progress from the State's FFY 2005 data of 64.81%; (2) for Indicator 7, the State reported 79.73% compliance with the 45-day timeline requirements, which represents progress from the State's FFY 2005 data of 71.70%; (3) for Indicators 1 and 7, the State did not report correction of prior findings of noncompliance; and (4) for Indicator 9, the State reported 72.7% compliance, which represents progress from the State's FFY 2005 data of 52.4%. For these reasons, we were unable to determine that your State met requirements under IDEA sections 616(d) and 642. OSEP notes that the State reported a high level of compliance and correction for Indicators 8A, 8B, and 8C. We hope that your State will demonstrate in next year's APR that it meets requirements.

The enclosed table provides OSEP's analysis of the State's FFY 2006 APR and revised SPP and identifies, by indicator, OSEP's review of any revisions made by the State to its targets, improvement activities (timelines and resources) and baseline data in the State's SPP. It also identifies, by indicator, the State's status in meeting its targets, whether the State's data reflect progress or slippage, and whether the State corrected noncompliance and provided valid and reliable data.

Your State may want to consider taking advantage of available sources of technical assistance. As you know, your State must report annually to the public on the performance of each early intervention service (EIS) program located in the State on the targets in the SPP under IDEA sections 616(b)(2)(C)(ii)(l) and 642. In addition, your State must review EIS program performance against targets in the State's SPP, determine if each EIS program meets the requirements of the IDEA and inform each EIS program of its determination. Finally, if you included revisions to baseline, targets or improvement activities in your APR submission, and OSEP accepted those revisions, please ensure that you update your SPP accordingly and that the updated SPP is made available to the public.
