### June Highlights

- Mid-Planning Conferences: ICTAP assisted with 36 exercise midplanning conferences throughout June.
- Final Planning Conferences: ICTAP led 11 sites through the final planning conferences to prepare for the validation exercise.
- TICP Validation Exercises (TVE):
  The States of Delaware, South
  Carolina, Tennessee, and New
  Jersey, as well as the Omaha and
  Dallas Urban Areas (UAs) held
  their validation exercises.

#### TICP IMPLEMENTATION WORKSHOPS

Through ICTAP, the Tactical Interoperable Communications Plan (TICP) Implementation Workshop is available to assist each site in preparing for the TVE. ICTAP recommends inviting any/all regional agency personnel including law enforcement, fire, and EMS incident management staff and communications specialists to attend the workshop.

The workshops cover a variety of topics to prepare sites to efficiently exercise their tactical plans according to the National Incident Management System (NIMS) and Incident Command Structure (ICS) standards during the validation exercise. At the workshop, instructors begin with a review of the TICP and help the site develop an Incident

Radio Communications Plan (ICS 205) for the exercise. The workshop continues with an overview of NIMS and the ICS

Communications Unit and an explanation of the associated standards and training. The instructor will help identify the site's appropriate Communications Unit Leader (COML) based on the 19 required core competencies. A total of 17 sites have already held their TICP Implementation workshops, and another 38 have one scheduled before their TICP validation exercise.

#### **EXERCISES**

As sites hold their exercises, ICTAP site managers continue to lead their sites through the planning and TICP implementation process while ICTAP evaluators help bring

their technical expertise to the exercises. Throughout June, six more sites held their communications-based exercises.

#### **South Carolina**

On June 8, 2006, Charleston, the designated metropolitan area in South Carolina, tested its TICP during the pre-planned Hurricane Isabella full-scale exercise.

#### Nashville, TN

Nashville, Tennessee conducted its exercise on June 8, 2006, as part of the Annual Airport Disaster Exercise.

#### **New Jersey**

The State of New Jersey, in conjunction with the cities of Newark and Jersey City, conducted its TICP validation exercise during the real world event of the annual Portuguese Days festival on June 10, 2006.

#### Omaha, NE

On June 20, 2006, the Omaha UA tested its TICP as part of the College World Series.

#### Dallas/Fort Worth/ Arlington, TX

The Dallas UATVE exercise took place at the University of Texas-Arlington Stadium. The scenario featured an Improvised Explosive Device (IED) threat and detonation in the stadium during a football game that attracted about 13,000 spectators.

#### **Delaware**

Delaware held its exercise on June 20, 2006, as part of the Operation Wildcat. Approximately 200 multidiscipline responders from the greater Wilmington, DE, area participated in the exercise, which simulated a terrorist hostage situation and the release of a hazardous material at a local high school.
