# **July Highlights**

- Mid-Planning Conferences: ICTAP assisted with 14 exercise midplanning conferences in July.
- Final Planning Conferences: ICTAP led 20 sites through the final planning conferences to prepare for the validation exercise.
- TICP Implementation Workshops: 13 sites took advantage of the ICTAP-led TICP Implementation Workshops.
- TICP Validation Exercises (TVE):
  Nine sites held their TVEs in July.

#### TECHNICAL INTEGRATION WORK GROUP

The ICTAP Technical Integration Work Group (TIWG) is a technology think-tank that provides guidance and support to ICTAP sites regarding communications technologies and technical issues. TIWG ensures that ICTAP receives relevant technical knowledge about new technologies and regulatory issues. TIWG meets on a regular basis and periodically issues "technical notes" that are distributed to ICTAP team members. These notes discuss important and current technical issues, such as:

#### **P25 Standards**

An overview of P25 standards for ICTAP personnel, covering recent developments from P25 steering committee meetings, existing technologies, and future P25 plans.

#### **Communications in Tunnels**

A discussion of the physical characteristics of propagation in tunnels and the technical solutions available to ensure coverage. Solutions adopted above-ground need to be extended below-ground.

# **Narrowbanding**

Provides an overview of narrowbanding in the context of land mobile radio technology and discusses relevant examples. The Federal Communications Commission (FCC) has mandated that State and local public safety agencies operate voice systems in a narrowband channel (or its equivalent) on channels below 512 MHz by January 2013.

#### **Wireless Communications**

Focuses on awareness of wireless data capabilities, technologies, issues, and related FCC Rules and Regulations that pertain to public safety agencies.

TIWG is also developing technical notes discussing Voice-over IP in Public Safety Land Mobile Radio. These TIWG technical notes, as well as other ICTAP-related documents, are available to registered users of the public safety community on the U.S. Department of Homeland Security's Lessons Learned Information System Web site at <a href="https://www.llis.gov">www.llis.gov</a>.

The Honolulu exercise took place on July 28, 2006, with an estimated 350 first responders in attendance.
