The Immigration User Fee Account was established in the Department of Justice Appropriations Act of 1987. Most of this account's revenue is generated from a \$6.00 fee charged to each passenger arriving in the United States aboard a commercial aircraft or vessel from a foreign location. Cruise ship passengers, whose journey originates in Canada, Mexico, or any territory or possession of the United States, or any adjacent island to the United States, are currently exempt from this charge.

The President's 2001 budget includes language that would increase the current user fee by \$2.00, to \$8.00, and would also lift the cruise ship exemption and institute a \$8.00 cruise ship fee from passengers whose journeys originated in Mexico, Canada, the United States, a territory or possession of the United States, or any adjacent island to the United States. However, it would not apply to immigration inspection at designated ports-of-entry of passengers arriving by Great Lakes international ferries or Great Lakes vessels on the Great Lakes and connecting waterways, when operating on a regular schedule. The requested fee changes are included in the General Provisions, and the 2001 User Fee funding level is based on these two provisions. The user fee was last increased (from \$5.00 to \$6.00) in FY 1994. In 2000, INS anticipates that program costs will exceed new revenues and that prior year carry forward funds will be depleted by FY 2001.

<p>INS requests <b>154 positions, 77 workyears, and \$12,186,000</b> for additional Immigration Inspectors at new airport terminals. Current construction at San Francisco, Detroit, Miami, and Philadelphia International airports will increase the number of international gates and primary inspection booths. With the anticipated increase in international travelers at each location, INS will require additional inspectors in order to process all passengers within 45 minutes.</p>

<p>INS requests <b>\$11,428,000</b> to upgrade the journeyman level of its Immigration Inspector job series to GS-11. The role of the Immigration Inspectors has evolved from primarily facilitating legal alien traffic, to one with an increased emphasis on the detection, identification, and apprehension of those seeking to enter the U.S. illegally. These requested resources will provide for more successful recruitment and retention of Immigration Inspectors and will alleviate the problem of losing experienced inspectors due to the current GS-9 journeyman level.</p>
