The danger pay regulation, found in Chapter 650 of the U.S. Department of State Standardized Regulations (DSSR), is designed to provide additional compensation to all United States Government (USG) civilian employees, including Chiefs of Mission, for service in foreign areas where terrorism, civil insurrection, civil war or wartime conditions exist.

COMPLETING THE REPORT:

- (a) Reporting officers should complete each section accurately and provide detailed explanations including supporting statistics for each item selected. The post security officer (Regional Security Officer for U.S. Department of State locations) should either complete this form or be consulted regarding the substance of the responses. The security officer's name, signature, and date of concurrence must be reported.
- (b) Report events that have taken place within a year prior to the date of request for danger pay.
- (c) Report incidents that involved Americans (USG employees, eligible family members, and private American citizens) foreign national employees, or other broader groups when the victims are targeted due to their affiliation with the United States Government.
- (d) Report precautionary measures taken by the USG to protect its employees.
