INTRODUCTION

On November 6, 1956, as authorized by the Fish and Wildlife Service Act of August 8, 1956 (70 Stat. 1119), the Fish and Wildlife Service was reorganized as the United States Fish and Wildlife Service. The Fish and Wildlife Service has been formed by the merger of the Bureau of Fisheries and the Bureau of Biological Survey in 1940. The Service was responsible for implementing programs and administering Federal laws for the control and conservation of food fisheries, migratory and game birds, and other forms of wildlife.

BUREAU OF FISHERIES

The Office of the Commissioner of Fisheries was established by a Joint Resolution of Congress on February 9, 1871 (16 Stat. 593). The President was directed by Congress to appoint a civil officer of the Government to serve without salary as Commissioner. Spencer F. Baird, Assistant Secretary of the Smithsonian Institution, was appointed the first Commissioner and served until his death in 1887. Following the death of Baird, by the Act of January 20, 1888 (20 Stat. 1), the Commissioner was made a salaried office. The Office of the Commissioner was often known as the United States Fish Commission.

The Act of February 14, 1903 (32 Stat. 825) placed the formerly independent Commissioner under the supervision of the newly created Department of Commerce and Labor. The title of the position was changed to the Commissioner of Fisheries, and the office was named the Bureau of Fisheries. When the Department was divided under the Act of March 4, 1913 (37 Stat. 736), the Bureau of Fisheries was assigned to the Department of Commerce.

On July 1, 1939, as part of the President's Reorganization Plan II under the Act of April 3, 1939 (53 Stat. 1433), the Bureau was transferred to the Department of the Interior.

The original duties of the United States Fish Commission were to conduct scientific investigations to determine the causes for the decrease of commercial food fish and aquatic animals in the coastal and inland waters of the United States and to recommend possible remedies. Related activities included studying the effect of river impoundment projects on fish migration patterns, and investigating the effects of red tides and water pollution on fishery resources. The scientific studies, largely conducted at biological laboratories and by research vessels operated by the Bureau, were directed by the Division of Scientific Inquiry.

An Act of June 10, 1872 (17 Stat. 350) authorized the Commissioner to undertake the propagation and distribution of certain food fish. The work was later expanded to include shellfish and lobsters. The operation of the fish hatcheries and the distribution of fry and eggs were directed by the Division of Fish Culture.

From 1871 to 1879 the collection and compilation of statistical information had been part of the scientific investigations. The Act of March 3, 1879 (20 Stat. 383) specifically authorized the collection and publication of statistical data bearing on the commercial fishing industry. The work later included investigating methods of storing and processing fish, establishing standards of quality, and suggesting improvements in fishing gear and methods. These activities were directed by the Division of Fishery Industries.

As directed by Orders of the Secretary of Commerce and Labor on February 15, 1905 and December 28, 1908 the administration of Alaskan fisheries and Alaskan fur seals, respectively, were transferred from the Office of the Secretary to the Bureau of Fisheries. The regulation of these industries had been a function of the Treasury Department from 1868 to 1903, when they were transferred to the jurisdiction of the Department of Commerce and Labor under the Act of February 14, 1903 (32 Stat. 828). The Fish Commission had been involved in several scientific investigations in Alaska in the 1890's. In 1893, as directed by the Act of March 3, 1893 (27 Stat. 585), the Fish Commission Steamer Albatross was used to transport Treasury Department agents to Alaska to investigate the fur seal herds of the Pribilof Islands and the Bering Sea. In 1898 as part of an investigation of the fishery resources of the west coast of the United States the Steamer Albamoss engaged in a survey of the streams in which the redfish were found along the southern and southeastern coasts of Alaska. The Acts of June 26, 1906 (34 Stat. 478) and June 6, 1924 (43 Stat. 464) clarified existing fishery laws and gave the Bureau the authority to undertake fishery management programs in Alaska. Alaska fisheries and fur seal matters were administered by the Division of Alaska Fisheries.

Other regulatory functions included enforcement of the Federal Black Bass Law of July 2, 1930 (46 Stat. 485), which provided for the regulation of interstate commerce in black bass, and the Whaling Treaty Act of May 1, 1936 (49 Stat. 1246), which was primarily enforced by the Coast Guard and the Bureau of Customs with the Bureau of Fisheries cooperating. The Bureau was charged with the collection of statistical and biological whaling data. The Law Enforcement Division, also known as the Division of Black Bass and

Anglers, was established to administer the Federal Black Bass Law, and the Bureau's responsibilities under the Whaling Treaty Act.

Although the Bureau operated hatcheries, biological laboratories, and vessels in the field, and maintained regional headquarters as scientific work dictated, it did not evolve a formalized regional organization structure.

BUREAU OF BIOLOGICAL SURVEY

The work of the Bureau of Biological Survey began with a clause in the Agricultural Appropriation Act of March 3, 1885 (23 Stat. 353, 354), which authorized the Division of Entomology in the Department of Agriculture to conduct investigations into the interrelationships of birds and agriculture. The Act of June 30, 1886 (24 Stat. 100, 101) specified the addition of investigations of mammals and their relationship to agriculture and forestry. Also, as authorized by that Act and effective July 1, 1886, these investigations were made the work of the newly established Division of Economic Ornithology and Mammalogy. Clinton Hart Merriam was appointed the first Chief of the Division. Effective July 1, 1896, as authorized by the Act of April 25, 1896 (29 Stat. 99, 100, 102), the Division was renamed the Division of Biological Survey. On July 1, 1905 the Division became the Bureau of Biological Survey as authorized in the Act of March 3, 1905 (33 Stat. 861, 877). The head of the Bureau was designated the Chief. The Survey remained in the Department of Agriculture until July 1, 1939, when it was transferred to the Department of the Interior in accordance with the President's Reorganization Plan II under the Reorganization Act of April 3, 1939 (53 Stat. 1433).

Until 1900 the work of the Biological Survey was organized along two lines: conducting research into the habits and life histories of birds and mammals, particularly their geographic distribution, and investigating the food habits of birds and mammals to determine their economic relationship to agriculture. Later the Survey undertook investigations concerning commercial fur productions, and bird and animal diseases. The organizational units administering these activities were consolidated in 1934 to form the Division of Wildlife Research.

The regulatory duties of the survey fell into three general categories. Initially under the Lacey Act of May 25, 1900 (31 Stat. 187) the Survey undertook the compilation and publication of State game laws and regulations, issued regulations governing the importation of mammals and birds, and cooperated with State game authorities in enforcing laws regarding the interstate shipment of birds killed in violation of State game laws. The "Egg Act" of June 3, 1902 (32 Stat. 285) extended the regulation of imports to include the eggs of game birds.

Under the Alaska Game Law of June 7, 1902 (32 Stat. 327) the Survey also was charged with the protection of game, primarily trophy animals, in Alaska. The Act of May 11, 1908 (35 Stat. 102) amended the Alaska Game Law and transferred responsibility for its enforcement to the Governor of Alaska. Under the Act of May 31, 1920 (41 Stat. 715, 716, 717) jurisdiction over certain islands in Alaska leased for fox farming purposes, and responsibility for protecting land fur bearing animals were transferred from the Bureau of Fisheries. The same Act transferred responsibility for the protection of sea lions and walrus from the Biological Survey to the Bureau of Fisheries. A Joint Resolution of Congress on June 7, 1924 (43 Stat. 668)

returned the authority to administer the Alaska Game Law from the Governor of Alaska to the Biological Survey. The Alaska Game Law was amended by the Act of January 13, 1925 (43 Stat. 739), which provided for the protection of both game and fur bearing animals in cooperation with the newly created Alaska Game Commission.

The third regulatory area concerned the protection of migratory birds. The Federal Migratory Bird Law of March 4, 1913 (37 Stat. 847) authorized the Bureauto promulgate and enforce regulations to fix the closed seasons on migratory game birds. That law was superseded by the Federal Migratory Bird Treaty Act of July 3, 1918 (40 Stat. 755), the result of a Treaty with Great Britain concerning the protection of birds migrating between the United States and Canada, and as amended June 20, 1936 (49 Stat. 1555) to extend protection to birds migrating between the United States and Mexico in accordance with the provisions of a treaty with Mexico. All the regulatory functions of the Survey were consolidated in the Division of Game Management in 1938.

The Biological Survey maintained and operated the Federal refuge system. It was made responsible for the first bird refuge, which was established by Executive Order on March 14, 1903 on Pelican Island in Florida, and its management duties expanded to include big game preserves when the National Bison Range was transferred from the Forest Service to the Survey in 1909. Refuge areas administered by the Biological Survey before 1929 were acquired by Executive Order, Act of Congress, gift or cession. The Migratory Bird Conservation Act of February 18, 1929 (45 Stat. 1222) authorized the purchase or rental of lands and marsh areas suitable for bird refuges as recommended

by the Secretary of Agriculture with the approval of the newly established Migratory Bird Conservation Commission. That Act was supplemented by the Migratory Bird Hunting Stamp Act of March 6, 1934 (48 Stat. 451), which provided for the establishment and maintenance of migratory waterfowl refuges using emergency funds allotted by Congress and for the disposition of proceeds from the sale of migratory hunting stamps. From 1934 to 1942 refuges were established and maintained with the assistance of the Civilian Conservation Corps and other work relief programs. In 1938 all functions relating to the administration of wildlife refuges were placed in the Division of Wildlife Refuges.

The work of the Biological Survey also included the operation of predator and rodent control programs. The Act of June 20, 1914 (30 Stat. 434) authorized the Survey to conduct experiments and demonstrations in the eradication of predatory animals injurious to livestock, and rodents that hindered the cultivation and storage of grains. Other legislation enlarged the Survey's predator and rodent control related activities to include work on the public domain, the eradication of rabies, cooperation with the Forest Service, and the negotiation of cooperative agreements with the States to finance and undertake control operations. In 1938 the Division of Predator and Rodent Control was established to administer the Survey's control programs.

In 1934 the Biological Survey divided the United States into nine administrative regions. Until the time the work of the Survey in the field had been managed directly by the Washington Office. Survey programs in Alaska and cooperation with the Alaska Game Commission were usually handled directly with officials and game agents in Alaska.

FISH AND WILDLIFE SERVICE

On July 1, 1940, as part of the President's Reorganization Plan III under the Act of June 30, 1940 (54 Stat. 1232), the Bureau of Fisheries and the Bureau of Biological Survey in the Interior Department were merged to form the Fish and Wildlife Service. The head of the Service was referred to as the Director. The administrative and management functions of the two Bureaus were consolidated. The organizational structure and functions of the operational units remained the same for some time after the merger.

The regional organization of the Bureau of Biological Survey was reorganized into five regions at the time of the merger of the two Bureaus when the field activities of the Bureau of Fisheries were integrated into the regional structure. Alaskan wildlife and fishery matters continued to be administered by Service personnel in Seattle and Juneau working directly with the appropriate Divisions in the Washington Office. Although the regional organization of the Service was revised several times, most of the records in the holdings of the Fish and Wildlife Service in the National Archives Building referring to the regions are arranged roughly according to the regional plan adopted in 1940.

All functions relating to international fishery matters, which had been directed by the former Commissioner of Fisheries, were transferred to the Office of the Director of the Fish and Wildlife Service in 1940. In 1945 an Office of Foreign Activities was established to administer international fishery activities.

Two major programs were begun under the Fish and Wildlife Service. In 1945 the Office of River Basin Studies was established under the supervision of the Director of the Service. Initially the Office operated under

Section 18 of the Federal Water Power Act of June 10, 1920 (41 Stat. 1063) and the Coordination Act of March 10, 1934 (48 Stat. 401), later amended by the Act of August 14, 1945 (60 Stat. 1080). The Office was responsible for investigating the effects of Federal water development projects on fish and wildlife resources and recommending measures to prevent loss or damage of these resources. In 1954 the Office of River Basin Studies was transferred to the Division of Technical Services.

A second program was the Columbia Basin Fishery Development Program, authorized by the Act of August 8, 1946 (60 Stat. 932), which amended existing Acts pertaining to salmon fishery conservation in the Columbia River Basin by making provision for the expenditure of additional funds. The Act also provided for closer cooperation between the Federal government and the States of Idaho, Oregon, and Washington. The program was administered by the Division of Fishery Biology.

UNITED STATES FISH AND WILDLIFE SERVICE

The Fish and Wildlife Service was replaced and succeeded by the United States Fish and Wildlife Service on November 6, 1956, as authorized by the Fish and Wildlife Act of August 8, 1956 (70 Stat. 1119). The Service as reorganized consisted of a Bureau of Commercial Fisheries, and a Bureau of Sport Fisheries and Wildlife each under a Director. The Service was headed by a Commissioner subject to the supervision of the Assistant Secretary for Fish and Wildlife. Personnel were not officially assigned to the new Bureaus until July 1, 1957.

The functions of the Bureaus of Commercial Fisheries, and Sport Fisheries and Wildlife corresponded closely to the functions of the former

Bureaus of Fisheries, and Biological Survey, respectively. As part of the reorganization the Bureau of Commercial Fisheries was assigned responsibility for the Columbia River Development Program, and the Bureau of Sport Fisheries and Wildlife was charged with supervising the Branch of River Basin Studies. Administration of the Federal Black Bass Law, and the National Fish Hatcheries, which had originated under the former Bureau of Fisheries, were placed with the Bureau of Sport Fisheries and Wildlife.

The Office of Foreign Activities continued under the supervision of the Commissioner of the Service. In 1958 the Office was renamed the Office of International Relations, and in 1966 all functions relating to international fishery activities were transferred to the Bureau of Commercial Fisheries.

In 1970 under Reorganization Plans 3 and 4, the Bureau of Commercial Fisheries was transferred to the Department of Commerce, renamed the Marine Fisheries Service, and placed under the newly established National Oceanic and Atmospheric Administration. Effective July 1, 1974, as authorized by the Act of April 22, 1974 (88 Stat. 92), the Bureau of Sport Fisheries and Wildlife in the Department of the Interior became the United States Fish and Wildlife Service under the supervision of a Director.

The records described in this inventory are those of the United States. Fish and Wildlife Service and its predecessors that were in the National Archives on September 30, 1976. The inclusive dates of the records are 1868 to 1972. They comprise 2276 cubic feet and are designated as Record Group 22, Records of the United States Fish and Wildlife Service. Except for cartographic records and audiovisual materials, which are maintained

apart from the textual records, the holdings are divided into those of the Bureau of Fisheries, the Bureau of Biological Survey, the Fish and Wildlife Service, the United States Fish and Wildlife Service, the Bureau of Commercial Fisheries, and the Bureau of Sport Fisheries and Wildlife.

There are many series, including the central files of the Bureau of Fisheries and the Bureau of Biological Survey, that were maintained by more than one Bureau or Service. The entries for cartographic and audiovisual records are dispersed throughout the inventory under the appropriate operational units. The records of the Bureau of Fisheries include certain records concerning Alaskan fur seals and salmon fisheries that were transferred from the Department of the Treasury and the Department of Commerce and Labor. The records maintained by the Treasury Department have been published as National Archives Microfilm Publication No. 720, Alaska File of the Secretary of the Treasury, 1868-1903.

There are closely related records in other record groups. Records concerning Departmental supervision on the United States Fish and Wildlife Service and its predecessors are in Record Group 40, General Records of the Department of Commerce; Record Group 56, General Records of the Department of the Treasury; Record Group 16, Records of the Office of the Secretary of Agriculture; and Record Group 48, Records of the Office of the Secretary of the Interior. The records of the Revenue Cutter Service, found in Record Group 26, Records of the United States Coast Guard, include information on the seal fisheries of Alaska and related matters. Among the record groups with records concerning extensive interagency cooperation with the United States Fish and Wildlife Service are Record Group 79, Records of the National Park Service, and Record Group 95, Records of the Forest Service.

Entries for cartographic records were prepared by William J. Heynan; and those for still pictures by Tom Oglesby. Portions of the inventory incorporate a finding aid compiled by Edward E. Hill.

RECORDS OF THE UNITED STATES FISH COMMISSION AND THE BUREAU OF FISHERIES
General Records

These records consist of correspondence and other records relating to the general administration of the United States Fish Commission and the Bureau of Fisheries and records concerning special activities that cannot be attributed readily to particular organizational units. General correspondence of the Bureau of Fisheries, which was continued by successor agencies, is described in entry 259 with records of the Bureau of Commercial Fisheries.

1. LETTERS RECEIVED. 1871-74. 10 vols. 2 ft.

Arranged alphabetically by name of office of writer.

Volume 7 consists entirely of letters received from Livingston Stone, Fish Commission Agent on the Pacific coast. See entry 4 for other letters from Mr. Stone.

2. INDEX TO NAMES OF WRITERS OF LETTERS RECEIVED. 1871-74. 1 vol. 2 in. Arranged alphabetically by name.

Index to records described in entry 1.

3. LETTERS RECEIVED. 1871-72. 4 in.

Arranged alphabetically by name of correspondent.

These letters were not bound with those described in entry 1. Primarily concerning fishery research in the United States and Europe.

Included are a few copies of letters written by Spencer Baird filed alphabetically under the name of the recipient.

4. LETTERS RECEIVED FROM LIVINGSTON STONE. 1874-77. 1 in.

Arranged chronologically.

Relate to fishery investigations and the establishment of fish culture stations on the Pacific coast, primarily in California. For other letters from Livingston Stone, see the records described in entries 1, 6, and 8.

5. LETTERS RECEIVED FROM EXECUTIVE DEPARTMENTS AND OTHER FEDERAL AGENCIES. 1876-81. 7 in.

Arranged by name of Department or Agency.

Concerning the assignment of vessels for use by the Commission, arrangements for Commission participation in international expositions, and other matters pertaining to the work of the Commission.

6. LETTERS RECEIVED. 1878-81. 7 ft.

Arranged by year and thereunder alphabetically by name or office of writer.

Includes letters from private individuals requesting information about certain kinds of fish or commenting on current research undertaken by the Commission or other fishery specialists, and from employees in the field

reporting on hatchery operations and fishery research. Letters from employees are usually filed by name of individual. Interspersed throughout the records are a few letters addressed to Spencer Baird concerning the administration of the Smithsonian Institution.

7. REGISTER OF LETTERS RECEIVED. 1877-81. 1 vol. ½ in.

Entries are arranged by name of writer often with many letters from one writer grouped together. Within the groups no discernable order is apparent.

Includes information on the date of receipt and the contents of the letter. A few of the letters can be found among the records described in entry 6. The remainder can not be located among the holdings of the Bureau of Fisheries.

8. LETTERS RECEIVED. 1882-1900. 120 ft.

Arranged by file number assigned in order of registration. See entry 9 for a description of the registers.

Included are letters requesting information about certain kinds of fish and aquatic animals; applications for shipments of fish and eggs from private individuals, State fish commissions, game clubs, and foreign governments; reports from employees on the status of hatchery operations and research at biological laboratories; and letters received from Spencer Baird while he supervised summer research at Woods Hole. Letters were

registered for the most part chronologically in order of receipt, with the exception of large groups of letters up to 1892, consisting primarily of applications for fish and eggs, which were registered out of order.

These groups are not found in the same place from volume to volume, nor are they necessarily found at the beginning or end of fiscal years. A few letters received as early as 1871 have been incorporated into this series. Through June 1892 one set of file numbers was continued from year to year; thereafter a new sequence was started at the beginning of each fiscal year. All letters received after 1900 as well as many earlier ones at one time part of this series are divided among many subject series.

9. REGISTERS OF LETTERS RECEIVED. 1882-1917. 91 vols. 14 ft.

The entries are arranged for the most part chronologically by date of receipt of the letter. A few letters received as early as 1871 were registered in these volumes. Until 1892 large groups of letters were registered out of order.

Included is a synopsis of the contents of each letter, registration number, the date of the letter, and the date the letter was received.

10. INDEXES TO LETTERS RECEIVED AND LETTERS SENT BY THE BUREAU. 1882-1906. 19 vols. 3 ft.

The entries are arranged alphabetically by name of correspondents and cover in the same volume both letters received and letters sent.

The letters received up to 1900 are found among the records described in entry 8, and after 1900 they are disbursed among many series. The letters sent are with the records described in entry 15.

11. INDEXES TO LETTERS RECEIVED. 1906-17. 9 vols. 1 ft.

The entries are arranged alphabetically by name of correspondents.

The letters to which the indexes refer are divided among many series.

12. INDEX TO LETTERS RECEIVED BY THOMAS B. FERGUSON, ASSISTANT COMMISSIONER. 1879-87. 1 vol. ½ in.

Arranged alphabetically by name of correspondents.

The letters are registered in Register No. 15, part of the records described in entry 9. The letters are among those identified in entry 8.

13. INDEX TO LETTERS RECEIVED. 1882-87. 1 vol. 2 in.

The entries are arranged alphabetically by subjects.

Include some entries for letters sent for 1882. The letters are found among the records described in entry 8.

14. INDEXES TO LETTERS RECEIVED. 1894-1917. 21 vols. 2 ft.

Arranged alphabetically by subjects.

The letters before 1900 are found among the records described in entry 8. Those after 1900 are divided among many series.

15. PRESS COPIES OF LETTERS SENT. 1871-1906. 699 vols. 74 ft.

Under the provisions of an Act of July 27, 1868 (15 Stat. 240), the Secretary of the Treasury was authorized to protect the fur bearing animals of Alaska, including the migratory fur seals. An Act of July 1, 1870 (16 Stat. 180) further authorized the Secretary to accept bids for a twenty-year lease to hunt fur seals on the islands of St. Paul and St. George,

subject to certain conditions specified by the Secretary. On March 2, 1889 (25 Stat. 1009) the Secretary was also given responsibility for supervising the salmon fisheries of Alaska. The records described in entry 26 are published as National Archives Microfilm Publication No. 720, Alaska File of the Secretary of the Treasury, 1868-1903.

Also included are three unidentified photographs and a photographic copy
of a painting of Wrangell Island, by J.J. Denny. Thirty-nine of Elliott's
41 paintings were used to illustrate his Report upon the Present Condition
of the Fur-Seal Rookeries of the Pribilof Islands of Alaska, November 17,
1890. The report was printed as House Document No. 175 (Serial No. 3421),
54th Cong., 1st Sess. (G.P.O., 1896). The glass negatives are among the
pictorial records of the Supervising Architect of the Treasury.

90. PHOTOGRAPHS OF SEAL ROOKERIES ON THE PRIBILOF ISLANDS. 1892-97. 4 vols. 1 ft. 400 items.

Arranged by rookery and then by station number.

Photographic prints collected by the Division of Special Agents,

Department of the Treasury of fur seal and sea otter rookeries on St.

Paul and St. George Islands for its investigation of the decrease in the number of fur seals. The photographs were taken in June and July of each

year and from approximately the same position. They were obtained from the U.S. Commission of Fish and Fisheries. Many of the items are panoramic views.

RECORDS OF THE DIVISION OF ALASKA FISHERIES

The Division of Alaska Fisheries, established in 1912, supervised varied activities relating to fisheries in Alaskan waters and to fur sealing on the Pribilof Islands, some of which activities had been conducted by the Federal Government since 1868. The Division also supervised social and economic activities of the small, isolated, dependent communities on the Islands. It was renamed the Branch of Alaska Fisheries in 1948, which became a part of the Branch Resource Management in 1960. Records related to those of the Division of Alaska Fisheries are described in entries 66 - 176 and 285 - 291.

91. REPORTS AND RELATED RECORDS. 1869-1937. 31 ft.

Arranged by subject (not alphabetically). A list of file headings is available.

Primarily periodic, investigative and research reports submitted by agents of the Treasury and Commerce Departments, and the Bureau of Fisheries concerning Alaskan fisheries and fur seals, including the observations

of Henry Elliott in 1890, and scientists aboard the Albatross during the Alaska cruise of 1893. Also included are copies of fishery hearings and regulations, and correspondence with territorial delegates, and related records pertaining to subjects such as Federal and Territorial legislation, the withdrawal of land for fishery reservations, fishery permits, leasing, islands for fox farming, wildlife refuges, the Alaska Interdepartmental Board, fish cannery operations, and related matters. A considerable amount of these records were transferred from the Treasury Department, and from the files of the Secretary of Commerce and Labor.

RECORDS OF THE DIVISION OF FISH CULTURE

An Act of June 10, 1872 (17 Stat. 350) authorized the United States

Fish Commission to undertake the propagation and distribution of certain

fresh water food fishes into the inland waters of the United States. Later

legislation extended this work to include marine fish, shellfish, and

lobsters. In 1887 supervision of the operation of fish hatcheries, also

referred to as fish culture stations, and the distribution of eggs and fry,

which had been administered by separate organizational units, were combined

to form the Division of Fish Culture. The Division was under the direct

supervision of the Commissioner of Fisheries until 1892, when as Assistant

in charge of Fish Culture was appointed. The work of the Division included

the operation and maintenance of fish hatcheries, the distribution of eggs,

and fry, the development of methods of hatching and transporting eggs and

fry, and cooperation with State fish and game agencies.

Records related to those of this Division are described in entries 221 - 229.

RECORDS OF THE DIVISION OF SCIENTIFIC INQUIRY

The primary function of the United States Fish Commission in 1871 was the scientific investigation of the distribution, abundance, and life histories of the commercial fishes and aquatic animals in the coastal and inland waters of the United States. The work was supervised directly by the Commissioner of Fisheries until 1882 when a Division of Fisheries was established, which conducted scientific investigations, and gathered statistical data regarding commercial fishes. In 1887 these two functions were separated with scientific studies placed under the supervision of an Assistant in charge of the Division of Scientific Inquiry.

The early work of the Division was oriented to ichthyological, biological, and oceanographic investigations relating to commerical fishes conducted in the field at biological laboratories and with the assistance of vessels such as the Steamers Fish Hawk and Albatross, and the Schooner Grampus, and research into the propagation of aquatic animals such as mussels, oysters, and sponges. Authorized by the Act of August 11, 1888 (25 Stat. 425) the duties of the Division soon expanded to include studying the effect of river impoundment projects on fish migration patterns,

and determining the feasibility of using fishways to direct fish around obstructions, both natural and manmade.

Concern about large scale fish and shellfish mortality caused the

Division to conduct investigations into the causes of red tides, and into
the prevalence and effect of water pollution upon inland and coastal commercial fishery resources. In 1934, with funds provided by the Public
Works Administration, the Division in cooperation with the Forest Service
and the National Park Service undertook surveys of certain streams to determine the potential of those streams to provide habitat for commercial and
game fishes.

Records related to those of this Division are described in entries 298 - 357.

Correspondence, reports, and related records concerning biological studies of certain commercially important species of fish, shellfish, and mollusks, and investigations of the fishery resources of certain geographical regions of the United States. 122. NOTES OF W. C. KENDALL CONCERNING MACKEREL INVESTIGATIONS OF THE SCHOONER GRAMPUS. 1895-96. 3 in.

Daily entries including information on vessel location, weather conditions, and research activities.

RECORDS OF THE DIVISION OF FISHERY INDUSTRIES

The Act of March 3, 1879 (20 Stat. 383) authorized the United States

Fish Commission to compile statistical data on the commercial fishes of

the inland and coastal waters of the United States. From 1871, when the

Commission was established, to 1879, when the Act was passed, the col
lection of statistical information had been undertaken in conjunction with

the scientific investigations conducted by the Commission.

A Division of Fisheries was established in 1882, which directed both the collection of statistical data and scientific investigations. In 1887 these activities were placed in separate organizational units, with statistical work under the direction of an Assistant in charge of the Division of Statistical Inquiry, also referred to as the Division of Statistics and Methods. In 1921 the unit was renamed the Division of Fishery Industries.

Records related to those of this Division are described in entries 292-297.

130. INDEX TO NAMES OF WRITERS OF LETTERS RECEIVED BY THE DIVISION OF STATISTICAL INQUIRY. 1888-91. 1 vol. 3/4 in.

compiled data on the shad fishery of the Middle Atlantic from 1876 to 1935, and other records.

General Records

The general records of the Bureau of Biological Survey are considered to include records relating to the general administration of the Bureau and files relating to special activities prior to 1940 that cannot be attributed readily to particular organizational units. They do not include general correspondence and other records relating to wildlife management (in the Bureau and its successor) that possibly antedate the abolition of the Bureau in 1940 and continue in unbroken series after 1940. Such records (illustrated by entry [46) are described under headings of successor organizations.

BUREAU OF BIOLOGICAL SURVEY

Known as the "old Alphabetical File" this series consists of correspondence exchanged with prominent wildlife biologists and others interested in wildlife conservation. Part of this series was destroyed by fire.

139. MAP FROM THE DEATH VALLEY BIOLOGICAL SURVEY EXPEDITION. 1891. 1 item.

Printed map of parts of California, Nevada, Arizona, and Utah traversed in 1891 by the Death Valley Expedition, a biological survey conducted under the direction of C. Hart Merriman. The map was compiled by the U.S. Geological Survey. Shows topography, mountain peak elevations, springs, wells, place names, towns, and railroads at a scale of 16 miles to 1 inch.

The Branch of Alaska Fisheries formerly known as the Division of Alaska Fisheries before 1948 had responsibility for regulating and protecting Alaskan fisheries, administering regulations concerning fur seal and fox herds on the Pribilof Islands, and caring for native inhabitants of these islands. Related records concerning these activities are described 91-114 285-291 in entries 98-115 and 284-290.

The Branch had originally been titled in 1934 as the Division of Wildlife Research. Its work fell into five categories: (1) wildlife surveys, (2) food-habits research, (3) bird distribution and migration studies, (4) fur-animal research, and (5) wildlife disease investigations. Records related to those of this Branch are described in entries 253 and 254.

Some of the reports are manuscript copies of published Fish and Wildlife Service bulletins. It thus continued work of that unit, which has been previously described as concerned with curbing the increase and spread of stock-killing wild animals and destructive rodents. Records related to those of the Branch are described in entries 157 - 161 and 230-235

The Division of Construction and CCC Operations established in 1938 brought into one unit of the Bureau of Biological Survey emerging relief activities funded by the Civilian Conservation Corps and other emergency agencies. These activities had been administered previously by mainly the Division of Game Management and Division of Migratory Waterfowl. This new division carried out general construction plans designed to improve and develop national wildlife refuges. It prepared specifications and cost estimates, apportioned funds to individual projects, directed maintenance and repair operations, and assisted in enrollee safety work and instruction of educational classes in CCC camps.

188. GENERAL RECORDS CONCERNING EMERGENCY RELIEF PROJECTS. 1933-35. 4 ft.

Arranged by subject (not in alphabetical sequence).

Records concerning Civil Works Administration, National Industrial Recovery Administration, and Emergency Conservation Work programs administered by the Biological Survey and jointly undertaken with other Federal agencies. Included are correspondence, interoffice memoranda, reports from refuge supervisors, official issuances and instructions from the Federal Civil Works Administration, copies of memoranda by the Bureau for Robert Fechner, Director of Emergency Conservation Work, and other records documenting the appointment of deputy game wardens for patrol and enforcement work, construction work on refuges, and cooperation with the Forest Service in predator and rodent control operations. Correspondence, project proposals, estimates of the costs of materials, engineering specifications, and other records concerning construction projects on refuges and administration of projects. Most of the refuge files are continuations of the records described in entry 189.

The Office of Foreign Activities was established in 1945 in the Office of the Director of the Fish and Wildlife Service. It had responsibility for coordinating with research units of the Service the assignment

of technical experts to foreign countries to conduct fishery investigations, organization of assistance programs to rehabilitate and utilize fishery resources, maintenance of liaison with the State Department on fishery agreements, and assistance in negotiating international fishery agreements. The Office also represented the United States at international meetings on fisheries. Records related to those of this Office 208-215 are described in entries 207-214.

The Branch of Lands established in 1948 was the successor to the Division of Land Acquisition created in the Bureau of Biological Survey in 1929. The Branch had responsibility for the acquisition of areas of land and water suitable for national wildlife refuges. These areas were procured by reservation of public domain by Executive order, gift or easement, and by purchase with funds authorized by the Migratory Bird Conservation Act of 1929 and other acts of Congress and with allotment of emergency funds. After the creation of the Fish and Wildlife Service the Branch was also concerned with the acquisition of land to be used as fish culture stations. Related records Are described in Entries 236-245

The Act provided

for grants-in-aid to States for fish restoration projects and fishery management research. The Branch also coordinated the fish and wildlife conservation programs of organizational units within the Survey with the restoration projects undertaken by the States.

One of the Division's oldest hatcheries was located at Wytheville, Va. This installation was discontinued in 1958 and some of its records were transferred to the Division of Fish Hatcheries. They constitute a major part of the divisional records described herewith. Earlier records concerning the Wytheville Hatchery are described in entry 21.

The Division supervised continuing activities to combat animal depredations on livestock, rodent damage to timber and range resources, and bird damage to agricultural crops. Correspondence, memoranda, legal opinions given by the Office of the Solicitor of the Department of the Interior, tables showing the acreage open to hunting on certain refuges, occasional copies of regulations, and

related records concerning the formation of Fish and Wildlife Service policy and subsequent regulations governing hunting and fishing on wildlife refuges.

250. LAND USE STATISTICS: 1950-65. 5 in.

Arranged by year, thereunder by region and thereunder alphabetically by name of refuge.

Printed statements showing the number of farming, grazing and timber permits that were issued; the acreage effected by each type of permit; and in some cases an acreage breakdown by a particular kind of farm use.

251. WILDERNESS STUDY AREA REPORTS. 1967. 9 ft.

Arranged alphabetically by name of area. A list is available.

Wilderness Study Reports containing information about the geological and social history, physical characteristics, resources such as wildlife, wetlands, grasslands, minerals and recreation possibilities, and potential for development for wildlife of the areas. These reports are often accompanied by transcripts of hearings and statements concerning the areas under consideration for inclusion in the National Wilderness Preservation System as provided for in the Wilderness Act of September 3, 1964.

252. RECORDS RELATING TO STUDIES PREPARED BY THE PUBLIC LAND LAW REVIEW COMMISSION. 1967-70. 5 in.

Arranged chronologically.

Correspondence, reports, and memoranda documenting cooperation between operating units of the Fish and Wildlife Service, primarily the Division of Wildlife Refuges, and certain officials of the Interior Department concerning studies prepared by the Public Land Law Review Commission bearing on the Federal laws and policies of the Fish and Wildlife Service that are applicable to the use and management of public lands administered as refuges, hatcheries, and for other purposes.

Records of the Division of Wildlife Research

The Division of Wildlife Research initially designated as such in 1934 and again in 1965 supervised continuing research activities that had begun in earlier units, especially the Division of Biological Investigations, Division of Economic Investigations, and Branch of Wildlife Research. Activities of these units have been described previously in this inventory. Records related to those of this Division are described in entries 177 and 178.

253. OFFICE FILES OF DR. FREDERICK C. LINCOLN. 1917-60. 19 ft.

Arranged alphabetically by subject. A list is available.

Includes correspondence, reports, memoranda, reference material and other records concerning the work of the Branch of Wildlife Research.

The files reflect Lincoln's active interest and expertise inormithology and include correspondence with private individuals, national organizations, international organizations and governmental committees concerning

conservation, regulations, distribution and migration, research, and various species of birds. Included are minutes of meetings of the American Ornithological Union, and correspondence with the Union and other committees and boards operating under the Migratory Bird Treaty Act. A few items predate Lincoln's service with the Bureau of Biological Survey.

254. CORRESPONDENCE. 1934-66. 14 ft.

Arranged by subject in rough alphabetical order. A file listing is available.

Correspondence, reports, and other records concerning research programs focused primarily on waterfowl and other birds with a few files on big game. Included are studies on banding, food habits, individual species of birds and the effects of pesticides on wildlife habitat and production.

Other records include information on cooperative agreements between the Fish and Wildlife Service and its predecessor, the Bureau of Biological Survey, with state game and conservation agencies and state educational and research institutions regarding wildlife conservation and research programs.

Records of the Division of Engineering

A Branch of Engineering was established in March 1950 by combining the engineering services formerly provided by the Branches of River Basin Studies, Game-fish and Hatcheries, Lands, Wildlife Refuges, and Federal Aid in Wildlife Restoration. The duties of the Branch included the design,

supervision of construction, and maintenance of structures and works, and other physical improvements, cadastral surveys, negotiation of water rights agreements, and other work requiring the services of civil engineers or architects.

The Branch of Engineering was organizationally assigned to the Bureau of Sport Fisheries and Wildlife subsequent to the reorganization of the Fish and Wildlife Service in 1956, but continued to furnish engineering services to the newly created Bureau of Commercial Fisheries, except for fish facilities design and services. The Branch became the Division of Engineering in 1965.

255. RECORDS CONCERNING CADASTRAL AND OTHER SURVEYS. 1926-67. 18 ft.

Arranged alphabetically by State, and thereunder alphabetically by name of refuge or fish hatchery. A list is available.

Correspondence and reports from field personnel concerning cadastral surveys made preliminary to the construction of levees, roads, trails, telephone lines, wells, and other physical improvements. The files also include considerable information on boundary surveys undertaken before 1950 with maps and index notes.

These records were maintained by the Division of Land Acquisition before being transferred to the Branch of Engineering in 1950.

Records of the Division of Management and Enforcement

Antecedents of the Division of Management and Enforcement, which was established in 1965, are traceable to various units of the Bureau of Biological Survey and Fish and Wildlife Service, especially the Section of Game Protection, Office of Game Protection, Division of Game and Bird Conservation, Division of Game Management, and Branch of Management and Enforcement. The Division inherited a number of functions from these units that dealt with the enforcement of Federal laws and regulations for the protection and conservation of wildlife. Records relating to those of the Division are described in entries 150-156.

258. RECORDS CONCERNING MIGRATORY WATERFOWL REGULATIONS. 1934-37. 5 ft.

Arranged in three subject areas (not in alphabetical order) and thereunder chronologically.

The records concern three general subject areas; migratory waterfowl regulations, including copies of regulations, advisory committee
recommendations, and correspondence from State game agencies, regional
officials of the Fish and Wildlife Service, and interested individuals;
Golden Eagle correspondence relating to depredations committed by eagles
and proposals to protect eagles; and Alaskan Game Law regulations including copies of the regulations, correspondence concerning cooperation
with the Alaska Game Commission, waterfowl protection problems, and proposals to transfer Fish and Wildlife functions to the State of Alaska.

259. RECORDS CONCERNING ENFORCEMENT OF GAME LAWS AND REGULATIONS. 1946-

Arranged alphabetically by State or subject.

Primarily reports of State or Federal game law offenses, often including information on the nature of the violation and prosecution of the offender, and related correspondence.

Records of the Division of River Basin Studies

Activities of the Division of River Basin Studies originated mainly in the Office of River Basin Studies created in 1945. This Office was placed under the Division of Technical Services in 1954. It was renamed

the Branch of River Basin Studies in 1957 and again renamed in 1964 the Division of River Basin Studies. The Division and its predecessors conducted studies that sought to ensure that Federal and federally licensed water development projects were planned, constructed, and operated with adequate protection of fish and wildlife.

260. GENERAL CORRESPONDENCE. 1944-72. 35 ft.

Arranged mainly alphabetically by subject.

General correspondence with regional officials of the Fish and Wildlife Service; and circulars and memoranda concerning administrative and policy matters governing the River Basin Studies program. Other files with subject headings such as beach erosion control, boat harbors, drainage, hurricane studies, and local flood protection, among others, include correspondence, reports, and other records concerning the effect on fish and wildlife resources of water development projects proposed bythe Army Corps of Engineers, the Bureau of Reclamation, and the Soil Conservation Service. Also documented is Fish and Wildlife Service participation in Federal programs such as Area Redevelopment, Economic Surveys of Hunters and Fisherman, Outdoor Recreation Surveys, the President's Water Resources Policy Commission, and an inventory of the Wetlands of the United States. The largest segment of the series contains information on Fish and Wildlife Service review of certain projects authorized by the Army Corps of Engineers and State agencies for the construction of causeways, dikes, boat ramps, and the dredging and filling in of areas serving as waterfowl and fishery habitats.

261. GENERAL PROJECT FILES. 1946-70. 230 ft.

Arranged alphabetically by name of individual project, river basin or stream. A list is available.

Correspondence, reports, studies, memoranda, and other records documenting consultations between the Fish and Wildlife Service and the Army Corps of Engineers, the Bureau of Reclamation, State fish and game agencies, conservation organizations, and others concerning the impact of hydroelectric, irrigation, flood control, beach erosion control, dredging, and other related projects on fish and wildlife resources.

262. HYDROELECTRIC PROJECT FILES. 1939-67. 35 ft.

Arranged numerically by license number assigned by the Federal Power Commission.

Correspondence of the Fish and Wildlife Service with officials of the Federal Power Commission, electric power company officials, members of Congress, and State fish and game departments; copies of licenses issued by the Federal Power Commission; and related records concerning the provision for fishways at hydroelectric dam sites. Records created before 1944 were transferred from the central files of the Bureau of Fisheries.

263. WATER RESOURCE ECONOMIC AND POLICY EVALUATION FILES. 1944-68. 5 ft.

Arranged by subject (not alphabetical sequence). A list is available.

Correspondence, memoranda, reports, printed volumes and other records concerning Fish and Wildlife Service participation on Presidential Commissions and interagency river basin committees concerned with formulating a comprehensive Federal policy for water resource development. Also included are records concerning the evaluation of the economic effects of Federal water resource development projects on fish and wildlife recreational resources.

264. RECORDS CONCERNING POLICY REVIEW AND EVALUATIONS. 1955-71. 11 ft.

Arranged by subject (not in alphabetical order). A list is available.

Correspondence, memoranda, studies and other records concerning the policy of the Fish and Wildlife Service with regard to the Cross Florida Barge Canal, channelization, estuary protection, small watershed development and other projects proposed by the Army Corps of Engineers and the Soil Conservation Service.

265. RECORDS CONCERNING THE WILD AND SCENIC RIVERS ACT. 1963-70. 3 ft.

Arranged chronologically.

Relating chiefly to the passage and implementation of the Wild and Scienic Rivers Act of October 2, 1968 (82 Stat. 906). Included are copies of bills, congressional hearings and reports, printed copies of studies on rivers proposed for coverage by the act, and correspondence of the Fish and Wildlife Service with the Bureau of Outdoor Recreation, members of Congress, and state conservation agencies.

Records of the Division of Fishery Services

A Section of Fishery Management was created in the Branch of Game

Fish and Hatcheries in 1950. As part of a reorganization effective

August 12, 1957, the Division of Sport Fisheries was established with a

Branch of Fishery Management as one of its component parts. The Branch

conducted studies and surveys of the production and utilization of marine

and fresh water sport fishery resources, developed fishery management pro
grams, facilitated implementation of these programs by other organizational
units of the Fish and Wildlife Service, and coordinated Federal programs

with State management plans.

In 1961 the Branch undertook the establishment of fishery cooperative units in cooperation with State fish and game departments, and universities as authorized and funded by the Act of September 2, 1960 (74 Stat. 733). The units, which were a part of the regional program of the Branch, engaged in the training of fishery biologists, fishery research, and furnishing extension services. In 1964 the Branch was made the Division of Fishery Management Services, and in 1965 it became the Division of Fishery Services.

266. RECORDS CONCERNING FISHERY PROGRAMS AND POLICIES. 1950-68. 7 ft.

Correspondence, periodic reports, budget proposals, and related records concerning the origins and mission of the Division, the effects of water impoundment projects on fishery resources, the development of recreational fishing areas on lands administered by the Defense Department

267. RECORDS CONCERNING FISHERY COOPERATIVE UNITS. 1961-66. 10 in.

Correspondence with State fish and game departments, and university officials, copies of agreements, and related records concerning the establishment of fishery cooperative units.

268. RECORDS CONCERNING FISHERY MANAGEMENT. 1964-67. 15 in.

Correspondence concerning fishery management programs directed by the Division on lands administered by Federal agencies, and information furnished to individuals making inquiries regarding certain Division programs.

RECORDS OF THE BUREAU OF COMMERCIAL FISHERIES

General Records

The general records of the Bureau of Commercial Fisheries are considered to include records relating to general administration of the Bureau and records concerning activities that cannot be readily attributed to particular organizational units.

Consist of correspondence, reports, memoranda, and related records pertaining to the operations and programs of the Bureau of Commercial Fisheries and predecessor agencies. The system, begun in 1937, replaced a numeric-subject classification system that was begun in 1906. When the 1906 system was discontinued the records were either merged into the new system or placed in subject files. The primary subdivisions of the decimal system, which correspond closely to the organization of the Bureau of Fisheries in 1937, are titled: Administration, Black Bass and Anglers, Vessels Service, Alaska Fisheries, Fish Culture, Fishery Industries, and Scientific Inquiry. For a select list of classifications, see Appendix I.

270. ADMINISTRATIVE RECORDS. 1926-68. 10 ft.

Arranged mainly by subject (not alphabetically).

Primarily binders containing copies of Directives, Field Manual Amendments, Orders, and other issuances. Included also are program planning materials, copies of the annual reports of the Bureau of Commercial Fisheries (1957-67), and records about Bureau reorganizations. Most of the records were created between 1942-64, and include a considerable amount of material maintained by the Fish and Wildlife Service up to 1956. Also part of the files are copies of appropriation Acts pertaining to fisheries from 1926 to 1965.

274. RECORDS CONCERNING DOMESTIC AND INTERNATIONAL CONFERENCES AND MEETINGS. 1958-68. 15 in.

Arranged by conference or meeting in rough chronological order.

Correspondence, memoranda, minutes of meetings, summaries of proceedings, briefing materials, copies of reports submitted at the meetings, and related records pertaining to participation by representatives of the Bureau.

275. RECORDS RELATING TO THE INTERNATIONAL PACIFIC HALIBUT COMMISSION. 1960-68. 3 ft.

Arranged chronologically by year, and thereunder by subject.

Included are minutes of meetings, annual reports of the Commission, periodic research reports compiled by the staff, copies of regulations issued by the Commission, and related records concerning the regulation of the halibut fishery in the North Pacific Ocean. These files were maintained by Harold E. Crowther, Chief of the Division of Industrial Research, who became a member of the Commission in 1961 and its Chairman in 1968.

276. RECORDS CONCERNING REGIONAL DIRECTOR'S MEETINGS. 1961-66. 8 in.

Includes agenda materials, memoranda, and other records relating to the review of Bureau programs and methods of operation, and the discussion of new legislation and orientations in Bureau resources and policies.

Records of the Branch of Resource Management

The Division of Resource Management, initially designated as such in 1957, inherited functions formerly performed by units of the Department of the Treasury and Department of Commerce and Labor; the Division of Alaska Fisheries and Division of Scientific Inquiry of the Bureau of Fisheries; and the Columbia Basin Fishery Development Program of the Fish and Wildlife Service. The Division exercised supervision over Alaska

ment, in cooperation with States. It was responsible for enforcing laws and regulations concerning the management of commercial fisheries and sea mammals, including laws and regulations concerning international agreements and commissions. Records related to those of the Division are described in entries 91-116 and 166-176

277. CORRESPONDENCE. 1942-66. 16 ft.

Arranged by subject (not alphabetically).

Correspondence, research and progress reports, memoranda, printed materials, and other records concerning river basin development programs, representation on international fishery commissions promulgating fishing regulations, enforcement of those regulations, and administration of Alaskan fisheries and fur seal resources.

Agreements with related correspondence, research reports, engineering plans, and other records concerning the handling of hatchery operations, stream clearance projects, fishway construction, and related work co-operatively undertaken by the Fish and Wildlife Service and the States of Idaho, Oregon, and Washington.

281. COLUMBIA RIVER PROJECT CLOSING REPORTS. 1952-58. 6 ft.

Arranged mainly by name of project.

These reports provide information on the project location, cost, objectives, closing statement of accomplishments, inspection reports, and related data. The projects concerned salmon rehabilitation, stream surveys, stream clearing and maintenance, biological investigations, the construction of fishways and screening of diversions. A few of the reports include maps and engineering drawings.

282. BUDGET RECORDS. 1961-68. 3 ft.

Arranged by fiscal year, and thereunder by type of record.

Included are program financial reports, justifications, appropriation estimates, and related records.

283. LEGISLATIVE RECORDS. 1962-66. 10 in.

Arranged by House or Senate bill number.

Copies of bills, committee reports, and memoranda concerning water resource projects.

284. STATE WATER QUALITY STANDARDS REPORTS. 1967-68. 7 ft.

Arranged alphabetically by State, and thereunder by stream, water-shed, or area.

Printed reports repared by State governments outlining water quality criteria, the means of reaching water quality control objectives, and the implementation of monitoring and surveillance programs.

Records of the Division of Industrial Research

The Division of Industrial Research established in 1960 was the successor to several fishing industry research units of the Bureau of Fisheries and the Fish and Wildlife Service, especially the Division of Fishery Industries, Division of Commercial Fisheries, Branch of Commercial Fisheries, and Division of Industrial Research and Services. The Division supervised fishing gear investigations, exploratory fishing activities, and the collection of statistics and other data to promote the efficient use of products of marine or fresh-water origin; determine the economic position of the fishing industry; assist the industry in developing markets for fishery products; and provide information on production trends, employment, supplies, areas of capture, and related subjects. Records related to those of the Division are described in entries 130-137.

292. CORRESPONDENCE RELATING TO TECHNOLOGICAL INVESTIGATIONS. 1943-67.

Arranged by subject (not alphabetically).

Correspondence and related research reports, and other records relating to projects investigating the utilization of fish by-products, storage and processing methods, grading standards, nutritional value, shellfish toxins, and other subjects concerning certain species of fish. The reports were prepared by technological field laboratories in cooperation with fish industry associations and university research centers, and financed by funds provided under the Saltonstall-Kennedy Act of 1954. Also included

are records concerning cooperation with domestic fishery associations, and attendance at meetings of international organizations concerning fishery resources.

293. CORRESPONDENCE RELATING TO EXPLORATORY FISHING. 1945-65. 4 ft.

A few files provide information on the administration of the research grant programs, proposal procedures, and related information.

Quarterly reports prepared by the Bureau's technological field laboratories containing a narrative description of current projects, estimates
of percentage completed, a summary of preliminary results often with

297. REPORTS ON FISHING TRENDS AND CONDITIONS. 1957-61. 15 in.

Periodic narrative and statistical reports compiled by fishery
marketing specialists concerning coastal marine fishery industries.

Included is information the amounts and quality of various species harvested

and market conditions, with comments on the labor situation in related industries, and the economic outlook for the region.

Records of the Division of Biological Research

The Division of Biological Research established in 1957 inherited some fisheries investigations formerly conducted by the Division of Scientific Inquiry, Division of Fishery Biology, and Branch of Fishery Biology. The Division supervised commercial fisheries investigations relating to the nature, extent, and causes of the varying abundance of important food fish and shellfish. It developed methods for conserving, developing, and managing fishery resources and recommended research for developing shellfish cultural practices and the prevention and control of fish diseases and pests. Records related to those of the Division are described in entries 121-129

298. PERIODIC NARRATIVE REPORTS. 1955-59. 10 in.
