YEMEN

The People's Democratic Republic of Yemen and the Yemen Arab Republic merged into a single sovereign State on May 22, 1990 called the Republic of Yemen. In a note dated May 19, 1990, to the Secretary-General of the United Nations, it was stated that . . . "All treaties and agreements concluded between either the Yemen Arab Republic or the People's Democratic Republic of Yemen and other States and international organizations in accordance with international law which are in force on May 22, 1990 will remain in effect, and international relations existing on May 22, 1990 between the People's Democratic Republic of Yemen and the Yemen Arab Republic and other States will continue." . . .
