**Subject:** Proposed Labor Reg 2520.101-4(a)(2)

Reviewing the proposed Model Notice for multiemployer plans, the section entitled "Benefit Payments Guaranteed by the PBGC" is not warranted, and will be confusing for participants whose plan's funded current liability percentage is less than 100% but are not at substantial risk of insolvency. Suggesting that benefits may be substantially reduced for participants in plans whose insolvency is highly improbable will create unnecessary (or at least premature) concerns and require otherwise unnecessary explanation by trustees and administrators. I suggest either that the PBGC portion of the notice be required only for plans that report a 75% or less funded liability percentage or that, following the sentence in the proposed section "Risks Governing Insolvent Plans", such plans be permitted to add a sentence to the effect that they are not insolvent and omit the next two sections..
