**ABSTRACT:** Investigative records contain copies of messages between US and foreign law enforcement in international criminal investigative and humanitarian matters. Administrative records include personnel and general files.

**PURPOSE:** To enable US federal, state, and local law enforcement to seek and to provide police-to-police criminal investigative and humanitarian assistance involving any two or more of the other 186 INTERPOL member countries; to enable the USNCB to function efficiently.

**ACCESS CONSTRAINTS:** All records are protected from unauthorized access through appropriate administrative, physical, and technical safeguards.

**USE CONSTRAINTS:** For performance of assigned tasks.

**AGENCY PROGRAM:** Supports international criminal investigative and humanitarian work of all US federal, state, and local law enforcement.
