ORDERED, ADJUDGED AND DECREED that Bicknell notify, in writing, all persons whose income tax returns he has prepared from 1987 to the date of this Court's order, inclusive, of the findings and relief ordered by this Court, including in such notice to each person a copy of this Complaint and of the Court's Final Order of Permanent Injunction; and that Bicknell file with the Court a list of the names and addresses of all persons so notified within 90 days of the date the Order is entered.

This Court will retain jurisdiction of this matter to enforce this order.
