Indicators of Domestic Primary Metals, Steel, Aluminum, and Copper Activity

December 2007

The primary metals leading index decreased in November, and its 6-month smoothed growth rate sank further into negative territory. The growth rate is suggesting that activity in the primary metals industry will slow in the months to come. The metals price leading index growth rate increased in November, suggesting an increase in some metals price growth in the near term. However, profit-taking by speculative investors could suppress that increase.

The primary aluminum and the aluminum mill products indexes are suspended because of discontinued availability of industry-specific historical data. The USGS will continue to calculate the steel and copper composite indexes.

The **primary metals leading index** decreased 0.5% to 151.0 in November from a revised 151.8 in October, and its 6-month smoothed growth rate sank to -2.8% from a downwardly revised -1.8% in October. The 6-month smoothed growth rate is a compound annual rate that measures the near-term trend. Normally, a growth rate above +1.0% signals an upward trend for future growth in metals activity, while a growth rate below -1.0% indicates a downward trend. The stock price index combining construction and farm machinery companies and industrial machinery companies declined sharply in November, contributing -0.9 percentage points to the net decrease in the primary metals leading index. The JOC-ECRI metals price index growth rate resumed its downward spiral, after an uptick in October, contributing -0.8 percentage points. The Institute for Supply Management's PMI continued to decline, although at a slower pace. Nevertheless, it settled above the threshold that suggests an increase in future U.S. manufacturing activity. Its contribution rounded to zero. In contrast, a longer average workweek in primary metals establishments in November contributed 1.1 percentage points to the leading index. Only four of the leading index's eight components were available for the November index calculation. The primary metals leading index will likely be revised next month when the remaining four components become available.

The slower U.S. manufacturing sector and suppressed housing construction have dampened domestic metals demands. Slower

economic growth in many other industrialized countries also has had a negative impact on metals demands. However, strong growth in emerging Asian economies, such as China and India, could lessen some of that negative impact. U.S. primary metals industry activity growth will likely slow in the near term.

The **steel leading index** eased down 0.2% to 119.8 in October, the latest month for which it is available, from a revised 120.0 in September. Its 6-month smoothed growth rate decreased to -1.7% from a revised -1.2% in September. The climbing S&P stock price index for steel companies and an increase in new orders for iron and steel mill products buoyed the steel leading index some. However, gains in these indicators could not offset declines in the index for new housing permits and the growth rate of the inflation-adjusted M2 money supply. The steel leading index growth rate continues to decline and is pointing to a downturn in the U.S. steel industry in the near future.

The **copper leading index** edged up 0.2% in October to 124.7 from a revised 124.5 in September, and its growth rate rose to -2.2% from -2.7% in September. Movement among its six indicators was mixed in October, with the largest positive contribution coming from added overtime hours in copper rolling, drawing, extruding, and alloying facilities. However, these extra hours were used to make up for fewer production workers employed in this industry. Fewer new housing permits issued, the declining copper price, and the falling S&P stock price index for building products companies made sizable negative contributions to the leading index. The copper leading index growth rate

has been negative for 3 months in a row; it is suggesting that activity growth in U.S. copper industry activity could slow in the near term.

Market Speculation May Hamper Metals Prices Growth

The **metals price leading index** increased 1.2% in October to 107.7 from a revised 106.4 in September. October is the latest month for which it is available. Its 6-month smoothed growth rate rose to 3.8% in October from a revised 1.5% in September. The climbing growth rate of the index measuring the trade-weighted average exchange value of other major currencies against the U.S. dollar accounted for most of the net increase in the leading index; it contributed 1.0 percentage point to the leading index. The yield spread between the U.S. 10-year Treasury Note and the federal funds rate lifted the leading index another 0.3 percentage points. The contribution from the growth rate of the inflation-adjusted value of new orders for U.S. nonferrous metal products rounded to zero. The fourth index component, the growth rate of the Economic Cycle Research Institute's (ECRI) 18-Country Long Leading Index, was only available

through September. It continued to decline, suggesting slow or decreased growth for most global economies. The ECRI 18-Country Long Leading Index signals changes in the growth of economic activity in major industrialized countries about 5 months in advance.

The growth rate of the inflation-adjusted value of inventories of U.S. nonferrous metal products, which is an indicator of metals supply, dropped in October. This indicator, which usually moves inversely with the price of metals, is deep in negative territory. It along with the positive metals price leading index growth rate would normally indicate an increase in metal prices. However, speculators concerns over many global economies' sustained growth may incite metals profit-taking and hamper metals price growth in the near term.

The business cycle and inventories are only two factors in metals price determination. Other factors that affect prices include changes in metals production, speculation, strategic stockpiling, foreign exchange rates, geopolitical instability, and production costs.

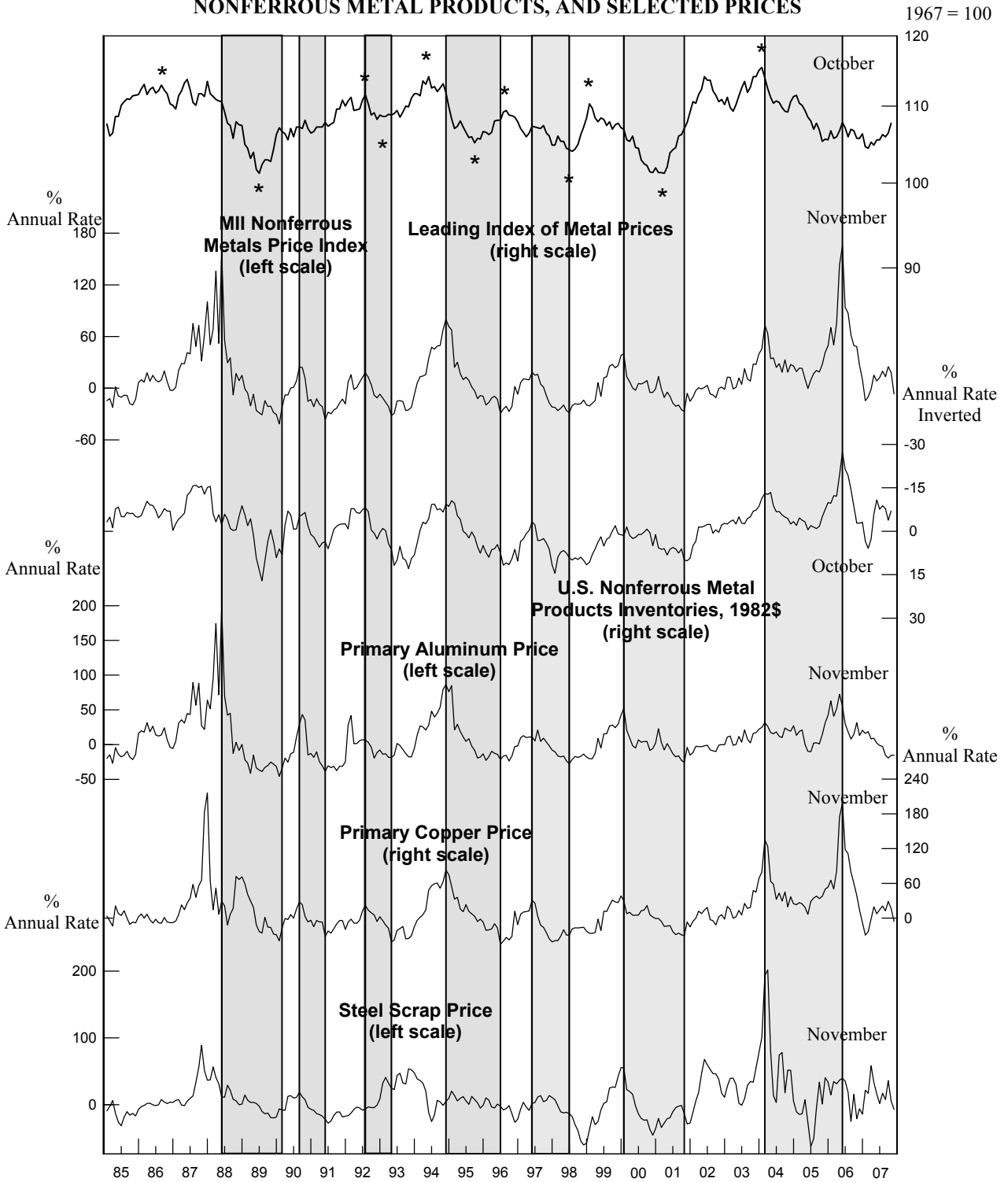

Note: The components of the Leading Index of Metal Prices are the spread between the U.S. 10-year Treasury Note and the federal funds rate, and the 6-month smoothed growth rates of the deflated value of new orders for nonferrous metal products, the Economic Cycle Research Institute's 18-Country Long Leading Index, and the reciprocal of the trade-weighted average exchange value of the U.S. dollar against other major currencies. The Metal Industry Indicators (MII) Nonferrous Metals Price Index measures changes in end-of-the-month prices for primary aluminum, copper, lead, and zinc traded on the London Metal Exchange (LME). The steel scrap price used is the price of No. 1 heavy melting. Inventories consist of the deflated value of finished goods, work in progress, and raw materials for U.S.-produced nonferrous metal products (NAICS 3313, 3314, & 335929). Six-month smoothed growth rates are based on the ratio of the current month's index or price to its average over the preceding 12 months, expressed at a compound annual rate.

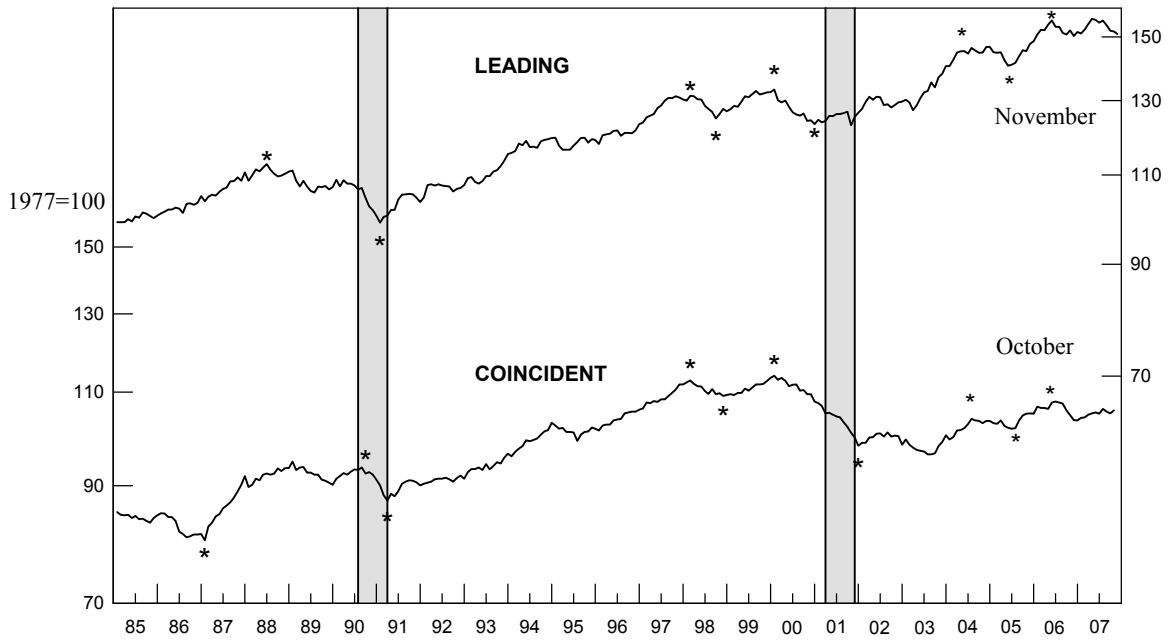

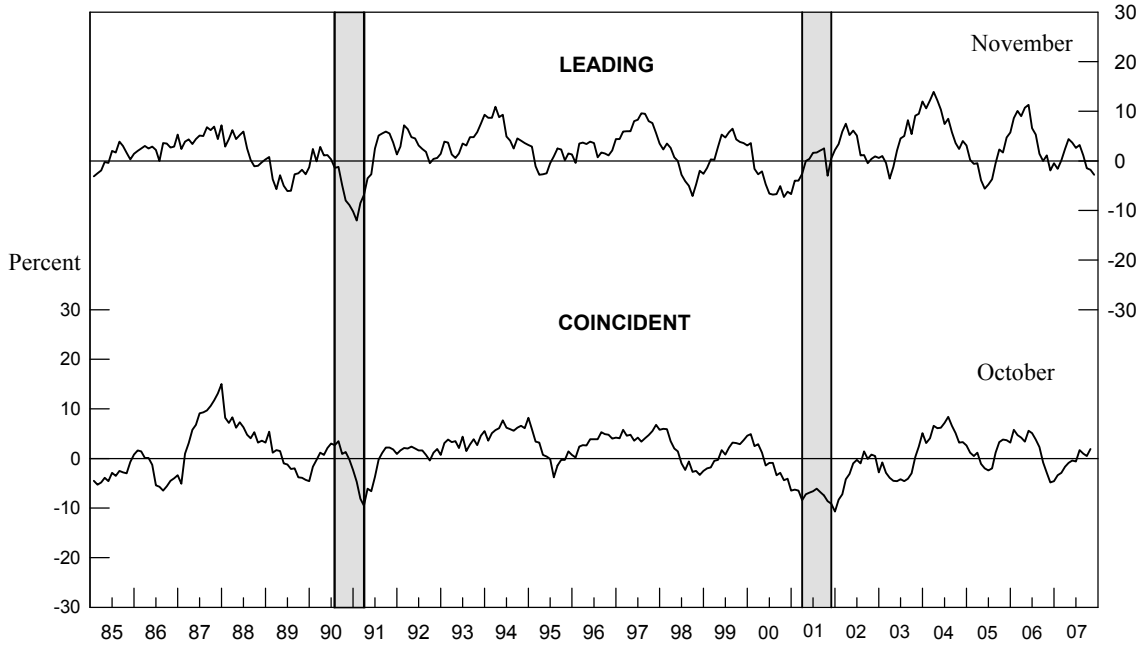
PRIMARY METALS: LEADING AND COINCIDENT INDEXES, 1985-2007 1977=100

1977=100

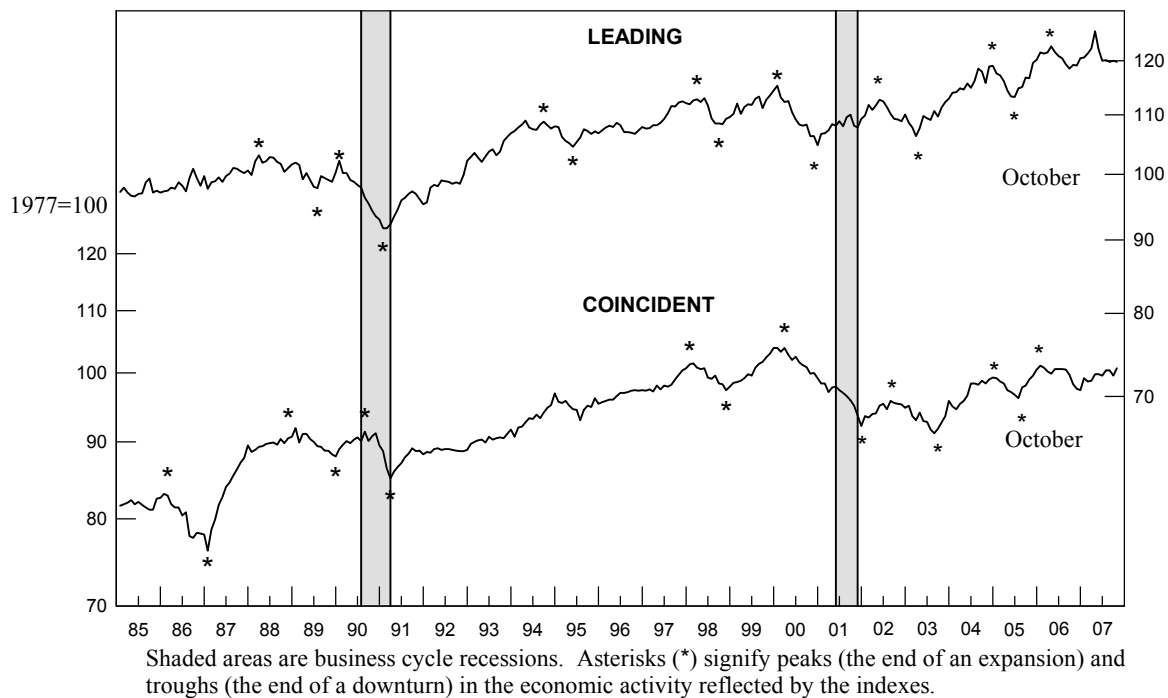
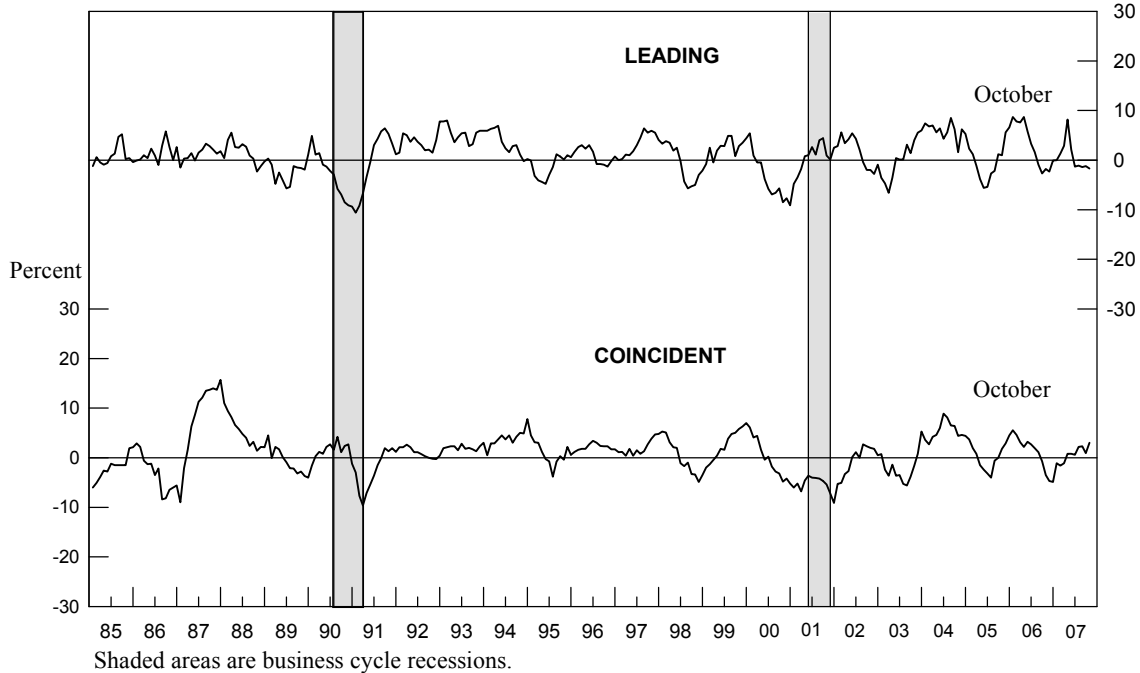

COPPER: LEADING AND COINCIDENT INDEXES, 1985-2007

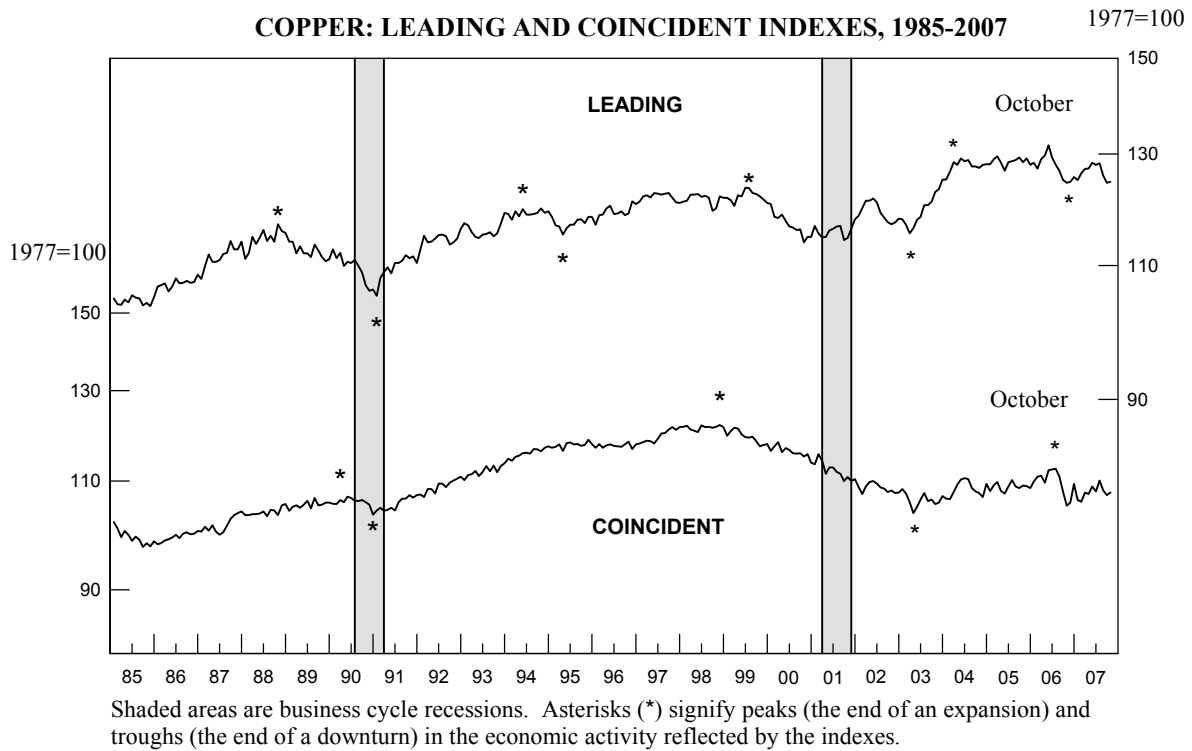
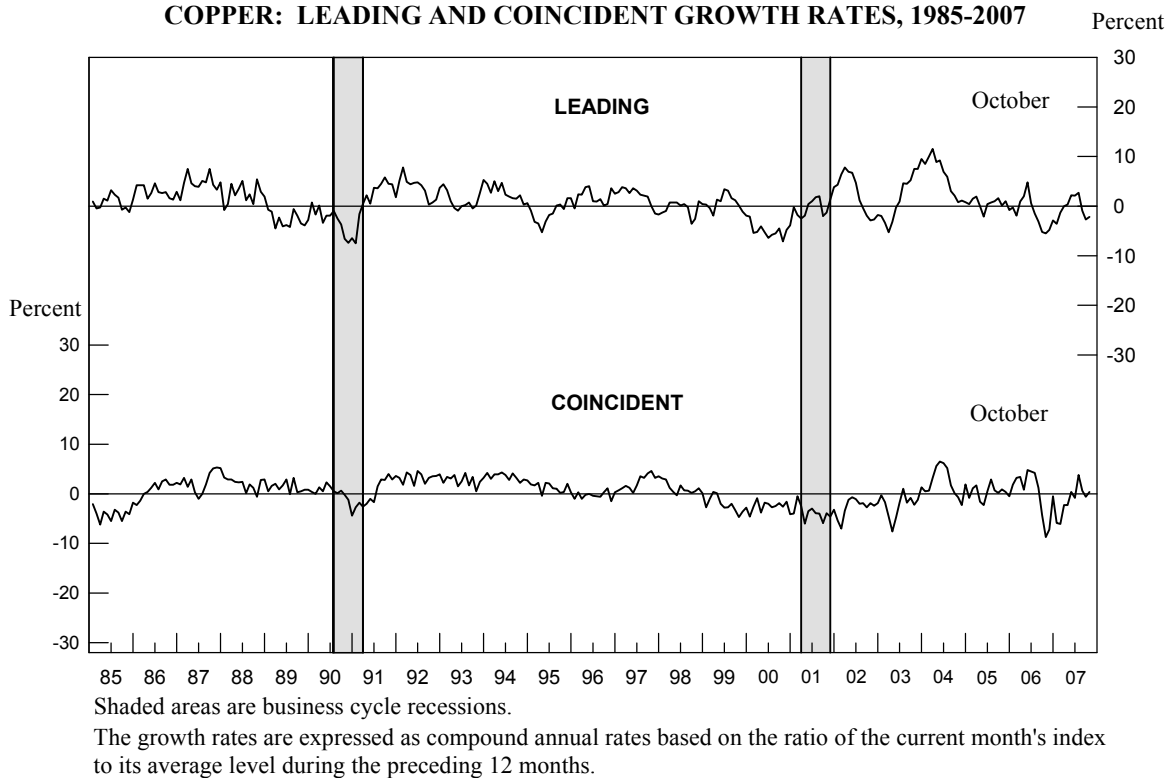

Explanation

Each month, the U.S. Geological Survey tracks the effects of the business cycle on five U.S. metal industries by calculating and publishing composite indexes of leading and coincident indicators. Wesley Mitchell and Arthur Burns originated the cyclical-indicators approach for the economy as a whole at the National Bureau of Economic Research in the mid-1930s. Over subsequent decades this approach was developed and refined, mostly at the National Bureau, under the leadership of Geoffrey H. Moore.¹

A business cycle can briefly be described as growth in the level of economic activity followed by a decline succeeded by further growth. These alternating periods of growth and decline do not occur at regular intervals. Composite indexes, however, can help determine when highs and lows in the cycle might occur. A composite index combines cyclical indicators of diverse economic activity into one index, giving decision makers and economists a single measure of how changes in the business cycle are affecting economic activity.

The indicators in the metal industry leading indexes historically give signals several months in advance of major changes in a coincident index, a measure of current metal industry activity. Indicators that make up the leading indexes are, for the most part, measures of anticipations or new commitments to various economic activities that can affect the metal industries in the months ahead.

Composite coincident indexes for the metal industries consist of indicators for production, shipments, and total employee hours worked. As such, the coincident indexes can be regarded as measures of the economic health of the metal industries.

The metal industry coincident indexes reflect industry activity classified by the U.S. Standard Industrial Classification (SIC) and the North American Industry Classification System (NAICS). Of the five metal industries, primary metals (NAICS 331) is the broadest, containing 25 different metal processing industries. Steel, aluminum, and copper are specific industries within the primary metals group.

The SIC was the main vehicle used by the U.S. Government and others in reporting industry economic statistics throughout most of the last century. Starting with the 1997 U.S. Economic Census, the U.S. Government began using the NAICS, which classifies economic data for industries in Canada, Mexico, and the United States. In general, metal industry indexes starting in 1997 begin to reflect the NAICS classification, while indexes for earlier years follow the SIC. Hence, composite indexes from 1997 forward are not entirely consistent with those of earlier years.

The largest change to primary metals because of the NAICS deals with other communication and energy wire manufacturing (NAICS 335929). Under NAICS, this manufacturing has been removed from primary metals and added to electrical equipment, appliance, and component manufacturing. Because monthly shipments and new orders for this wire are not available, the USGS is estimating their values from 1997 onward and adding them to the appropriate metal industry indicators and indexes to maintain consistency.

There are other small changes to the primary metals industry because of the switch to the NAICS. Coke oven activity not done by steel mills, for example, is removed and alumina refining, a part of industrial inorganic chemical manufacturing under the SIC, is added. Since the historic trends of the composite indexes are not affected by these small changes, the USGS is not making specific adjustments to the indexes for them for the periods before and after 1997.

The metal industry leading indexes turn before their respective coincident indexes an average of 8 months for primary metals and 7 months for steel and copper. The average lead time for the primary aluminum leading index is 6 to 8 months, and the average lead time for the aluminum mill products leading index is 6 months.

The leading index of metal prices, also published in the *Metal Industry Indicators*, is designed to signal changes in a composite index of prices for primary aluminum, copper, lead, and zinc traded on the London Metal Exchange. On average, this leading index indicates significant changes in price growth about 8 months in advance.

The growth rate used in the *Metal Industry Indicators* is a 6-month smoothed growth rate at a compound annual rate, calculated from a moving average. Moving averages smooth fluctuations in data over time so that trends can be observed. The 6-month smoothed growth rate is based upon the ratio of the latest monthly value to the preceding 12-month moving average.

$$\left[\left(\frac{\text{current value}}{\text{preceding 12-month moving average}} \right)^{\frac{12}{6.5}} - 1.0 \right] * 100$$

Because the interval between midpoints of the current month and the preceding 12 months is 6.5 months, the ratio is raised to the 12/6.5 power to derive a compound annual rate.

The growth rates measure the near-term industry trends. They, along with other information about the metal industries and the world economy, are the main tools used to determine the outlook of the industries. A 6-month smoothed growth rate above +1.0% usually means increasing growth; a rate below -1.0% usually means declining growth.
