CEMENT IN SEPTEMBER 2007

This report provides monthly data on the shipments of cement to final customers, and the production of clinker, in the United States from January 2006 through the current month.¹ Data on the imports of cement and clinker for the current month are also provided.

Total shipments of portland and blended cement in the United States and Puerto Rico for September 2007 were about 9.7 million metric tons (Mt). This was 9.6% lower than shipments in September 2006 (tables 2A and 2B). Shipments year-to-date totaled about 86.0 Mt, down by 9.6% compared with those (revised) of the same period in 2006. The leading producing States (Texas, California, Michigan, Pennsylvania, and Missouri, in descending order) shipped about 35% of the September total (table 1A). The leading consuming States (Texas, California, Florida, Illinois, and Ohio, in descending order) received about 36% of September's total shipments (tables 2A and 2B).

Clinker production totaled about 7.4 Mt, about 4.4% lower than the production in September 2006 (table 4). Production year-to-date was 65.1 Mt, down by 2.6% from that of the same

period in 2006. The leading clinker-producing States (California, Texas, Pennsylvania, Alabama, and Florida, in descending order) produced about 42% of the September total.

Masonry cement shipments in September of about 337,000 metric tons were 21.7% lower than shipments for September 2006 (table 2C). Shipments year-to-date were 3.39 Mt, down by 19.6% from those of the same period in 2006. The leading consuming States in September, in descending order, were Florida, California, Texas, North Carolina, and Georgia, and these States received almost 48% of the month's total shipments.

Tables 5, 6, and 7 contain import data from the U.S. Census Bureau. Data for clinker imports into the Seattle and possibly the Detroit customs districts remain incomplete owing to some shipments arriving overland from Canada on an informal entry basis. September 2007 imports of cement and clinker were about 2.0 Mt, down by about 35% from imports in September 2006. Imports year-to-date were about 18.0 Mt, down by about 38% from those of the same period in 2006.

 (based on table 3)

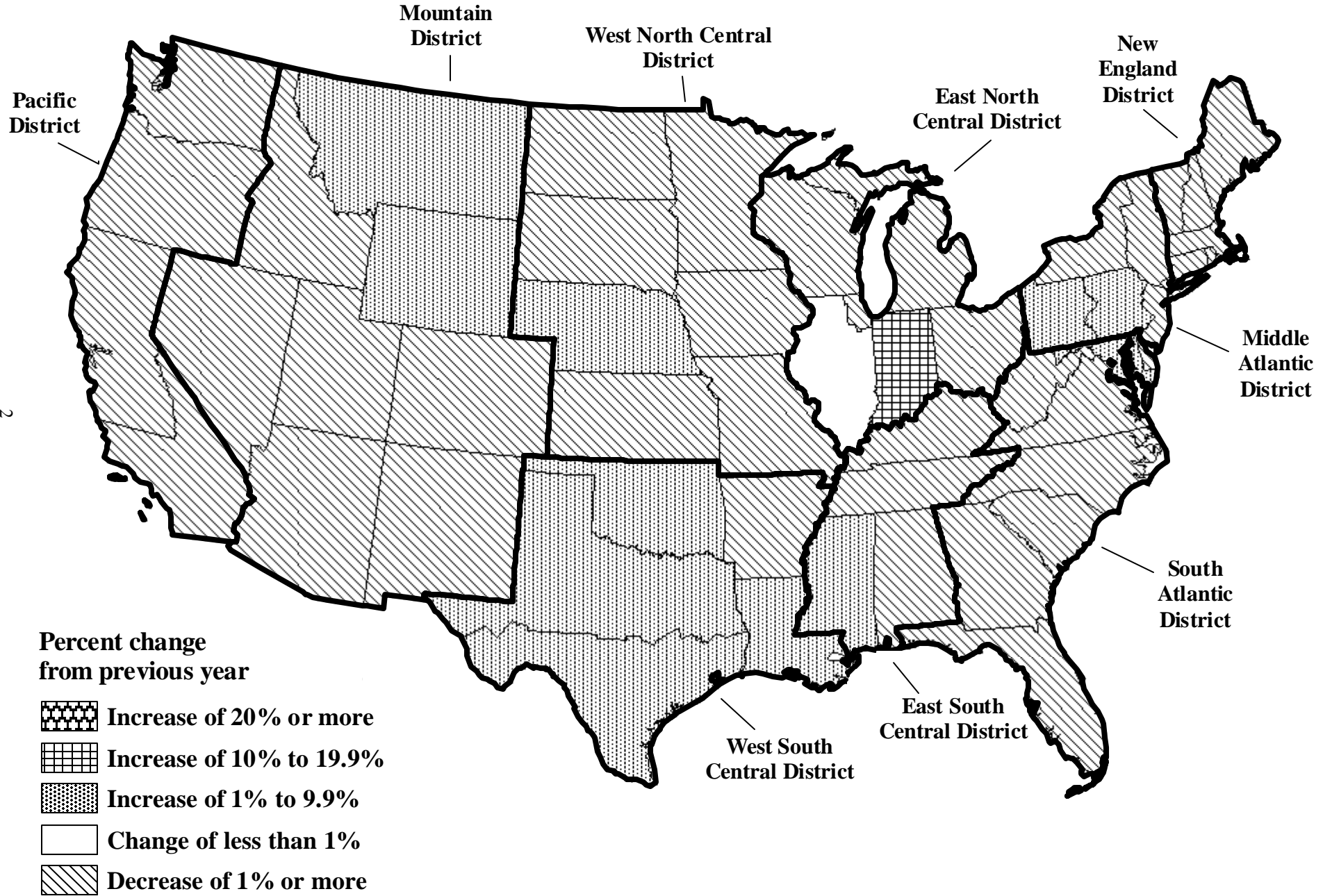
