# II. Background

Baskets Weavers Co-operative Club's (BBWCC) members are skilled artisans capable of producing high quality straw products for export. They weave to buyer requests for specific size, style and color according to the season or colors currently in-vogue in an export market. BBWCC, however, lacks the management capability to be proactive in identifying export markets, produce to export standards, and develop product designs that appeal to western consumers. Therefore, BBWCC's export marketing strategy has been reactive,. Generally consisting of ad hoc interactions with buyers. Because of their high cost of inputs and their lack of control of the distribution channel, BBWCC's members also earn low margins on their products.

There is an immediate market opportunity for BBWCC to develop a more stable export market through selling its products to an international buyer. This opportunity has resulted from ADF's new pilot initiative called the Buyer Linkage Program (BLP) which is a focused program aimed at connecting suppliers especially in the handicraft sector to a wide range of suitable buyers.

# V. Project Purpose

The purpose of this project is to increase the incomes of BBWCC and its members derived from the export and domestic sale of their straw products, as indicated by the following:

- BBWCC's net income will improve from a\$721deficit in year 0, to \$3,896 in year 1, \$4,468 in year 2, and to \$7,000 in year 5.
- The income of members from their weaving activities will increase from zero before project implementation begins to \$16 in year 1, and to \$24 by year 5.

# VI. Project Outputs

The expected outputs from the project areas follows.

# A. Increased capacity of BBWCC to produce market-quality baskets:

- production output will increase from 3,000 baskets in year 0 to 7,000 in Year 1 to 7,700 in Year 2, to 8,450 in Year 3, to 9,316 in Year 4 to 10,249 in year 5; and
- revenue from the sell of baskets will increase from \$11,413 in year 0 to \$55,805 in year 1, to \$63,295 in year 2, \$71,790 in Year 3, to \$81,428 in Year 4 to \$92,361 in year 5.

# B. Improved operational efficiency:

Specific production improvement activities will include re-organizing weavers to work in groups at craft centers, bulk purchase of straw during the peak season to reduce input cost and ensure continuous production, and establishment of a straw farm to reduce production cost.

BBWCC will undertake the necessary actions to ensure the safety of its member. These action will include, but are not limited to, maintaining a first aid kits and fire extinguishers and production centers, training in the use of the kits and extinguishers, and undertake an environmental impact evaluation of the chemical dyes, fungicides, and pesticides used in production.
