FOIA/PA Request-A FOIA request is generally a request for disclosure of records concerning a third party, an organization or a particular topic of interest. A Privacy Act request is a request for records covered by that Act concerning the requestor, such requests would also be treated as FOIA requests.

Initial Request-a request to NACIC for records under FOIA.

Appeal-a request to NACIC asking that it review at a higher administrative level a full or partial denial of a FOIA request, or any other FOIA determination such as a matter pertaining to fees.

Processed Request or Appeal-a request or appeal for which NACIC has taken final action.

Denial-a NACIC decision not to release any part of a record or records in response to a FOIA request because all of the information in the denied request is determined by NACIC to be exempt under one or more of the FOIA exemptions, or for procedural reasons.

Working Days-days excepting Saturdays, Sundays, and legal public holidays.
