<u>Introduction to Agency:</u> The Voice of America is a component of the Broadcasting Board of Governors. The VOA broadcasts news and information to millions throughout the world in more than 40 languages, via radio, television and the Internet. Our diverse, multicultural and dedicated professionals staff correspondent bureaus, transmission stations and marketing offices around the world in addition to our main offices in Washington, DC.

<u>DUTIES</u>: This position will be used to fill International Broadcaster positions who will serve as reporters, writers, translators, adapters, editors, producers, video journalist and announcers for Radio, TV and/or Internet. Broadcasters research and write original materials in the broadcast language, translate and adapt a variety of news and news-related material from English into the broadcast language, edit material prior to broadcast, and provide reportorial coverage of news events. Materials include news, editorials, interviews, news analyses, and feature pieces covering a wide range of issues and subjects. The broadcaster also voices all types of material broadcast by the language service. In carrying out these functions, broadcasters must tailor materials to the interest and needs of the audience, and see that the broadcast is factual, objective, and balanced. The broadcaster also is responsible for assuring that the material broadcast serves to make American policies and culture understandable and meaningful to audiences living in different political settings and with differing cultural frames of reference.

QUALIFICATION REQUIREMENTS: CANDIDATES MUST HAVE EXPERIENCE IN RADIO BROADCAST JOURNALISM, PRINT, TELEVISION OR FILM JOURNALISM. WORK MUST HAVE INCLUDED WRITING, EDITING AND/OR VOICING BROADCAST MATERIAL FROM ENGLISH INTO THE BROADCAST LANGUAGE.

**SPECIALIZED EXPERIENCE**: Candidates must possess one year of specialized experience equivalent to the next lower level of the position for which applying. This experience must have provided work translating, adapting and originating news and news-related scripts for TV, radio and/or Internet under intense time pressure with accuracy, speed and intelligence.

Candidates must be able to announce/voice news and feature program materials live and pre-recorded for TV, radio and Internet. Candidates must have experience writing reports and features on subjects of general interest for broadcast on TV, radio and/or posting on the Internet. Experience must have provided the ability to produce live and pre-recorded air show segments for radio and TV.

Candidates should possess knowledge of world affairs, international relations, Americana, and U.S. policies in order to prepare programs appropriately and effectively for the targeted listening audience.

Candidates must posses native fluency in the broadcast language including idioms, contemporary nuances and commonly used terms and vocabulary in order to translate/adapt English language news into correct, comprehensive and effective TV, radio scripts and Internet postings. The language ability required typically is that of a native speaker but may be obtained through extensive study or exposure to the written and spoken language that has provided the candidate with equivalent ability.

The candidate's overall background must clearly demonstrate possession of the required experience and language ability.

## **SUBSTITUTION OF EDUCATION PROVISIONS:**

GS-9 = Master's degree or equivalent; OR two full years of graduate level experience OR LLB or JD

GS-11 = Phd; OR equivalent doctoral degree

Education at the levels shown above in journalism, mass communication, etc. is fully qualifying. Other degree concentrations with an emphasis in journalism or communications may equip the candidate with the required knowledge as may appropriate combinations of education and experience in a related field. TRANSCRIPTS MUST BE PROVIDED if applying based on education.

EXAMINATIONS REQUIRED: Candidates who meet all education and/or experience requirements must demonstrate their knowledge and ability in language writing, and translation/adaptation through successful performance in a written examination and their ability to voice material for radio broadcast in a voice audition. You will be notified as to whether you will be scheduled for testing once qualifications determinations have been made. Tests are administered in Washington, D.C., New York, N.Y., and Miami, Fl. on an on-going basis. Tests are administered in Boston, Ma., Chicago, Il., Denver, Co., Los Angeles, Ca., Raleigh, N.C., Kansas City, Mo., San Antonio, Tx., San Francisco, Ca. and Seattle, Wa. on a quarterly basis. Tests may also be given in certain overseas locations. APPLICANTS WILL BE RESPONSIBLE FOR PAYING THEIR OWN EXPENSES TO AND FROM THE TEST SITE.
