Malta Field Office Planning Process Underway Scoping Meetings Scheduled

MALTA--The Bureau of Land Management's (BLM) Malta Field Office intends to prepare a Resource Management Plan (RMP) with an associated Environmental Impact Statement (EIS). The planning area encompasses Blaine, Glacier, Hill, Liberty, Phillips, Toole, Valley, and northern Choteau Counties, Montana. This new plan will replace the existing Judith-Valley-Phillips RMP and the West HiLine RMP, which currently guide management of these public lands.

As part of the planning process, 18 public scoping meetings are planned to obtain tribal, public and agency input to assist in identifying planning issues and to exchange ideas on how public land should be managed. Scoping is an invaluable first step in the planning process and public participation is encouraged. The RMP will address many issues related to: access and transportation corridors, energy development – (fluid minerals – oil and gas; alternative - wind), management of vegetation, management of wildlife, conservation and recovery of special status species, water quality, quantity, and aquatic species, management of areas with special values, availability and management of public lands for commercial uses, and land tenure adjustments.

Public scoping meetings will begin at 6:00 p.m. Shortly thereafter will follow a 15 to 20-minute presentation explaining the RMP developmental process. BLM staff members will be available to answer questions and collect public commentary. Handouts describing the planning process will be available, as will public scoping commentary forms and cards. The meetings will adjourn at 8:00 p.m. Public scoping comments will be accepted through November 8, 2006.
